SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 54 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 18 new Agreements processed in the month of August 2009, as follows:

- 1. Amendment No. 9 (DMH-01200) with Dubnoff Center for Child Development and Educational Therapy** makes a technical correction to increase the Maximum Contract Amount (MCA) in order to correctly state the Fiscal Year (FY) 2002-03 MCA of \$1,775,794, which was erroneously understated during the amendment process.
- 2. Amendment No. 14 (MH010054) with The Regents of UCLA** adds MHSA Prevention and Early Intervention (PEI) funding for the expansion of services related to Addendum A, sub-section A2.6 (Additional Academic and Medical Teaching Services for Recovery-Oriented Education and Training) by \$237,000, with a revised MCA of \$4,178,102.
- 3. Amendment No. 10 (MH120225) with Gay and Lesbian Adolescent Social Services** shifts Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Federal Financial Participation (FFP) Funds by \$5,992, Healthy Families (HF) FFP and EPSDT MHSA Full Service Partnership (FSP) Child by \$3,226 to HF MHSA FSP Transition Age Youth (TAY). There is no change to the MCA.
- 4. Amendment No. 7 (MH120347) with Exodus Recovery, Inc.,** makes a technical correction to Amendment No. 3, executed on April 21, 2009, pertaining to funding allocations that incorrectly increased the MCA for FY 2008-09 by \$461,000; decreases MHSA FSP Adult Client Supportive Services (CSS) (Flex

Funds) by \$126,080, MHSA Wellness Centers by \$169,000, Non-EPSTD Medi-Cal County General Funds (CGF) by \$72,000, Non-EPSTD-FFP by \$72,000 and CGF Local Mental Health Plan (MHP) Non-Medi-Cal by \$102,000; increases MHSA Non-FSP Cross Cutting Urgent Care Non-Medi-Cal by \$299,080, with a revised MCA of \$8,514,400.

5. **Amendment No. 10 (MH120375) with Mental Health America of Los Angeles** makes technical corrections to Amendment No. 3, originally executed on April 1, 2009, to correct the funding misallocation that erroneously reduced the Contractor's MCA for FY 2008-09 in the amount of \$170,000.
6. **Amendment No. 1 (MH120432) with Braswell Rehabilitation Institute for Development of Growth and Education Services, Inc., (BRIDGES)** adds a new delivery site at BRIDGES TruStart located at 6267 Variel Avenue., Suite B, Woodland Hills, CA 91367, under a new Medi-Cal/Short-Doyle Provider Number (PN) to be assigned. The services to be provided at this site are Targeted Case Management Services (Mode 15, Service Function Codes (SFCs) 01-09), Mental Health Services (MHS) (Mode 15, SFCs 10-19/30-59, Medication Support (Mode 15, SFCs 60-69), Crisis Intervention (Mode 15, SFCs 70-79), Outreach Services-Mental Health Promotion (Mode 45, SFCs 10-19), Community Client Services (Mode 45, SFCs 20-29), and CSS (Mode 60, SFCs 64/70-79). There is no change to the MCA.
7. **Amendment No. 1 (MH120452) with Gateways Hospital and Mental Health Center** provides MHS for 12 additional clients at Gateways Outpatient Clinic located at 2414 N. Broadway, Los Angeles, CA 90031; increases MHSA Enriched Residential Services Non-Medi-Cal/Indigent by \$325,188, and MHSA Enriched Residential Medi-Cal/HF by \$249,660, with a revised MCA of \$16,578,148
8. **Amendment No. 1 (MH120512) with Emotional Health Association dba SHARE!** adds a new service delivery site located at 425 S. Broadway, Los Angeles, CA 90031; adds MHSA Family Focus Wellness Services Plan, and Mental Health Promotion (Mode 45, SFCs 20-29) under a new PN. There is no change to the MCA.
9. **Amendment No. 1 (MH120516) with Hamburger Home dba Family and Children's Services dba Aviva Center** changes the address of Aviva Family and Children's Services – Community MHS from 3701 Wilshire Blvd., 9th Floor, Los Angeles, CA 90010 to 3580 Wilshire Blvd., Suite 800, Los Angeles, CA 90010 under existing PN 7268. There is no change to the MCA.

10. **Amendment No. 1 (MH120519) with Jewish Family Services of Los Angeles** relocates its services delivery site with PN 7693 from 6505 Wilshire Blvd., Suite 500, 4th Floor, Los Angeles, CA 90048 to 330 N. Fairfax Ave., Los Angeles, CA 90036. There is no change to the MCA.

14. **Agreement (MH190065) with Trilogy Integrated Resources, LLC** is being executed to provide Network of Care Services through June 30, 2012, with two (2) optional year renewal periods; also the Agreement may be extended on a month-to-month basis for up to 12 months.
15. **Amendment No. 2 (MH200030) with QueensCare Family Clinics** changes the contractors name specified in the MHSA Master Agreement from Franciscan Clinics dba QueensCare Family Clinics to QueensCare Family Clinics.
