SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 55 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 30 new Agreements processed in the month of December 2009, as follows:

1. **Agreement (MH9019) with Regents of the University of California dba UCLA Neuropsychiatric Behavioral Health** is being renewed for the provision of Medi-Cal specialty Mental Health Services (MHS) with a term date of July 1, 2009 through June 30, 2014.
2. **Amendment No. 3 (MH050020) with Karen Bollow** extends the term of Agreement for an additional 18 months through June 30, 2011, adds MHSA funding in the amount of \$273,600, revises Statement of Work, and adds revised and/or new County mandated provisions. The revised Total Compensation Amount (TCA) will be \$674,880.
3. **Amendment No. 4 (MH120437) with Children's Bureau of Southern California** adds a new service site located at 1910 South Magnolia Avenue, Los Angeles, CA 90007. Contractor will be providing Targeted Case Management Services (TCMS) (Mode 15, Service Function Codes (SFCs) 01-09); MHS (Mode 15, SFCs 10-19/30-59); Therapeutic Behavioral Services (TBS) (Mode 15, SFC 58); Medication Support (Mode 15, SFCs 60-69); Crisis Intervention (Mode 15, SFCs 70-79); Mental Health Promotion (MHP) (Mode 45, SFCs 10-19); and Community Client Services (CCS) (Mode 45, SFCs 20-29). There is no change to the Maximum Contract Amount (MCA).

4. **Amendment No. 3 (MH120441) with Didi Hirsch Psychiatric Service** enables contractor to transform and expand the services of its Suicide Prevention Center under the MHSA Prevention and Early Intervention (PEI) Plan's Early Start Suicide Prevention Program. It reduces Non-Medi-Cal/Indigent Funded Program in the amount of \$450,000, and adds MHSA PEI Plan's Early Start funds in the amount of \$1,252,733. County will allow contractor to use \$94,000 of the MHSA PEI Plan's Early Start funds for one-time only start-up costs. The revised MCA will be \$20,008,171.
5. **Amendment No. 4 (MH120452) with Gateways Hospital and Mental Health Center** adds Client Supportive Services (CSS) (Mode 60, SFCs 64/70-79) and deletes Life Support/Board & Care (Mode 60, SFCs 40-49) from existing Provider Number (PN) 6757, located at 437 North Hoover Street, Los Angeles, CA 90004. There is no change to the MCA.
6. **Amendment No. 1 (MH120463) with LAMP, Inc.**, adds a new service delivery site at LAMP, Inc., located at 115 East 3<sup>rd</sup> Street, Los Angeles, CA 90013 that will provide TCMS (Mode 15, SFCs 01-09); MHS (Mode 15, SFCs 10-19/30-59); Medication Support (Mode 15, SFCs 60-69); MHP (Mode 45, SFCs 10-19); CCS (Mode 45, SFCs 20-29); Case Management Support (Mode 60, SFCs 60-69); and CSS (Mode 60, SFCs 64/70-79), with no change to the MCA.
7. **Amendment No. 3 (MH120473) with Personal Involvement Center, Inc.**, restores the reductions taken in Amendment No. 1 that were erroneously added back to Healthy Families (HF) funding in the amount of \$274,379 in Amendment No. 2; decreases other MHS for clients under the age of 21 years Medi-Cal or HF Funded Program in the amount of \$274,379, with a revised MCA of \$1,900,501.
8. **Amendment No. 2 (MH120477) with Social Model Recovery Systems, Inc.**, decreases other MHS for clients under the age of 21 years Medi-Cal or HF Funded Program by \$159,044, and other MHS for clients 21 years of age or older Medi-Cal or HF Funded Program by \$429,734, with a revised MCA of \$2,242,522.
9. **Amendment No. 4 (MH120518) with Hillview Mental Health Center, Inc.**, increases California Work Opportunity and Responsibility to Kids (CaWORKs) funding by \$95,000, with a revised MCA of \$9,292,685.
10. **Amendment No. 3 (MH120519) with Jewish Family Service of Los Angeles** corrects the address at an existing service delivery site under PN 7723 from

6043 Hollywood Blvd., Hollywood, CA 90028 to 6043 Hollywood Blvd., Los Angeles, CA 90028, with no change to the MCA.

11. **Amendment No. 4 (MH120525) with Mental Health America of Los Angeles** shifts funds between the MHSA Funded Program allocations in order to make payments to contractor for claimed services when necessary to facilitate the State's implementation of the Federal Certified Public Expenditure (CPE) rules; decreases MHSA Wellness/Client-Run Centers Non-Medi-Cal/Indigent by \$358,739, and MHSA Wellness/Client-Run Medi-Cal/HF Funded Programs by \$709,046; increases MHSA Full Service Partnership (FSP) Adult Non-Medi-Cal/Indigent by \$217,720, MHSA FSP Adult Medi-Cal/HF Funded Programs by \$372,300, MHSA Field Capable Clinical Services (FCCS) Non-Medi-Cal/Indigent by \$90,054, MHSA FCCS Medi-Cal/HF Funded Programs by \$336,746; and increases MHSA Planning Outreach and Engagement Non-Medi-Cal/Indigent funding by \$50,965, with no change to the MCA.
12. **Amendment No. 3 (MH120532) with Penny Lane Centers** expands Wraparound Services to additional clients through Tier II-FSP Wraparound Services and adds Specialized Foster Care Funded Program, Medi-Cal/HF by \$1,212,840, with a revised MCA of \$15,718,758.
13. **Amendment No. 4 (MH120536) with San Fernando Valley Community Mental Health Center, Inc., (SFVCMHC, Inc.)** shifts Homeless Services Funded Program funds from Non-Medi-Cal/Indigent to Medi-Cal/HF in the amount of \$25,172 and adds Federal Financial Participation (FFP) funds to the Homeless Services Funded Program Medi-Cal/HF in the amount of \$40,364, with a revised MCA of \$28,651,748.
14. **Amendment No. 3 (MH120542) with St. Joseph Center** shifts Homeless Services Funded Program funds from Non-Medi-Cal/Indigent to Medi-Cal/HF in the amount of \$26,887 and adds FFP funds to the Homeless Services Funded Program Medi-Cal/HF in the amount of \$43,113, with a revised MCA of \$1,146,898 for Fiscal Year (FY) 2009-10 and \$1,086,898 for FY 2010-11.
15. **Amendment No. 2 (MH120546) with Telecare Corporation** reduces the MHSA Non-Medi-Cal/Indigent Urgent Care Centers funded program by \$75,000 for FY 2009-10 and \$100,000 for FY 2010-11, with a revised MCA of \$9,167,900 for FY 2009-10 and \$9,142,900 for FY 2010-11.
