SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 305 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 18 new Agreements processed in the month of February 2010, as follows:

1. **Amendment No. 2 (MH110001) with Unilab Corporation dba Quest Diagnostics** increases laboratory services funds in the amount of \$26,518, with a revised Maximum Contract Amount (MCA) of \$736,518.
2. **Amendment No. 3 (MH010023) with University of Southern California Department of Contracts and Grants** shows that contractor has met the minimum qualifications listed in the Request For Statement of Qualifications (RFSQ) and has been selected for recommendation to be on a Mental Health Services Act (MHSA) Master Agreement list as being qualified to deliver Older Adult Certificate Training Program, Prevention and Early Intervention (PEI), Workforce Education and Training (WET), Under-Represented Ethnic Populations, and Regional Partnership MHSA services.
3. **Amendment No. 2 (MH200006) with All for Health, Health for All, Inc.**, makes corrections to the original MHSA Master Agreement list and adds new language. There is no change to the MCA.
4. **Agreement (MH9015) with Rudy Chavez, M.D., Inc., dba Advanced Psychiatric Group** renew Agreement as an Individual and Group provider for the provision of Medi-Cal specialty Mental Health Services (MHS). There is no MCA for this contract.

5. **Amendment No. 5 (MH120432) with Braswell Rehabilitation Institute for Development of Growth and Educational Services, Inc., (B.R.I.D.G.E.S.)** shifts other MHS for clients under the age of 21 years and other MHS for clients 21 years of age or older Non-Medi-Cal/Indigent in the amount of \$311,350 to other MHS for clients 21 years of age or older Medi-Cal/Healthy Families (HF); and shifts MHSA Wellness/Client-Run Centers Non-Medi-Cal/Indigent in the amount of \$74,000 to MHSA Institutions for Mental Disease (IMD) Step-down Medi-Cal/HF. The revised MCA will be \$2,336,461.
6. **Amendment No. 6 (MH120452) with Gateways Hospital and Mental Health Center** decreases MHSA IMD Medi-Cal/HF in the amount of \$978,912 and increases MHSA Enriched Residential Services Funded Program, Medi-Cal/HF by \$978,912. There is no change to the MCA.
7. **Amendment No. 9 (MH120469) with Pacific Clinics** shifts funds that are not currently being used to services that can be matched by State/Federal funds, thus increasing the provision of direct services. With a revised MCA of \$73,349,274.
8. **Amendment No. 7 (MH120478) with Special Services for Groups** decreases MHSA Wellness/Client-Run Centers allocation in the amount of \$70,000; adds Non-Medi-Cal/Indigent/County General Funds (CGF) in the amount of \$70,000 to make a correction in the categorical funding allocation. There is no change to the MCA.
9. **Amendment No. 2 (MH120497) with Barbour and Floyd Medical Associates** shifts MHSA Full Service Partnership (FSP) Adult Gross Medi-Cal in the amount of \$853,600 to MHSA Field Capable Clinical Service (FCCS) Adult Gross Medi-Cal. There is no change to the MCA.
10. **Amendment No. 6 (MH120503) with ChildNet Youth and Family Services, Inc.,** removes the Satellite office under the current Provider No. 7469, located at Central Juvenile Hall, 1605 Eastlake Avenue, Los Angeles, CA 90033. There is no change to the MCA.
