SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 40 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 30 new Agreements processed in the month of July 2009, as follows:

1. **Agreement (MH030156) with Amy Allison Maiman** renews its Clinical Assessment Programs for Fiscal Years (FYs) 2009-10, 2010-11, and 2011-12.
2. **Amendment No. E1 (MH050013) with California Institute for Mental Health (CIMH)** intends to extend the term of this agreement by one year, beginning July 1, 2009, ending June 30, 2010. The Total Compensation Amount (TCA) is \$565,700.
3. **Amendment No. 2 (MH050020) with Karen Bollow** adds MHSA funds in the amount of \$66,880 for FY 2009-10 to continue services pertaining to the preparation and implementation of the Integrated Behavioral Health Information System. The TCA for FY 2009-10 is \$66,880.
4. **Agreement (MH050032) with Mental Health Advocacy Services, Inc.,** does not guarantee a specific project or funding amount as this will be based on specific needs of the provider. The provider was identified through a Request for Information process and has met the minimum qualifications. This action was approved by the Board of Supervisors on April 7, 2009, and is being processed under delegated authority in accordance with MHSA, Client Supportive Services (CSS) Plan for siting new mental health facilities or supportive housing developments that require assistance in securing community acceptance, leveraging funds, developing affordable housing, or understanding land issues.

5. **Amendment No. 1 (MH060015) with East Valley Glendora Hospital, L.P.,** increases the daily rate for acute inpatient hospital services by 10 percent for each Medi-Cal beneficiary receiving services in a 24-hour acute psychiatric inpatient hospital.
6. **Agreement (MH060026) with The Regents of the University of California on behalf of the Resnick Neuropsychiatric Hospital at UCLA** is being executed for Fee-For-Service (FFS) Medi-Cal acute psychiatric inpatient services and administrative day services.
7. **Amendment No. 15 (MH120209) with Counseling and Research Associates, Inc. dba Masada Homes** increases Wraparound funding by \$303,210. The revised Maximum Contract Amount (MCA) for FY 2008-09 is \$8,917,280.
8. **Amendment No. 4 (MH120337) with Didi Hirsch Psychiatric Service** shifts \$40,000 from Full Service Partnership (FSP) Adult CSS to Field Capable Clinical Services (FCCS) Adult Mental Health Services (MHS) Medi-Cal, decreases FSP Transition Age Youth (TAY) MHS by \$40,000, increases FSP TAY non-Early and Periodic Screening, Diagnosis and Treatment (EPSDT) MHS match by \$104,000, FSP Older Adult (OA) MHS by \$16,000, FSP OA MHS match by \$115,000, non-EPSDT FFP by \$259,000. The revised MCA for FY 2008-09 is \$19,871,350.
9. **Amendment No. 5 (MH120361) with Hillside**s shifts \$135,000 from MHSA-Child Family Support Services Local Mental Health Plan (MHP) non-Medi-Cal to MHSA-FSP MHS, also \$50,000 from MHSA-FSP TAY CSS (Flex Funds) Local MHP non-Medi-Cal to MHSA-TAY MHSA Local non-Medi-Cal. There is no change to the MCA.
10. **Amendment No. 9 (MH120375) with Mental Health America of Los Angeles (MHALA)** shifts MHSA Wellness Center to MHSA Adult FSP by \$103,480 and MHSA Wellness Center non-EPSDT to MHSA Adult FSP non-EPSDT by \$177,250. There is no change to the MCA.
11. **Amendment No. 9 (MH120391) with San Fernando Valley Community Mental Health Center, Inc.,** transforms funds from County General Funds (CGF) Local MHP non-Medi-Cal by \$37,236, non-EPSDT CGF by \$136,303, Adult FCCS Local MHP non-Medi-Cal by \$37,236 and non-EPSDT Medi-Cal by \$136,303. There is no change in the MCA.
12. **Amendment No. 3 (MH120407) with The Los Angeles Child Guidance Clinic** increases current California Work Opportunities and Responsibility to Kids

(CalWORKs) funding for MHS by \$8,850 and decreases current CalWORKs funding for Community Outreach Services (COS) by \$8,850. There is no change to the MCA.

13. **Agreement (MH180023) with CareerStaff Unlimited, Inc.** renews Temporary Psychiatrist Services Agreement for three (3) years beginning FYs 2009-10 through 2011-12.
14. **Amendment No. 5 (MH190010) with California State University, Long Beach Foundation** intends to exercise the option to extend funding for FY 2009-10, using authority delegated under Recommendation No. 1 of the October 2, 2008, Board letter. The TCA will increase from \$200,000 to \$1,118,000.
15. **Amendment No. 1 (MH190024) with California Hispanic Commission on Alcohol and Drug Abuse, Inc.,** extends the term of the Enhanced Emergency Shelter Program for TAY for a period of three (3) years, also adds new language, and revises Exhibit A (Statement of Work) and Exhibit B (Fee Schedule).
16. **Agreement (MH190045) with White Memorial Medical Center** will be renewed for the provision of Medi-Cal specialty mental health FFS Hospitals services.
17. **Agreement (MH190064) with CIMH** enables the Department to participate in CIMH's California Mental Health and Spirituality Initiative Project. The term is for two (2) years, effective upon the Board approval.
