SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 141 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 212 new Agreements processed in the month of June 2010, as follows:

1. **Amendment No. 2 (A00776) with Eli Lilly and Company** replaces Exhibit B (Formulary Status) and is being executed under delegated authority.
2. **Amendment No. 1 (MH9005) with Coast Psychiatric Associates**, effective February 1, 2010, the State Department of Mental Health (SDMH) implemented the transition of the SDMH Medi-Cal claiming system to comply with the Health Insurance Portability and Accountability Act (HIPAA) of 1996; and effective October 21, 2009, adds new provisions pursuant to the new Ordinance No. 2009-0026 (Los Angeles County Code 2.206), Defaulted Property Tax Reduction Program.
3. **Agreement (MH010080) with University of St. Augustine** is being executed as a new Affiliation Agreement for Student Professional Development Programs in which County educates and trains students through placement experiences which are required and an integral part of professional academic curriculum. The term of the Agreement begins July 1, 2010 through June 30, 2015.
4. **Amendment No. 4 (MH050017) with Pacific Clinics** for Fiscal Year (FY) 2008-09, extends the term of the Agreement for a period of 12 months, beginning July 1, 2008 through June 30, 2009; for FY 2009-10, extends for a period of 12 months, beginning July 1, 2009 through June 30, 2010; and for FY 2010-11, extends for a period of an additional six (6) months, beginning July 1, 2010 through December 31, 2010 to continue the implementation of the Workforce Education and Training Programs (WET).

5. **Amendment No. 6 (MH050019) with Mental Health America of Los Angeles** for FY 2008-09, extends the term of the Agreement for a period of 12 months, beginning July 1, 2008 through June 30, 2009; for FY 2009-10, extends for a period of 12 months, beginning July 1, 2009 through June 30, 2010; and for FY 2010-11, extends for a period of an additional 12 months, beginning July 1, 2010 through June 30, 2011, to continue the implementation of the WET Programs.
6. **Amendment No. 4 (MH050026) with Inez K. Mann dba Mann and Associates** renews agreement for one (1) year, beginning July 1, 2010 through June 30, 2011; it will be funded with County General Funds (CGF) in the amount of \$75,000 and the remaining balance of \$45,500 from the allocation of MHSA Community Services and Supports (CSS) funding.
7. **Amendment No. 3 (MH050029) with A Community of Friends** adds MHSA CSS Plan funds in the amount of \$6,250 to provide siting training to Avenues of Independence, Inc.
8. **Amendment No. 3 (MH120287) with Tri-City Mental Health Center** increases provisional cost reimbursement rates for Targeted Case Management Services (TCMS) (Mode 15, Service Function Codes (SFCs) 01-09) from \$1.43 to \$1.75; Mental Health Services (MHS) (Mode 15, SFCs 10-19/30-59) from \$1.83 to \$2.25; Medication Support (Mode 15, SFCs 60-69) from \$3.39 to \$4.20; and Crisis Intervention (Mode 15, SFCs 70-79) from \$2.73 to \$3.35. There is no change to the Maximum Contract Amount (MCA).
9. **Amendment No. 4 (MH120431) with Bienvenidos Children's Center, Inc.,** decreases Other MHS for Clients Under the Age of 21 Years Medi-Cal/HF by \$179,680 and adds Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Medi-Cal funds by \$179,680 to Specialized Foster Care Funded Program, Medi-Cal/HF for the purpose of expanding Wraparound Services under the Katie A. Settlement Agreement. There is no change to the MCA.

11. **Amendment No. 10 (MH120441) with Didi Hirsch Psychiatric Service** increases CGF Non-Medi-Cal/Indigent Maximum Program Amount by \$262,310;

and decreases MHSa Prevention and Early Intervention (PEI) Early Start (ES) funds by \$262,310. There is no change to the MCA.

12. **Amendment No. 8 (MH120447) with Exodus Recovery, Inc.**, increases MHSa Urgent Care Centers/Crisis Resolution Services Non-Medi-Cal/Indigent by \$471,709; decreases MHSa Urgent Care Centers/Crisis Resolution Services Medi-Cal/Healthy Families (HF) by \$362,390; and shifts \$5,000 from MHSa-Urgent Care Centers/Crisis Resolution Services Medi-Cal/HF to MHSa-Wellness/Client-Run Centers Medi-Cal/HF. The revised MCA will be \$10,867,282.
13. **Amendment No. 4 (MH120449) with Florence Crittenton Services of Orange County, Inc., dba Crittenton Services for Children and Families** effective March 26, 2010, moved the location of its Headquarters' address from 801 East Chapman Avenue, Suite 230, Fullerton, CA 92831 to 801 East Chapman Avenue, Suite 203, Fullerton, CA 92831; moved the location of Provider Number (PN) 7660 from 4010 Watson Plaza Drive Suite #135, Lakewood, CA 90712 to 12440 Firestone Boulevard Suite #215, Norwalk, CA 90060; and changed the name of PN 7660 from Crittenton Child and Family-Lakewood to Crittenton Services for Children and Families. There is no change to the MCA.
14. **Amendment No. 9 (MH120453) with Hathaway-Sycamores Child and Family Services** shifts funds within the age groups of Child and Transition Age Youth (TAY), under the Full Service Partnership (FSP) of the MHSa CSS Plan to meet service needs in accordance with the actual demographics of clients served. Decreases FSP Child Non-Medi-Cal/Indigent Maximum Program Amount by \$1,690; increases FSP Child Medi-Cal/HF Maximum Program Amount by \$260,000; decreases TAY Non-EPST Medi-Cal by \$132,299, TAY Non-Medi-Cal Flex by \$21,363; increases TAY EPST Medi-Cal by \$56,004, TAY HF by \$55,000, and TAY Non-Medi-Cal/Indigent program by \$50,000. The revised MCA will be \$34,619,576.
