SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 133 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 229 new Agreements processed in the month of June 2009, as follows:

1. **Amendment No. 11 (MH010054) with The Regents of University of California, Los Angeles (UCLA)** adds a service site to Provider Number (PN) 7446 located at 1033 Gayley Avenue, Suite 204, Los Angeles, CA 90024-3426.
2. **Amendment No. 12 (MH010054) with The Regents of UCLA** revises funding source language pertaining to Addendum G (Development of a Disaster Mental Health Model; Concept of Operations; and Coordinated Incident Management Strategy and Training); it will not increase or decrease the total amount of funding for Addendum G.
3. **Amendment No. 13 (MH010054) with The Regents of UCLA – TIES for Adoption** decreases Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Federal Financial Participation (FFP) funds by \$250,000, EPSDT State General Funds (SGF) by \$215,950, and EPSDT Medi-Cal match by \$34,050, with a revised Maximum Contract Amount (MCA) of \$1,231,266.
4. **Amendment No. 5 (MH050011) with California Mental Health Directors Association (CMHDA)** adds \$20,000 of Substance Abuse and Mental Health Services Administration (SAMHSA) Federal Block Grant (FBG) funds to develop training and technical assistance for staff with clinical and administrative capacities to treat clients with Co-Occurring Disorders (COD); the revised Total Compensation Amount (TCA) will be \$232,935.

5. **Agreement (MH060030) with Success Healthcare 1, LLC dba Silver Lake Medical Center** replaces agreement with Intercare Health Systems, Inc., dba City of Angels Medical Center-Ingleside Campus and will allow for medically necessary acute psychiatric inpatient hospital services and administrative day services to severely mentally ill clients who reside throughout the County of Los Angeles.
6. **Amendment No. 1 (MH060030) with Success Healthcare 1, LLC dba Silver Lake Medical Center** adds the Psychiatric Mobil Response Team (PMRT) Psychiatric Outreach Division Program (PDP) from June 11, 2009 to June 30, 2009; adds PMRT PDP under the direction of the Department of Health Services Medical Alert Center and to limit it to clients who are uninsured.
7. **Amendment No. 16 (MH120248) with Penny Lane Centers** provides Department of Children and Family Services (DCFS) Intensive In-Home-Enhanced Specialized Foster Care Non-Medical funding in the amount of \$5,000 for one-time expenses associated with the Program Development for the implementation of Intensive Evidence-Based Treatment Practices as part of the Katie A. Strategic Plan; adds Client Supportive Services (CSS) (Mode 60, Service Function Codes (SFCs) 64 and 70-79) to PN 7455, with a revised MCA of \$14,423,229.
8. **Amendment No. 2 (MH120316) with AIDS Project Los Angeles** decreases State Human Immunodeficiency Virus (HIV)/Acquired Immune Deficiency Syndrome (AIDS) by \$9,833, with a revised MCA of \$98,467.
9. **Amendment No. 5 (MH120318) with Amanecer Community Counseling Services, Inc.**, increases provisional Cost Reimbursement (CR) Rates for Targeted Case Management Services (TCMS) (Mode 15, SFCs 01-09) from \$1.47 to \$1.68; Mental Health Services (MHS) (Mode 15, SFCs 10-19/30-59) from \$1.90 to \$2.16; Therapeutic Behavioral Services (TBS) (Mode 15, SFC 58) from \$1.90 to \$2.16; Medication Support (Mode 15, SFCs 60-69) from \$3.51 to \$4.02; and Crisis Intervention (Mode 15, SFCs 70-79) from \$2.83 to \$3.24. There is no change to the MCA.
10. **Amendment No. 2 (MH120319) with ASC Treatment Group dba The Anne Sippi Clinic** allows contractor to "transform" a portion of its curtailed outpatient services and resources to MHSA-Community Services and Supports Plan; decreases Non-EPSDT County General Funds (CGF) match funds by \$92,800; and adds MHSA Adult Institution for Mental Diseases (IMD) Step-down Non-EPSDT Medi-Cal by \$92,800 with no change to the MCA.

11. **Amendment No. 3 (MH120320) with Alma Family Services** increases EPSDT FFP by \$11,667, EPSDT SGF by \$10,077, Non-EPSDT FFP by \$2,916, MHSA-Full Service Partnership (FSP) Transition Age Youth (TAY) CSS by \$11,767, MHSA-FSP TAY MHS by \$17,500, MHSA-FSP TAY MHS EPSDT by \$1,589, and MHSA-FSP TAY MHS Non-EPSDT by \$2,917, with a revised MCA of \$6,578,933.
12. **Amendment No. 2 (MH120321) with Bienvenidos Children's Center, Inc.**, changes the service delivery site for PN 7575 from 780 West Mission Blvd, Pomona, CA 91766 to 421 South Glendora Ave., West Covina, CA 91790. There is no change to the MCA.
13. **Amendment No. 4 (MH120330) with Children's Bureau of Southern California** adds EPSDT CGF by \$10,215, EPSDT SGF by \$64,785, and EPSDT FFP by \$75,000, with a revised MCA of \$9,063,361.
14. **Amendment No. 4 (MH120339) with Dubnoff Center for Child Development and Educational Therapy** decreases CGF by \$8,483; funds will then be used as the State of California-Department of Rehabilitation required for County match for leveraging Federal Funds. The revised MCA will be \$2,444,517.
15. **Amendment No. 7 (MH120351) with Foothill Family Service** adds Outreach Services (Mode 45, SFCs 10 and 20) under PN 7755, with no change to the MCA.
16. **Amendment No. 2 (MH120359) with Helpline Youth Counseling, Inc.**, revises the Provisional CR Rates for TCMS (Mode 15, SFCs 01-09) from \$1.83 to \$2.02; MHS (Mode 15, SFCs 10-19/30-59) from \$2.36 to \$2.61; and Crisis Intervention (Mode 15, SFCs 70-79) from \$3.52 to \$3.88, with no change to the MCA.
