SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 184 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 16 new Agreements processed in the month of March 2010, as follows:

1. **Agreement (MH9018) with Traditions Psychology Group, Inc., dba Traditions Behavioral Health** is being executed under delegated authority by the Director of Mental Health and shall commence on February 17, 2010 through June 30, 2014. There is no Maximum Contract Amount (MCA) for this contract.
2. **Agreement (MH29376) with Aleksandra Wirga, MD, Inc.**, is being executed effective March 3, 2010, to provide services as an Individual Fee-For-Service (FFS) provider. There is no MCA for this contract.
3. **Amendment No. 16 (MH010054) with The Regents of the University of California, Los Angeles (UCLA)** adds \$103,299 of MHSA Prevention and Early Intervention (PEI) funding for the expansion of services related to Addendum A, sub-section A2.4. Also adds a satellite service delivery site located at 2191 Franz Hall, Los Angeles, CA 90024 to current Provider Number (PN) 7446 and adds a new PN to current service delivery site located at 1033 Gayley Avenue, Suite #204, Los Angeles, CA 90024.
4. **Agreement (MH050037) with Los Angeles County Office of Education** is being executed to provide web site design development and maintenance and shall commence on February 23, 2010 through June 30, 2012, with an annual MCA of \$255,000.

5. **Agreement (MH060032) with Catholic Healthcare West dba Northridge Hospital Medical Center-Roscoe Boulevard Campus** is being renewed to allow uninterrupted, medically necessary acute psychiatric inpatient hospital services and administrative day services to severely mentally ill clients who reside throughout the County of Los Angeles and will become effective April 1, 2010 through June 3, 2010.
6. **Amendment No. 6 (MH120436) with Child and Family Center** adds Mental Health Services (MHS) (Mode 15, Service Function Codes (SFCs) 10-19/30-59) at a provisional rate of \$2.61, and Medication Support (Mode 15, SFCs 60-69) at a provisional rate of \$4.82 to PN 7778. There is no change to the MCA.
7. **Amendment No. 6 (MH120437) with Children's Bureau of Southern California** is adding two (2) new suites, No. 102 and No. 122, to delivery site located at 460 East Carson Plaza Drive, Suite 103, Los Angeles, CA 90746, under PN 7570. The services that will be provided are Targeted Case Management Services (TCMS) (Mode 15, SFCs 01-09); MHS (Mode 15, SFCs 10-19/30-59); Medication Support (Mode 15, SFCs 60-69); Mental Health Promotion (MHP) (Mode 45, SFCs 10-19); and Community Client Services (CCS) (Mode 45, SFCs 20-59). There is no change to the MCA.

There is no change to the MCA.
