SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 86 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 19 new Agreements processed in the month of September 2009, as follows:

1. **Amendment No. E2 (MH050013) with California Institute for Mental Health** adds Katie A – Enhanced Specialized Foster Care funding in the amount of \$192,000. The revised Total Compensation Amount (TCA) will be \$757,700.
2. **Amendment No. 18 (MH120253) with SHIELDS For Families** makes a technical correction to the Financial Summary of the Agreement to identify the correct responsible financial party/funding source as Schiff-Cardenas Multi-Systematic Therapy (MST) Program, which was erroneously identified as Schiff-Cardenas Mental Health Screening, Assessment, and Treatment (MHSAT); increases Schiff-Cardenas MST Program funding by \$150,000, and decreases Schiff-Cardenas MHSAT funding by \$150,000, with no change to the Maximum Contract Amount (MCA).
3. **Amendment No. 8 (MH120347) with Exodus Recovery, Inc.**, makes a technical correction to Amendment No. 3, executed on April 21, 2009, to correct the zip code to 90059 and add Suite Number 303 to service delivery site PEJ Exodus Wellness Center. Services to be provided are Targeted Case Management Services (TCMS) (Mode 15, Service Function Codes (SFCs) 01-09); Mental Health Services (MHS) (Mode 15, SFCs 10-19/30-59); Medication Support (Mode 15, SFCs 60-69); Crisis Intervention (Mode 15, SFCs 70-79); Mental Health Promotion (Mode 45, SFCs 10-19); Community Client Services (CCS) (Mode 45, SFCs 20-29); and Client Supportive Services (Mode 60, SFCs 70-79). There is no change to the MCA.

4. **Amendment No. 6 (MH120364) with Institute for Multicultural Counseling & Education Services, Inc., (IMCES)** makes technical corrections to the Financial Summary of the Agreement to correct the funding misallocations that erroneously allocated \$24,000 to California Work Opportunity and Responsibility to Kids (CalWORKs) Community Outreach Services (COS), thus the allocation of CalWORKs for MHS was understated by \$24,000. It increases CalWORKs funding for MHS by \$24,000 and decreases CalWORKs funding for COS by \$24,000, with no change to the MCA.
5. **Amendment No. 6 (MH120397) with Special Service For Groups** adds Medication Support (Mode 15, SFCs 60-69) under Provider Number (PN) 7682; Crisis Intervention (Mode 15, SFCs 70-79) under PNs 7124, 7510, and 7682; Mental Health Promotion (Mode 45, SFCs 10-19) under PNs 7656, 7657, 7681, 7686, and 7732; CCS (Mode 45, SFCs 20-29) under PN 7732; Client Supportive Services (Mode 60, SFCs 64/70-79) under PNs 7124, 7186, 7187, 7329, 7362, 7400, 7510, 7517, 7579, 7619, 7656, 7657, 7681, 7682, 7686, 7688, and 7732, with no change to the MCA.
6. **Amendment No. 1 (MH120427) with Alma Family Services** adds a new service delivery site located at 3357 E. Gage Avenue, Huntington Park, CA 90255. Services to be provided are TCMS (Mode 15, SFCs 01-09); MHS (Mode 15, SFCs 10-19/30-59); and Crisis Intervention (Mode 15, SFCs 70-79) under existing PN 7562, with no change to the MCA.

8. **Amendment No. 1 (MH120447) with Exodus Recovery, Inc.,** increases MHSA Wellness Center Gross Non-Early and Periodic Screening, Diagnosis and Treatment (EPSDT) Medi-Cal funds by \$215,000, and MHSA Wellness/Client-Run Center Non-Medi-Cal Indigent funds by \$281,500, with a revised MCA of \$8,791,800.

9. **Amendment No. 1 (MH120471) with Para Los Ninos** adds Crisis Intervention (Mode 15, SFCs 70-79) and Group Services (Mode 15, SFC 52) under PN 7546, with no change to the MCA.
10. **Amendment No. 1 (MH120493) with Vista Del Mar Child and Family Services** adds a new PN and service delivery site for Vista Del Mar – SPA 4 located at 3345 Wilshire Boulevard, Suite 609, Los Angeles, CA 90010. Services to be provided are TCMS (Mode 15, SFCs 01-09); MHS (Mode 15, SFCs 10-19/30-59); Mental Health Promotion (Mode 45, SFCs 10-19); and CCS (Mode 45, SFCs 20-29), with no change to the MCA.
11. **Amendment No. 2 (MH120493) with Vista Del Mar Child and Family Services** adds EPSDT Federal Financial Participation (FFP) funds by \$56,958, EPSDT State General Funds (SGF) by \$30,685, Department of Children and Family Services (DCFS) Intrafund Transfer Funds (ITF) match by \$4,837, and DCFS ITF for Non-Medi-Cal services by \$23,120 for the purpose of the expansion of the Multidisciplinary Assessment Team (MAT) services under the Katie A. Corrective Action Plan, with a revised MCA of \$9,034,080.
12. **Amendment No. 2 (MH120519) with Jewish Family Service of Los Angeles** deletes an existing service delivery site located at 23430 Hawthorne Blvd., Suite 125, Torrance, CA 90505 and deletes TCMS (Mode 15, SFCs 01-09); MHS (Mode 15, SFCs 10-19/30-59); Medication Support Services (Mode 15, SFCs 60-69); Crisis Intervention (Mode 15, SFCs 70-79); and CCS (Mode 45, SFCs 20-29) under PN 7745, with no change to the MCA.
