SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 21 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of February 2009, as follows:

- Amendment No. 1 (MH040064) with Mid-Valley Recovery Services, Inc.**, includes actual addresses where services are being provided; those addresses are as follow: 3426 and 3434 Cogswell Road, El Monte, CA 91732.
- Amendment No. 5 (MH120211) with Drew Child Development Corporation** implements a technical adjustment to change the reimbursement methodology from Negotiated Rate to Cost Reimbursement for Targeted Case Management Services (TCMS) (Mode 15, Service Function Codes (SFCs) 01-09); Mental Health Services (MHS) (Mode 15, SFCs 10-19/30-59); Medication Support (Mode 15, SFCs 60-69); and Crisis Intervention (Mode 15, SFCs 70-79). There is no change to the Maximum Contract Amount (MCA).
- Amendment No. 13 (MH120262) with Step Up on Second Street, Inc.**, decreases non-Early and Periodic Screening, Diagnosis, and Treatment (non-EPSDT) – County General Funds (CGF) by \$74,116; Transition Age Youth (TAY) Full Service Partnership (FSP) MHS by \$4,633; Adult FSP non-ESPDT Federal Financial Participation (FFP) by \$59,167; Adult FSP MHS by \$4,829; Adult FSP MHS non-EPSDT by \$4,829; and Adult Field Capable Clinical Services (FCCS) MHS by \$31,966. In addition, this amendment increases CGF by \$74,116; TAY FSP Community Services and Supports (CSS) by \$17,650; TAY FSP non-EPSDT FFP by \$22,083; Adult FCCS CSS by \$4,000; and Adult FCCS CSS non-EPSDT FFP by \$56,862. The total amount of Mental Health Services Act (MHSA) funds to be transformed to new and/or expanded programs

under the MHSA – CSS Plan from Fiscal Year (FY) 2007-08 will be \$174,711. There is no change to the MCA.

4. **Amendment No. 6 (MH120266) with Tarzana Treatment Center, Inc.**, intends to restore EPSDT funds in the amount of \$319,000 and increases EPSDT CGF by \$21,724; EPSDT FFP matching funds by \$159,500; and EPSDT State General Funds (SGF) matching funds by \$137,776. The revised MCA will be \$1,925,300.
5. **Amendment No. 1 (MH120312) with Tarzana Treatment Center, Inc.**, for FYs 2009-10 and 2010-11 intends to restore EPSDT funds in the amount of \$319,000 and increases EPSDT CGF by \$21,724; EPSDT FFP matching funds by \$159,500; and EPSDT SGF matching funds by \$137,776. The revised MCA for each FY will be \$1,925,300.
6. **Amendment No. 1 (MH120349) with Five Acres – The Boys' & Girls' Aid Society of Los Angeles County** deletes Day Rehabilitation Full Services (Mode 10, SFC 98) under Provider Number (PN) 7337. There is no change to the MCA.
7. **Amendment No. 1 (MH120351) with Foothill Family Service** increases EPSDT CGF by \$5,107; EPSDT FFP matching funds by \$37,500; and EPSDT SGF matching funds by \$32,392. The revised MCA will be \$9,371,699.
8. **Amendment No. 1 (MH120362) with Hillview Mental Health Center, Inc.**, decreases non-EPSDT FFP by \$250,000; shifts \$250,000 from non-EPSDT CGF to Local Mental Health Plan non-Medi-Cal CGF funds; decreases MHSA Wellness Centers matching funds by \$25,422; increases MHSA Adult FCCS matching funds by \$25,422; and shifts \$100,000 from MHSA Older Adult FCCS MHS to MHSA Adult FCCS MHS funds. The revised MCA will be \$9,535,600.
9. **Amendment No. 1 (MH120388) with PROTOTYPES, Centers for Innovation in Health, Mental Health and Social Services** decreases EPSDT CGF by \$5,107; EPSDT FFP matching funds by \$37,500; and EPSDT SGF matching funds by \$32,392. The revised MCA will be \$6,311,001.
10. **Amendment No. 1 (MH120409) with The Los Angeles Gay and Lesbian Community Services Center dba L.A. Gay and Lesbian Center** increases CGF by \$25,000 to provide Outreach Services to individuals and families who were formerly served by Gay and Lesbian Adolescent Social Services, Inc. The revised MCA will be \$222,800.

11. **Amendment No. 2 (MH120410) with The Village Family Services** adds Department of Children and Family Services matching funds in the amount of \$41,541; EPSDT FFP in the amount of \$305,000; and EPSDT-SGF in the amount of \$263,459. The revised MCA will be \$1,946,731.
12. **Amendment No. 1 (MH120412) with Topanga-Roscoe Corporation dba Topanga West Guest Home** decreases gross non-EPSDT by \$48,688 and MHSA Wellness Center funding by \$25,818 and adds MHSA Wellness Center-Client Run funds in the amount of \$50,162. The revised MCA will be \$508,756.
13. **Amendment No. 1 (MH120418) with Verdugo Mental Health Center** relocates its PN 7193 service delivery site from the site located at 1530 E. Colorado Street, Glendale, CA 91205 to a new site located at 1540 E. Colorado Street, Glendale, CA 91205. There is no change to the MCA.

The following eight (8) amendments to LE Agreements (14 to 21) increase/shift MCA funds to enable County to make additional payments to Contractor to facilitate the State's implementation of the Federal Certified Public Expenditure rules. They increase/decrease EPSDT FFP, EPSDT SGF, and EPSDT CGF:

14. **Amendment No. 4 (MH120166) with Maryvale** increases EPSDT FFP by \$236,679; EPSDT SGF by \$217,303; and EPSDT CGF by \$19,218, with a revised MCA of \$2,839,200.
15. **Amendment No. 5 (MH120166) with Maryvale** increases EPSDT FFP by \$85,000; EPSDT SGF by \$72,556; and EPSDT CGF by \$12,444, with a revised MCA of \$3,009,200.
16. **Amendment No. 9 (MH120171) with Pediatric & Family Medical Center dba Eisner Pediatric & Family Medical Center** shifts funds from EPSDT to Healthy Families (HF); decreases EPSDT FFP by \$4,605 and EPSDT SGF by \$2,480; and increases HF FFP by \$4,605 and HF CGF by \$2,480. There is no change to the MCA.
17. **Amendment No. 8 (MH120194) with Barbour and Floyd Medical Associates** increases non-EPSDT FFP by \$33,557 and non-EPSDT CGF by \$33,528, with a revised MCA of \$2,028,629.

18. **Amendment No. 10 (MH120209) with Counseling and Research Associates, Inc., dba Masada Homes** increases non-EPSDT CGF by \$13,859; EPSDT FFP by \$245,786; EPSDT SGF by \$244,939; EPSDT CGF by \$44,344; HF FFP by \$25,793; and HF CGF by \$18,787, with a revised MCA of \$8,896,903.
19. **Amendment No. 8 (MH120212) with D'Veal Corporation Family and Youth Services** increases non-EPSDT FFP by \$1,613; non-EPSDT CGF by \$1,613; EPSDT FFP by \$20,791; and EPSDT SGF by \$41,683, with a revised MCA of \$5,524,331.
20. **Amendment No. 9 (MH120222) with Foothill Family Service** increases non-EPSDT FFP by \$62,340; non-EPSDT CGF by \$62,340; EPSDT FFP by \$109,330; EPSDT SGF by \$107,720; EPSDT CGF by \$13,989; HF FFP by \$20,744; and HF CGF by \$30,769, with a revised MCA of \$9,395,366.
21. **Amendment No. 7 (MH120252) with San Gabriel Children's Center, Inc.**, increases EPSDT FFP by \$126,517; EPSDT SGF by \$112,476; and EPSDT CGF by \$4,087, with a revised MCA of \$2,732,881.
