SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 33 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of January 2009, as follows:

- 1. Amendment No. 11 (MH050013) with California Institute for Mental Health** adds Mental Health Services Act (MHSA) funding in the amount of \$90,460 and adds Title IVE waiver funds through an Intrafund Transfer from the Department of Probation in the amount of \$70,500, with a revised Total Compensation Amount (TCA) of \$1,025,760.
- 2. Amendment No. 5 (MH050015) with Mental Health America of Los Angeles** eliminates Assembly Bill (AB) 2034 funding in the amount of \$440,000 due to curtailment of AB 2034 funding by the State of California and adds MHSA funding in the amount of \$480,000, with a revised TCA of \$1,145,003.
- 3. Amendment No. 26 (MH120144) with Pacific Clinics** changes the name and address of Pacific Clinics – Foster Family Agency Concept 7, 200 Citadel Drive, Suite 175, Commerce, CA 90040 to Pacific Clinics – Concept 7 Program, 5675 Telegraph Road, Suites 250 and 260, Commerce, CA 90040, under existing Provider Number (PN) 7424. The services to be provided will be Targeted Case Management Services (TCMS) (Mode 15, Service Function Codes (SFCs) 01-09) at a rate of \$1.91; Mental Health Services (MHS) (Mode 15, SFCs 10-19/30-59) at a rate of \$2.47; Medication Support Services (MSS) (Mode 15, SFCs 60-69) at a rate of \$4.56; and Crisis Intervention Services (Mode 15, SFCs 70-79) at a rate of \$3.67. There is no change to the Maximum Contract Amount (MCA).

4. **Amendment No. 16 (MH120193) with Alma Family Services** increases the Provisional Cost Reimbursement Rates for TCMS (Mode 15, SFCs 01-09) from \$1.77 to \$1.98; MHS (Mode 15, SFCs 10-19/30-59) from \$2.30 to \$2.56; MSS (Mode 15, SFCs 60-69) from \$4.25 to \$4.73; Crisis Intervention (Mode 15, SFCs 70-79) from \$3.60 to \$3.81; Outreach Services Mental Health Promotion (Mode 45, SFCs 10-19) from \$51.25 to \$52.38; and Community Client Services (Mode 45, SFCs 20-29) from \$60.27 to \$61.61. There is no change to the MCA.
5. **Amendment No. 8 (MH120267) with Telecare Corporation** adds Local Mental Health Plan (MHP) Psychiatric Emergency Service County General Funds (CGF) in the amount of \$245,000, with a revised MCA of \$10,336,000.
6. **Amendment No. 1 (MH120410) with The Village Family Services** adds Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) CGF match in the amount of \$1,294; EPSDT-Federal Financial Participation (FFP) in the amount of \$9,500; and EPSDT State General Funds (SGF) in the amount of \$8,206, with a revised MCA of \$1,336,731.
7. **Amendment No. 1 (MH150168) with Rely-On Pharmacy, Inc., dba Value Care Pharmacy** revises Paragraph 3 (Payment), which adjusts the prescription drug reimbursement rates. Pharmacy Contractors are reimbursed at a "Maximum Allowable Ingredient Cost" plus \$3.35 professional fee for each prescription dispensed.

The following two (2) amendments to LE Agreements (8 and 9) implement a technical adjustment to change the reimbursement methodology from Negotiated Rate to Cost Reimbursement.

8. **Amendment No. 2 (MH120200) with Wise and Healthy Aging (Center for Healthy Aging)** for Day Rehabilitation – Full Day (Mode 10, SFCs 95-99); TCMS (Mode 15, SFCs 01-09); MHS (Mode 15, SFCs 10-19/30-59); MSS (Mode 15, SFCs 60-69); and Crisis Intervention (Mode 15, SFCs 70-79). There is no change to the MCA.
9. **Amendment No. 8 (MH120249) with Personal Involvement Center, Inc.,** for TCMS (Mode 15, SFCs 01-09); MHS (Mode 15, SFCs 10-19/30-59); MSS (Mode 15, SFCs 60-69); and Crisis Intervention (Mode 15, SFCs 70-79). There is no change to the MCA.

The following two (2) amendments to LE Agreements (10 and 11) intend to add funds to Children's MHA Full Service Partnership (FSP) to increase the allocation from \$14,000 per child slot to \$19,000 per child slot; increase MHA funds for EPSDT FSP Children Local Match; increase EPSDT-FFP matching funds for FSP Children; increase EPSDT SGF matching funds for FSP Children; increase MHA funds for Healthy Families (HF) FSP Children Local match; increase HF FFP matching funds for FSP Children; and increase MHA Local MHP non-Medical funds for indigent Children FSP Children:

10. **Amendment No. 12 (MH120205) with Childrens Hospital Los Angeles** increases MHA funds for EPSDT FSP Children Local Match slots by \$12,598; increases EPSDT FFP matching funds for FSP Children slots by \$92,500; increases EPSDT SGF matching funds for FSP Children slots by \$79,902; increases MHA funds for HF FSP Children Local Match slots by \$5,250; increases HF FFP matching funds for FSP Children slots by \$9,750, and increases MHA Local MHP non-Medical funds for indigent Children FSP Children slots by \$25,000, with a revised MCA of \$11,003,500.
11. **Amendment No. 12 (MH120270) with The Los Angeles Child Guidance Clinic** increases MHA match funds for EPSDT FSP Children slots by \$27,921; increases EPSDT FFP funds for FSP Children slots by \$205,000; increases EPSDT SGF match funds for FSP Children slots by \$177,079; increases MHA match funds for HF FSP Children slots by \$5,250; increases HF FFP funds for FSP Children slots by \$9,750; and increases MHA Local MHP non-Medical funds for indigent Children FSP Children slots by \$50,000, with a revised MCA of \$15,415,000.
