**SUBJECT: AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 226 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of July 2008, as follows:

- 1. Amendment No. 7 (DMH-01798) with Institute for Multicultural Counseling & Education Services, Inc.,** increases Early and Periodic Screening, Diagnosis and Treatment (EPSDT)–State General Funds (SGF) by \$11,282 with a revised Maximum Contract Amount (MCA) of \$886,282, for Fiscal Year (FY) 2004-05.
- 2. Amendment No. 7 (MH010054) with The Regents of the University of California, Los Angeles (UCLA)** decreases County General Funds (CGF) by \$500,000 from Addendum A (Countywide Academic and Medical Teaching Services Program) and adds Mental Health Services Act (MHSA) fund by \$500,000. For FYs 2007-08, 2008-09, 2009-10, and 2010-11 total payments for Addendum A shall remain at \$1,448,202.
- 3. Amendment No. 2 (MH060019) with City of Angels Medical Center – Ingleside Campus** extends the term of the Psychiatric Mobile Response Team (PMRT) Psychiatric Outreach Diversion Program (PDP) from July 1, 2008, to June 30, 2009, under the Director of the Department of Health Services (DHS) Medical Alert Center (MAC) to limit it to clients who are uninsured in FY 2008-09. The PDP is designed to alleviate the overcrowding in the County Hospital Psychiatric Emergency Services (PES) when all PES are operating at capacity by diverting clients to participating private hospitals.
- 4. Amendment No. 5 (MH120160) with Hamburger Home dba Aviva Family and Children’s Services dba Aviva Center** decreases Local Mental Health Plan (MHP) non-Medi-Cal Plan funds–CGF by \$2,776; Healthy Families (HF) CGF by

\$10,289; HF Federal Financial Participation (FFP) by \$19,108; Supportive and Therapeutic Options Program (STOP) CGF match by \$3,266; and STOP Department of Children and Family Services (DCFS) by \$7,621. For FY 2008-09, the total MCA will be \$5,851,040.

5. **Amendment No. 7 (MH120160) with Hamburger Home dba Aviva Family and Children's Services dba Aviva Center** adds Targeted Case Management (TCM) (Mode 15, Service Function Codes (SFCs) 01-09) at a rate of \$1.89 and Crisis Intervention (Mode 15, SFCs 70-79) at a rate of \$3.63 to existing Provider Number (PN) 7282 located at 6603 Whitman Ave., Van Nuys, CA 91406. There is no change to the MCA.
6. **Amendment No. 5 (MH120179) with Transitional Living Centers for L.A. County, Inc.**, changes the method of reimbursement from Negotiated Rate (NR) to Cost Reimbursement (CR) for the following Short-Doyle/Medi-Cal (SD/MC) services: Adult Residential (Mode 15, SFCs 65-79) at a rate of \$109.15; TCM Services (Mode 15, SFCs 01-09) at a rate of \$1.60; Mental Health Services (MHS) (Mode 15, SFCs 10-19/30-59) at a rate of \$1.98; and Medication Support (Mode 15, SFCs 60-69) at a rate of \$3.67. There is no change to the MCA.
7. **Amendment No. 6 (MH120189) with Alcott Center for Mental Health Services** adds Mental Health Services Act (MHSA)–Adult Field Capable Clinical Services (FCCS) to an existing service delivery site located at 1433 S. Robertson Blvd., Los Angeles, CA 90035, and also adds Outreach Services–Community Client Services (CCS) (Mode 45, SFCs 20-29) at a rate of \$60.00, under PN 7229. There is no change to the MCA.
8. **Amendment No. 6 (MH120220) with Five Acres – The Boys' and Girls' Aid Society of Los Angeles County** adds EPSDT–FFP funds by \$72,000, EPSDT–SGF by \$61,459 and DCFS Intrafund Transfer Funds (ITF) by \$10,541 for the purpose of the expansion of EPSDT Wraparound services, with a revised MCA of \$11,166,00.
9. **Amendment No. 5 (MH120253) with SHIELDS For Families** increases Provisional CR Rates for the following SD/MC Services: TCM Services (Mode 15, SFCs 01-09) from \$0.98 to \$1.75; MHS (Mode 15, SFCs 10-19/30-59) from \$1.26 to \$2.26; and Crisis Intervention (Mode 15, SFCs 70-79) from \$1.89 to \$3.34, under existing PNs 7365, 7536, 7573, 7465, and 7264. There is no change to the MCA.

10. **Amendment No. 14 (MH120255) with Special Service For Groups** decreases current California Work Opportunity and Responsibility to Kids (CalWORKs) funding for MHS by \$150,000. The revised CalWORKs funding for MHS will be \$75,000 and for Community Outreach Services (COS) will be \$25,000. For FY 2007-08, the revised MCA will be \$26,353,462.
11. **Amendment No. 6 (MH120277) with United American Indian Involvement, Inc.**, increases current CalWORKs funding for MHS by \$20,000. The revised CalWORKs funding for MHS will be \$75,000. For FY 2007-08, the revised MCA will be \$1,114,742.
12. **Amendment No. 8 (MH120277) with United American Indian Involvement, Inc.**, restores the NR for the following SD/MC services for the period of March 1, 2008, through June 30, 2008: TCM Services (Mode 15, SFCs 01-09) to \$1.47; MHS (Mode 15, SFCs 10-19/30-59) to \$1.89; Medication Support (Mode 15, SFCs 60-69) to \$3.51; and Crisis Intervention (Mode 15, SFCs 70-79) to \$2.82. The MCA shall remain the same.
13. **Amendment No. 1 (MH160064) with California Care Center, Inc., dba The Manor** adds to the MHSA Master Agreement list as being qualified to deliver housing and residential (excluding Safe Havens Supportive Housing) MHSA services.

***The following two (2) amendments to LE Agreements (14 to 15) add Contractors to the MHSA Master Agreement List:***

14. **Amendment No. 6 (MH120252) with San Gabriel Children's Center, Inc.**
15. **Amendment No. 8 (MH120279) with Verdugo Mental Health Center**

***The following two (2) amendments to LE Agreements (16-17) shift non-EPSTD CGF to match the Local Mental Health Plan (Local MHP) non-Medi-Cal CGF funds and intend to have County and Contractor amend Agreement to enable Contractor to "transform" a portion of its curtailed outpatient services and resources to MHSA-Client Supportive Services (CSS) Plan services using unspent FY 2007-08 MHSA-CSS plan program funds:***

16. **Amendment No. 7 (MH120210) with Didi Hirsch Psychiatric Service** shifts non-EPSTD CGF match by \$70,609 to Local MHP non-Medi-Cal CGF funds; decreases MHSA Transition Age Youth (TAY) FSP CSS funds by \$42,288 and MHSA Adult FSP CSS funds by \$42,288 and increases MHSA Adult FCCS MHS

funds by \$13,967 and MHSA Adult FCCS MHS non-EPSTD match by \$70,609. For FY 2007-08, the total MCA of \$19,430,124 will remain unchanged.

17. **Amendment No. 12 (MH120255) with Special Services For Groups** shifts non-EPSTD CGF match by \$90,000 to Local MHP non-Medical CGF funds by \$90,000; decreases MHSA Child FSP CSS by \$8,976, Family Supportive Services by \$50,000, MHSA Older Adult FSP CSS by \$30,000, and MHSA Older Adult Services Extender funds by \$40,000; and increases MHSA Adult FCCS and CSS by \$30,576 and \$8,400, and non-EPSTD FFP by \$90,000. There is no change to the MCA.

***The following two (2) amendments to LE Agreements (18-19) decrease HF CGF Funds and HF FFP:***

18. **Amendment No. 5 (MH120176) with South Bay Children's Health Center Association, Inc.**, decreases HF CGF by \$5,051 and HF FFP by \$9,380. For FY 2008-09, the revised MCA will be \$779,069, and for FY 2009-10, the MCA shall remain the same at \$793,500.

20. **Amendment No. 17 (MH120206) with Children's Institute, Inc.**, decreases HF CGF by \$21,836 and increases MHSA Child, FSP MHS funds by \$21,836. For FY 2008-09, the total amount of MHSA funds from FY 2007-08 will be \$21,836 to be transformed to new and/or expanded programs in FY 2008-09 under the MHSA-CSS Plan. For FY 2008-09, the total MCA of \$15,294,600 will remain unchanged.
21. **Amendment No. 6 (MH120230) with Hillside**s decreases HF CGF by \$20,126 and HF FFP by \$37,377 and increases MHSA TAY FCCS and MHS funds by \$20,126 and HF FFP funds by \$37,377. For FY 2008-09, the total amount of MHSA funds from FY 2007-08 will be \$57,503 to be transformed to new and/or

expanded programs in FY 2008-09 under the MHSA-CSS Plan. For FY 2008-09, the total MCA of \$10,471,100 will remain unchanged.

27. **Amendment No. 6 (MH120161) with Heritage Clinic and the Community Assistance Program for Seniors** restores the NR for the following SD/MC services effective March 1, 2008, through June 30, 2008: TCMS (Mode 15, SFCs 01-09) to \$1.70; MHS (Mode 15, SFCs 10-19/30-59) to \$2.19; Medication

Support (Mode 15, SFCs 60-69) to \$3.82; and Crisis Intervention (Mode 15, SFCs 70-79) to \$2.38. There is no change to the MCA.

28. **Amendment No. 6 (MH120180) with The Children's Center of the Antelope Valley** restores the NR for the following SD/MC services effective March 1, 2008, through June 30, 2008: TCMS (Mode 15, SFCs 01-09) to \$1.82; MHS (Mode 15, SFCs 10-19/30-59) to \$2.30; and Medication Support (Mode 15, SFCs 60-69) to \$4.20. There is no change to the MCA.
29. **Amendment No. 6 (MH120249) with Personal Involvement Center, Inc.,** restores the NR for the following SD/MC services effective March 1, 2008, through June 30, 2008: TCMS (Mode 15, SFCs 01-09) to \$1.77; MHS (Mode 15, SFCs 10-19/30-59) to \$2.28; Medication Support (Mode 15, SFCs 60-69) to \$4.21; and Crisis Intervention (Mode 15, SFCs 70-79) to \$3.38. There is no change to the MCA.
30. **Amendment No. 6 (MH120265) with Sunbridge Harbor View Rehabilitation Center, Inc. dba Harbor View Adolescent Center** restores the NR for the following SD/MC services effective March 1, 2008, through June 30, 2008: Day Treatment Intensive – Full Day (Mode 10, SFCs 85-89) to \$107.73; TCMS (Mode 15, SFCs 01-09) to \$1.17; MHS (Mode 15, SFCs 10-19/30-59) to \$1.54; Medication Support (Mode 15, SFCs 60-69) to \$2.81; and Crisis Intervention (Mode 15, SFCs 70-79) to \$2.18. There is no change to the MCA.

***The following three (3) amendments to LE Agreements (31-33) decrease non-EPSTD CGF and non-EPSTD FFP Medi-Cal and intend to have Contractor "transform" a portion of its curtailed outpatient services and resources to MHSA-CSS Plan services using unspent FY 2007-08 MHSA-CSS plan program funds:***

31. **Amendment No. 3 (MH120165) with Los Angeles Unified School District 97<sup>th</sup> Street School** decreases non-EPSTD CGF by \$15,887 and non-EPSTD FFP Medi-Cal by \$15,888. For FY 2008-09, increases MHSA TAY FCCS one time, CSS, and/or MHS funds by \$31,775. For FY 2008-09, the total amount of MHSA funds from FY 2007-08 will be \$31,775 to be transformed to new and/or expanded programs in FY 2008-09 under the MHSA-CSS Plan and for FY 2008-09, the MCA of \$2,801,300 will remain unchanged.
32. **Amendment No. 4 (MH120232) with Institute for Multicultural Counseling & Education Services, Inc., (IMCES)** decreases non-EPSTD CGF by \$3,867 and non-EPSTD FFP Medi-Cal by \$3,867. For FY 2008-09, increases Adult FCCS MHS funds by \$3,867 and non-EPSTD FFP by \$3,867. For FY 2008-09, the total

MHSA funds from FY 2007-08 will be \$3,867 to be transformed to new and/or expanded programs in FY 2008-09 under the MHSA-CSS Plan, and for FY 2008-09, the total MCA of \$1,657,900 will remain unchanged.

33. **Amendment No. 4 (MH120254) with Social Mode Recovery Systems, Inc.**, decreases non-EPSTD CGF by \$150,192 and non-EPSTD FFP Medi-Cal by \$150,192. For FY 2008-09, it increases MHSA Adult Wellness Center MHS funds by \$150,192 and non-EPSTD FFP by \$150,192. For FY 2008-09, the total amount of MHSA funds from FY 2007-08 will be \$150,192 to be transformed to new and/or expanded programs in FY 2008-09 under the MHSA-CSS Plan, and for FY 2008-09, the total MCA of \$2,831,300 will remain unchanged.

***The following seven (7) amendments to LE Agreements (34-40) delete/change and/or add service delivery sites:***

37. **Amendment No. 15 (MH120206) with Children's Institute, Inc.**, adds a new service delivery site located at 10221 South Compton Avenue, Suites 203 & 104, Los Angeles, CA 90002 in accordance with Medi-Cal certification regulations. Services to be provided at this site include Day Treatment Intensive, Full Day (Mode 10, SFCs 85-89); MHS (Mode 15, SFCs 10-19/30-59); Medication Support (Mode 15, SFCs 60-69); Crisis Intervention (Mode 15, SFCs 70-79); Mental Health Promotion (Mode 45, SFCs 10-19); Community Client Services (Mode 45,

There is no change to the MCA.
39. **Amendment No. 15 (MH120255) with Special Service for Groups** changes the service delivery site located at 333 South Central Avenue, Los Angeles, CA 90013, to 420 South San Pedro Street, G4, Los Angeles, CA 90013, under PN 7400. There is no change to the MCA.
40. **Amendment No. 3 (MH120282) with Jewish Family Service of Los Angeles** adds MHSA–Older Adult FCCS to a new service delivery site located at 23430 Hawthorne Blvd., Suite 125, Torrance, CA 90505. Services to be provided are, TCMS (Mode 15, SFCs 01-09); MHS (Mode 15, SFCs 10-19/30/59); Medication Support Services (Mode 15, SFCs 60-69); Crisis Intervention (Mode 15, SFCs 70-79); Outreach Services–Community Client Services (Mode 45, SFCs 20-29); and Support Services–CSS (Mode 60, SFCs 70-79) under a new PN TBA. There is no change to the MCA.

***The following eight (8) amendments to LE Agreements (41-48) decrease Assembly Bill (AB) 2034, non-EPSDT FFP, MHSA AB 2034 Services, and Local MHP non-Medi-Cal CGF, and also increase MHSA Adult FSP MHS, non-EPSDT FFP and in CSS Flex funds:***

41. **Amendment No. 13 (MH120162) with Hillview Mental Health Center, Inc.**, decreases AB 2034 by \$1,151,900; non-EPSDT FFP by \$355,000; MHSA AB 2034 Services by \$35,900; and Local MHP Non-Medi-Cal CGF by \$60,463. Increases \$315,505 in MHSA Adult FSP MHS; \$294,650 in non-EPSDT match; \$294,650 in non-EPSDT FFP; and \$357,921 in CSS (Flex Funds). It increases \$75,124 in MHSA Older Adult FSP MHS; \$60,350 in Non-EPSDT match; \$60,350 in non-EPSDT FFP and \$48,350 in CSS Flex Funds. For FY 2008-09, the MCA will be decreased by \$96,363 with a revised MCA of \$9,785,537.
42. **Amendment No. 20 (MH120144) with Pacific Clinics** decreases AB 2034 by \$2,879,600; non-EPSDT FFP by \$1,308,400; MHSA AB 2034 Services by \$89,900; and Local MHP non-Medi-Cal CGF by \$151,158. It also increases



\$950,268 in MHSA Adult FSP MHS; \$835,084 in non-EPSTD match; \$835,084 in Non-EPSTD FFP; and \$1,094,248 in CSS Flex Funds with a number of 232 service slots. For FY 2008-09, the total MCA will be increased by \$3,714,684 with a revised MCA of \$77,964,276. For FY 2008-09, the total MCA will be decreased by \$4,429,058.

- 43. Amendment No. 13 (MH1202168) with Mental Health America of Los Angeles** decreases AB 2034 by \$2,581,000; non-EPSTD FFP by \$2,599,999; MHSA AB 2034 Services by \$80,600; and Local MHP non-Medi-Cal CGF by \$135,482. It also increases by \$31,636 in MHSA TAY FSP MHS; \$70,000 in non-EPSTD match; \$70,000 in non-EPSTD FFP; \$11,441 in EPSTD match; \$84,000 in EPSTD FFP; \$72,559 in EPSTD SGF; and \$81,120 in the CSS Flex funds. It increases \$196,794 in MHSA Adult FSP MHS; \$1,773,486 in non-EPSTD match and \$1,773,486 in non-EPSTD FFP. It increases \$107,480 in MHSA Wellness Centers MHS; \$318,000 in non-EPSTD match; and \$318,000 in non-EPSTD FFP. It also increases \$195,301 in Client Run Center funds. For FY 2008-09, the total MCA will be decreased by \$293,777 with a revised MCA of \$15,231,920.
- 44. Amendment No. 12 (MH120217) with ENKI Health and Research Systems, Inc.,** decreases AB 2034 by \$874,600; Non-EPSTD FFP by \$200,000; MHSA AB 2034 Services by \$27,300; and Local MHP non-Medi-Cal CGF by \$45,907. It also increases \$288,618 in MHSA Adult FSP MHS; \$282,539 in non-EPSTD match; \$282,539 in non-EPSTD FFP; and \$303,447 in CSS Flex funds. For FY 2008-09, the MCA will be increased by \$9,336 with a revised MCA of \$26,805,512.
- 45. Amendment No. 4 (MH120219) with Exodus Recovery, Inc.,** decreases AB 2034 by \$639,900; non-EPSTD FFP by \$232,500; MHSA AB 2034 services by \$20,000; and Local MHP non-Medi-Cal CGF by \$33,591. It also increases AB 2034 (MHSA Conversion) by \$639,900 and non-EPSTD FFP by \$232,500. For FY 2008-09, the total MCA will be decreased by \$53,591 with a revised MCA of \$7,920,355.
- 46. Amendment No. 8 (MH120234) with Kedren Community Health Center, Inc.,** decreases AB 2034 by \$533,300; non-EPSTD FFP by \$150,000; MHSA AB 2034 Services by \$16,600; and Local MHP non-Medi-Cal CGF by \$27,992. It also increases \$175,989 in MHSA Adult FSP MHS; \$154,657 in non-EPSTD match; \$154,657 in non-EPSTD FFP; and \$202,654 in CSS Flex funds. For FY 2008-09, the total MCA will be decreased by \$39,935 with a revised MCA of \$26,786,365.

47. **Amendment No. 13 (MH120255) with Special Service For Groups** decreases AB 2034 by \$106,700; non-EPSTD FFP by \$50,000; MHSA AB 2034 Services by \$3,300; and Local MHP non-Medi-Cal CGF by \$5,598. It also increases AB 2034 (MHSA Conversion) by \$312,523; non-EPSTD FFP by \$78,000; EPSTD FFP by \$63,000; and EPSTD SGF by \$53,777. For FY 2007-08, the total MCA will be increased by \$341,702 with a revised MCA of \$26,503,462.
48. **Amendment No. 7 (MH120279) with Verdugo Mental Health Center** decreases AB 2034 by \$170,600; non-EPSTD FFP by \$34,100; MHSA AB 2034 Services by \$5,300; and Local MHP non-Medi-Cal CGF by \$8,958.
