SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 68 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of March, as follows:

1. **Amendment No. 5 (MH120174) with San Fernando Valley Community Mental Health Center, Inc.**, rebases the County General Fund (CGF) allocation within their existing Maximum Contract Amount (MCA); reduces \$255,171 from the Local Mental Health Plan (MHP) Non-Medi-Cal; increases Non-Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Medi-Cal in the amount of \$255,171; adds \$255,171 in Non-EPSDT-Federal Financial Participation (FFP) Medi-Cal for a combined total increase of \$255,171; reduces \$20,154 from Local MHP Non-Medi-Cal funds and increases EPSDT Medi-Cal in the amount of \$20,154; and increases EPSDT State General Fund (SGF) in the amount of \$117,509 and EPSDT-FFP in the amount of \$137,662. The revised MCA will be \$27,990,509.
2. **Amendment No. 4 (MH120224) with Gateways Hospital and Mental Health Center** reduces Mental Health Services Act (MHSA) Institutions for Mental Disease (IMD) Step Down Non-Medi-Cal funds by \$224,000 and redirects these funds to services in another area. Adds Non-EPSDT-FFP funds in the amount of \$224,000 and MHSA IMD Step Down Non-EPSDT-FFP Match funds in the amount of \$224,000; reduces MHSA IMD Step Down Non-Medi-Cal funds by \$671,000 and redirects these funds to services in another area. Adds Non EPSDT-FFP funds in the amount of \$671,000 and MHSA IMD Step Down Non EPSDT-FFP Match funds in the amount of \$671,000. Fiscal Year (FY) 2007-08 MCA will increase by \$224,000 with a revised MCA of \$15,366,267 and FY 2008-09 MCA will increase by \$671,000 with a revised MCA of \$15,817,300. Increases the provisional Cost Reimbursement (CR) Rates for the following

Short-Doyle/Medi-Cal Services (SD/MC) : Case Management Services (Mode 15, Service Function Codes [SFCs] 01-09) from \$1.17 to \$1.47; Mental Health Services (Mode 15, SFCs 10-19/30-59) from \$1.69 to \$1.99; Therapeutic Behavioral services, (Mode 15, SFC 58) from \$1.69 to \$1.99; and Medication Support, (Mode 15, SFCs 60-69) from \$3.19 to \$4.28.

3. **Amendment No. 4 (MH120217) with ENKI Health and Research Systems, Inc.**, FY 2007-08 increases \$28,250 in Non-EPSTD-FFP and adds \$113,142 in MHSA Wellness Centers Non Client-Run for a combined total increase of \$141,392. For FY 2008-09, increases \$84,750 in Non-EPSTD-FFP and adds \$339,426 in MHSA Wellness Center Non Client-Run for a combined total increase of \$424,176. Provider Number (PN) 7472 has changed from 2130 East First Street, Suites 205 and 305, Los Angeles, CA 90033 to 2130 East First Street, Suites 250 and 305, Los Angeles, CA 90033. PN 7452 has changed from 3208 Rosemead Boulevard, South El Monte, CA 91731 to 3208 Rosemead Boulevard, Suite 100, South El Monte, CA 91731. The revised MCA for FY 2007-08 is \$27,737,592 and for FY 2008-09 is \$26,796,176.
4. **Amendment No. 3 (MH120210) with Didi Hirsch Psychiatric Service** intends to change the suite number for PN 7209 located at 111 No. La Brea Avenue, Inglewood, CA 90301 from Number 201 to Numbers 500 and 700. The MCA shall remain the same at \$19,448,700 for FY 2007-08 and \$18,848,700 for FY 2008-09.
5. **Amendment No. 1 (MH120149) with Cedars-Sinai Medical Center** changes Cedars-Sinai – Infant and Child Outpatient service delivery site from 8730 Alden Drive – Thaliens, Room W104, Los Angeles, CA 90048 to 8730 Alden Drive – Thaliens, Room W112, Los Angeles, CA 90048, under the existing PN 1980. There is no change to the MCA.
6. **Amendment No. 5 (MH120168) with Mental Health America of Los Angeles** changes the LE name from National Mental Health Association of Greater Los Angeles to Mental Health America of Los Angeles; adds a new MHSA Wellness Center (Client-Run) Services Site South Los Angeles Wellness Recovery Center to be located at 11905 S. Central Avenue, Los Angeles, CA 90050; adds the following services to the new service Delivery Site located at 11905 S. Central Avenue, Los Angeles, CA 90050, under PN To Be Determined (TBD) Mental Health Promotion (Mode 45, SFCs 10-19) and Community Client Services (Mode 45, SFCs 20-29). There is no change to the MCA.

7. **Amendment No. 3 (MH050015) with Mental Health America of Los Angeles** changes the Consultant's name from National Mental Health Association of Greater Los Angeles to Mental Health America of Los Angeles. There is no change to the MCA.
8. **Amendment No. 1 (MH050019) with Mental Health America of Los Angeles** changes the Consultant's name from National Mental Health Association of Greater Los Angeles to Mental Health America of Los Angeles. There is no change to the MCA.
9. **Amendment No. 5 (MH120162) with Hillview Mental Health Center, Inc.**, decreases Local MHP funds--CGF in the amount of \$94; decreases Non-EPSTD-CGF in the amount of \$1,459; decreases Non-EPSTD-FFP Medi-Cal in the amount of \$1,459. For FY 2007-08, the total MCA will be decreased by \$3,012 with a revised MCA of \$9,878,888.
10. **Amendment No. 2 (MH120212) with D'Veal Corporation dba D'Veal Family and Youth Services** decreases Non-EPSTD-CGF by \$1,000; decreases Non-EPSTD-FFP Medi-Cal by \$1,000; decreases Healthy Family (HF) CGF by \$619; decreases HF FFP by \$1,150. For FY 2007-08, the total MCA will be decreased by \$3,769 with a revised MCA of \$5,438,631.

***The following two (2) amendments to LE Agreements (11 to 12) change the method of reimbursement from Negotiated Rate (NR) to CR for the following Short-Doyle/Medi-Cal services for FYs 2007-08 and 2008-09.***

For FYs 2007-08 and 2008-09, the revised MCA will be \$8,339,150 and \$8,339,150 respectively.
29. **Amendment No. 1 (MH120212) with D'Veal Corporation dba D'Veal Family and Youth Services** decreases CalWORKs funding for MHS by \$30,200; decreases current CalWORKs funding for COS by \$7,800; and the revised CalWORKs funding for MHS will be \$130,000 and \$10,000 for COS. For FY 2007-08, the revised MCA will be \$5,442,400.
