SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 24 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of December, as follows:

- 1. Amendment No. 2 (MH010054) with The Regents of the University of California, Los Angeles (UCLA)** adds a new Addendum F – Professional Development and Consultation Program for Co-Occurring Mental Health and Substance Abuse Disorders (COD) and Human Immunodeficiency Virus/Acquired Immune Deficiency Syndrome (HIV/AIDS) Recommended Care Program for Transition Age Youth (TAY), adults, and older adults. For Fiscal Year (FY) 2007-08 it also adds Mental Health Services Act (MHSA) funds in the amount of \$500,000 to the Addendum F. The revised Maximum Contract Amount (MCA) for FY 2007-08 will be \$5,150,218.
- 2. Amendment No. 8 (MH120134) with Harbor View Rehabilitation Center, Inc., dba Harbor View Adolescent Center** makes a technical correction to reform the contract in accordance with the parties' original understanding and intent by deleting the rate of \$205.83 from Patch for Institution for Mental Disease (IMD), Mode 05, Service Function Code (SFC) 36 for Provider No (PN) 0054, and adding the rate of \$198.42 to Patch for IMD, Mode 05, SFC 36 for PN 0054. There is no change to the MCA.
- 3. Amendment No. 3 (MH120162) with Hillview Mental Health Center, Inc.,** increases MHSA Urgent Care funds in the amount of \$20,000. The revised MCA will be \$9,881,900.

4. **Amendment No. 3 (MH120174) with San Fernando Valley Community Mental Health Center, Inc.**, adds MHA TAY Probation Camp Services funds for FY 2007-08 in the amount of \$112,867, which includes MHA one-time costs totaling \$14,108. For FY 2008-09 it adds MHA TAY Probation Camp Services funds in the amount of \$169,300. The revised MCA for FY 2007-08 will be \$27,480,167 and for FY 2008-09 it will be \$27,486,600.
5. **Amendment No. 3 (MH120193) with Associated League of Mexican Americans, Inc., dba ALMA Family Services** adds MHA TAY Probation Camp Services funds for FY 2007-08 in the amount of \$59,066, which includes MHA one-time costs totaling \$7,383. For FY 2008-09 it adds MHA TAY Probation Camp Services funds in the amount of \$88,600. The revised MCA for FY 2007-08 will be \$6,225,066 and for FY 2008-09 it will be \$6,224,600.
6. **Amendment No. 1 (MH120197) with Braswell Rehabilitation Institute for Development of Growth and Education Services, Inc.**, increases Non-Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Federal Financial Participation (FFP) funds in the amount of \$50,000. It shifts MHA Wellness Centers – Non Client Run in the amount of \$50,000 to Non-EPSDT Medi-Cal County General Funds (CGF). This amendment also adds the following Provisional Rates under Cost Reimbursement: Community Client Services, Mode of Service 45, SFCs 20-29, at a rate of \$40.00; and Client Supportive Services, Mode of Services 60, SFCs 64/70-79, under existing Medi-Cal/Short-Doyle PN 7595. The revised MCA for FYs 2007-08 and 2008-09 will be \$2,411,000.
7. **Amendment No. 2 (MH120217) with ENKI Health and Research Systems, Inc.**, decreases Department of Public Social Services (DPSS) California Work Opportunity and Responsibility to Kids (CalWORKs) funds for Mental Health Services (MHS) in the amount of \$400,000. The revised MCA for FYs 2007-08 and 2008-09 will be \$26,372,000.
8. **Amendment No. 1 (MH120253) with SHIELDS For Families** adds Mentally Ill Offenders Crime Reduction (MIOCR) grant funds for the provision of Functional Family Therapy (FFT) MHS to Seriously Emotional Disturbed (SED) juvenile offenders. It adds Probation – MIOCR funds in the amount of \$88,041, EPSDT State General Funds (SGF) in the amount of \$513,329, and EPSDT FFP funds in the amount of \$601,370. This amendment also makes a technical correction to identify funding of \$150,000 for the Schiff-Cardenas – Multi-Systemic Therapy Program (MST). The revised MCA for FY 2007-08 will be \$7,933,940.

9. **Amendment No. 2 (MH120253) with SHIELDS For Families** changes the service delivery site located at 105 West Victoria, Long Beach, CA 90805 to 121 West Victoria, Long Beach, CA 90805, under PN 7465. It also adds service delivery site located at 1720 East Kay Street, Compton, CA 90221, for the delivery of services for Targeted Case Management Services, Mode 15, SFCs 01-09; MHS, Mode 15, SFCs 10-19/30-59; Medication Support, Mode 15, SFCs 60-69; Crisis Intervention, Mode 15, SFCs 70-79. There is no change to the MCA.
10. **Amendment No. 6 (MH120261) with Star View Adolescent Center, Inc.**, adds MIOCR grant funds for the provision of FFT MHS to SED juvenile offenders. It adds Probation – MIOCR funds in the amount of \$51,921, EPSDT SGF funds in the amount of \$302,729, and EPSDT FFP funds in the amount of \$354,650. The revised MCA for FY 2007-08 will be \$27,254,350.
11. **Amendment No. 1 (MH120267) with Telecare Corporation** reduces \$214,000 from Local Mental Health Plan Non-Medi-Cal funds and increases Non-EPSDT-CGF by the amount of \$214,000. It also adds \$214,000 in Non-EPSDT-FFP Medi-Cal funds. The revised MCA for FY 2007-08 will be \$10,332,700.
12. **Amendment No. 2 (MH120280) with Vista Del Mar Child and Family Services** changes provider service delivery city site from Vista Del Mar WrapAround SA 8, 11222 S. La Cienega Boulevard, Suite 115, Los Angeles, CA 90304 to Vista Del Mar WrapAround SA 8, 11222 S. La Cienega Boulevard, Suite 115, Inglewood, CA 90304.
13. **Amendment No. 1 (MH140035) with Mental Health Systems, Inc.**, adds a new service site located at Logan River Academy, LLC, 1683 South Highway 89/91, Logan, Utah 84321 for MHS to children and adolescents between 11 to 18 years of age.
14. **Amendment No. 1 to Medi-Cal Professional Services Agreements with 11 individual providers** temporarily adds provisional payment language for the period effective July 1, 2006, through June 30, 2009, or until the Department of Mental Health's adjudication process is restructured to reduce Fee-For-Service Network Providers payment wait time, whichever comes first.
