SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 164 amendments to existing Legal Entity Agreements, Specialized Agreements, and Clinical Assessment programs processed in the month of July, as follows:

1. **Amendment No. 3 (DMH-01900) with Aurora Charter Oak Hospital**, increases the administrative day rate from \$296.03 to \$374.75, pursuant to a directive by the California Department of Mental Health (CDMH) mandate and is authorized by Sections 1820.110, 1820.115 and 51542, Title 9, California Code of Regulations.
2. **Amendment No. 2 (DMH-01912) with Glendale Adventist Medical Center**, increases the administrative day rate from \$296.03 to \$374.75, pursuant to a directive by the CDMH mandate and is authorized by Sections 1820.110, 1820.115 and 51542, Title 9, California Code of Regulations.
3. **Amendment No. 7 (DMH-02066) with National Mental Health Association of Greater Los Angeles**, adds \$70,292 in one-time only County General Funds (CGF) for the provision of payment for client stipends for Fiscal Year (FY) 2005-06.
4. **Amendment No. 3 (DMH-02099) with California Hispanic Commission, Inc.**, adds Department of Children and Family Services (DCFS) Specialized Foster Care Program Funds in the amount of \$1,826, State General Funds (SGF)-Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) program funds in the amount of \$8,174, and EPSDT-Federal Financial Participation (FFP) funds in the amount of \$10,000 for the Countywide Enhanced Specialized Foster Care Mental Health Services Plan.

Increases EPSDT-CGF funds in the amount of \$45,650, increases EPSDT-FFP revenue in the amount of \$250,000, and increases EPSDT-SGF in the amount of \$204,350, for a combined total increase of \$500,000 to the Maximum Contract Amount (MCA) for FY 2005-06.
6. **Amendment No. 3 (DMH-02115) with Phoenix Houses of Los Angeles, Inc.**, increases EPSDT-CGF funds in the amount of \$18,260, increases EPSDT-FFP revenue in the amount of \$100,000, and increases EPSDT-SGF in the amount of \$81,740, for a combined total increase of \$200,000 to the MCA for FY 2005-06.
7. **Amendment No. 3 (DMH-02117) with St. Francis Medical Center – Children's Counseling Center**, amends Agreement to increase \$3,467 in EPSDT-CGF Program Match, decrease \$19,662 in Non-EPSDT-CGF Medi-Cal Match, increase \$18,986 in Medi-Cal FFP, decrease \$19,662 in Non-EPSDT Medi-Cal FFP, increase \$15,519 in EPSDT-SGF for a combined total decrease of \$1,352 to the MCA.

10. **Amendment No. 5 (DMH-02125) with Telecare Corporation**, increases Non-EPSDT Medi-Cal FFP funds in the amount of \$545,124, increases CGF-Psychiatric Emergency Services (PES) in the amount of \$49,000, shifts \$493,296 from Assembly Bill (AB) 2034 Local Mental Health Plan (MHP) Non-Medi-Cal funds to AB 2034 Match for Non-EPSDT Medi-Cal FFP, and shifts \$51,828 from CGF to CGF Match for Non-EPSDT Medi-Cal FFP, for a combined total increase of \$594,124 to the MCA for the delivery of community-based mental health care services. Increases the Provisional Cost Reimbursement (CR) rates for the following Short-Doyle/Medi-Cal services: Mode 05, SFCs 20-29 (Psychiatric Health Facility – PHF), from \$318.61 to \$374.82; Mode 15, SFCs 01-09 (Targeted Case Management Services), from \$1.01 to \$1.44; Mode 15, SFCs 10-19/30-59 (Mental Health Services), from \$1.22 to \$1.96; Mode 15, SFCs 60-69

(Medication Support), from \$2.28 to \$3.75; Mode 15, SFCs 70-79 (Crisis Intervention), from \$1.84 to \$3.36; Mode 45, SFCs 10-19 and 20-29 (Outreach Services), from \$76.05/Hr. to \$86.40/Hr.; and Mode 60, SFCs 40-49 (Life Support/Board and Care), from \$27.00 to \$27.41.

Laurel Park's IMD services shall be recorded as Mode 05, SFC 35, IMD services (Beds 1-59) with a rate of \$119.74. Olive Vista's IMD services shall be recorded as Mode 05, SFC 35 (Beds 60 & over), with a rate of \$165.50; Mentally Ill Offenders (MIO) Regular services shall be recorded as Mode 05, SFCs 36-39 (37), with a rate of \$158.70; and MIO Indigent services shall be recorded as Mode 05, SFCs 36-39 (38), with a rate of \$215.72. Sierra Vista's IMD services with Patch, shall be recorded as Mode 05, SFCs 36-39 (36), with a rate of \$183.09.
