

SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 66 amendments to existing Legal Entity Agreements, Specialized Agreements, and Clinical Assessment programs processed in the month of June, as follows:

1. **Amendment No. 3 (DMH-01739) with California State University, Long Beach Foundation**, adds Mental Health Services Act (MHSA) funds in the amount of \$800,000, from \$200,000 to \$1,000,000 to train additional number of students for Fiscal Year (FY) 2005-06.
2. **Amendment No. 4 (DMH-01750) with ValueOptions, Inc.**, extends the contract term one (1) year, beginning 7/1/06 to 6/30/07.
3. **Amendment No. 1 (DMH-02042) with Parents of Watts Working with Youth & Adults**, amends the Agreement to extend the term of the Agreement by three (3) months to allow the Agreement to continue in full force and in effect through September 30, 2006.
4. **Amendment No. 6 (DMH-02066) with National Mental Health Association of Greater Los Angeles**, adds \$100,000 in one-time only MHSA funds for the provision of consultation services to the Department of Mental Health (DMH) planning and stakeholders process, to support the implementation of current plans and to develop new plans for the capital facilities and technology, education and training, prevention and early intervention, and innovation MHSA components.

5. **Amendment No. 6 (DMH-02105) with D'Veal Corporation dba D'Veal Family and Youth Services**, amends Agreement to change the method of reimbursement from Negotiated Rate (NR) to Cost Reimbursement (CR).
6. **Amendment No. 9 (DMH-02120) SHIELDS For Families**, increases the Early and Periodic Screening, Diagnosis, and Treatment (EPSDT)–County General Funds (CGF) in the amount of \$11,889, EPSDT-State General Funds (SGF) in the amount of \$53,218, and EPSDT-Federal Financial Participation (FFP) in the amount of \$65,107, for a net increase of \$130,214 to the Maximum Contract Amount (MCA).
7. **Amendment No. 5 (DMH-02122) with Star View Adolescent Center, Inc.**, adds \$150,000 in CGF for the Functional Family Therapy Program (FFT), for FYs 2005-06, 2006-07, and 2007-08.
8. **Amendment No. 3 (DMH-02124) with Tarzana Treatment Center, Inc.**, decreases EPSDT funds in the amount of \$319,000 for FY 2005-06.
9. **Amendment No. 4 (DMH-02270) with ASC Treatment Group**, adds Psychiatric Emergency Services (PES) CGF in the amount of \$13,000, EPSDT-FFP funds in the amount of \$58,495, and Non EPSDT-CGF in the amount of \$58,495, for a combined total increase of \$129,990 for the delivery of mental health services.
10. **Amendment No. 6 (DMH-02272) with Providence Community Services, LLC**, adds Department of Children and Family Services (DCFS) Specialized Foster Care Program funds in the amount of \$5,295, EPSDT-SGF in the amount of \$23,705 and EPSDT-FFP in the amount of \$29,000. Adds a new Provider Number To Be Announced (TBA) to the service site located at 21520 S. Pioneer Blvd., #110, Hawaiian Gardens, CA 90716 to provide the following services: Mode 15, Service Function Codes (SFCs) 01-09 (Targeted Case Management), Mode 15, SFCs 10-19/30-59 (Mental Health Services), Mode 15, SFCs 60-69 (Medication Support), and Mode 15, SFCs 70-79 (Crisis Intervention).
11. **Amendment No. 3 (DMH-02280) with Cedars-Sinai Medical Center dba Thaliens Mental Health Center.**, amends the NR for the following Short-Doyle/Medi-Cal services: Mode 15, SFCs 01-09 (Targeted Case Management Services) from \$1.71 to \$1.95, Mode 15, SFCs 10-19/30-59 (Mental Health Services) from \$2.19 to \$2.52, Mode 15, SFCs 60-69 (Medication Support Services) from \$4.07 to \$4.65.
12. **Amendment No. 5 (DMH-02289) with Community Family Guidance Center**, adds DCFS Specialized Foster Care Program funds in the amount of \$5,295,

- EPSDT-SGF in the amount of \$23,705, and EPSDT-FFP in the amount of \$29,000. Amends Agreement to add two (2) new Provider Numbers TBA to the service sites located at 10929 South Street, Suite 208B, Cerritos, CA 90703, and 8320 Iowa Street, Downey, CA 90241, to provide the following services: Mode 15, SFCs 01-09 (Targeted Case Management), SFCs 10-19/30-59 (Mental Health Services) SFCs 60-69 (Medication Support), and SFCs 70-79 (Crisis Intervention).
13. **Amendment No. 4 (DMH-02296) with El Centro De Amistad, Inc.**, increases CGF-EPSDT Program Match by \$29,125, EPSDT-FFP Medi-Cal by \$159,500 and EPSDT-SGF by \$130,375, for a total combined total increase of \$319,000 to the MCA.
  14. **Amendment No. 7 (DMH-02300) with ENKI Health and Research Systems, Inc.**, adds DCFS Services Specialized Foster Care Program funds in the amount of \$5,295, EPSDT-SGF in the amount of \$23,705, and EPSDT-FFP in the amount of \$29,000. Adds a new Provider Number TBA to the service site located at 1000 Goodrich Blvd., Commerce, CA 90022, to provide the following services: Mode 15, SFCs 01-09 (Targeted Case Management), SFCs10-19/30-59 (Mental Health Services), SFCs 60-69 (Medication Support), and SFCs 70-79 (Crisis Intervention).
  15. **Amendment No. 4 (DMH-02314) with Hathaway-Sycamores Child and Family Services**, extends Cash Flow Advance (CFA) for November through December of FY 2005-06 in an amount not to exceed \$1,626,759 per month. Amends the Agreement to add revised Board – mandated language in regards to “Contractor Responsibility and Debarment” and “Contractor’s Charitable Activities Compliance” for FY 2005-06 and any subsequent fiscal years. Adds Attachment IX-Charitable Contributions Certification to the Agreement.
  16. **Amendment No. 5 (DMH-02320) with Hillview Mental Health Center**, amends Agreement to make a technical adjustment to the financial summary to accurately reflect CGF-PES in the amount of \$470,850 as CGF. Adds CGF in the amount of \$78,475, and MHSA funds in the amount of \$392,375 to total \$470,850 which is added to the MCA to fund the purchase of 12 residential beds as part of the Olive View PES Relief Plan.
  17. **Amendment No. 9 (DMH-02323) with Institute for the Redesign of Learning**, increases \$18,990 in EPSDT-CGF, \$104,000 in EPSDT-FFP Medi-Cal funds, and \$85,010 in EPSDT-SGF for a combined total increase of \$208,000 to the MCA.
