**SUBJECT: AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 163 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of March, as follows:

1. **Amendment No. 6 (DMH-01760) with Bienvenidos Children's Center, Inc.**, revises the Negotiated Rates for the following Short-Doyle/Medi-Cal (SD/MC) services: Mode 10, Service Function Codes (SFCs) 85-89 (Day Treatment Intensive: Full Day) from \$154.28 to \$159.50; Mode 15, SFCs 01-09 (Targeted Case Management Service) from \$1.21 to \$1.59; Mode 15, SFCs 10-19/30-59 (Mental Health Services) from \$1.54 to \$2.05; Mode 15, SFCs 60-69 (Medication Support) from \$3.59 to \$3.80; and Mode 15, SFCs 70-79 (Crisis Intervention) from \$2.89 to \$3.06.
2. **Amendment No. 5 (DMH-01934) with California Institute for Mental Health (CIMH)**, adds Substance Abuse and Mental Health Services Administration (SAMHSA) Federal block grant funds in the amount of \$20,000 to the Total Compensation Amount (TCA) for co-occurring disorders.
3. **Amendment No. 6 (DMH-01934) with California Institute for Mental Health (CIMH)**, amends Agreement to allow access to Mental Health Services Act (MHSA) Community Program Planning funds in the amount of \$45,000, which were allocated in Fiscal Year (FY) 2004-05 in previous Amendment #3 to the TCA for continuing the MHSA planning process in FY 2005-06 to create a Community Services and Support Plan in accordance with provisions of the MHSA within guidelines established by the State Department of Mental Health (SDMH).

4. **Amendment No. 8 (DMH-01934) with California Institute for Mental Health (CIMH)**, adds MHSAs funds in the amount of \$170,000 to the Total Compensation Amount (TCA) for consultation services on the implementation of MHSAs Community Services and Supports Plan.
5. **Amendment No. 4 (DMH-02066) with National Mental Health Association of Greater Los Angeles**, adds MHSAs funds in the amount of \$21,252 to the TCA for the provision of support services for outreach and engagement activities to increase participation of service providers, service recipients, their families, unserved and underserved populations in the planning process for the implementation of the MHSAs.
6. **Amendment No. 5 (DMH-02105) with D'Veal Corporation dba D'Veal Family and Youth Services**, makes a technical adjustment to the financial summary to accurately reflect California Work Opportunity and Responsibility to Kids (CalWORKs) – Mental Health Services (MHS) as \$184,000, and CalWORKs – Community Outreach Services (COS) as \$16,000, changes the reimbursement method of Mode 45, SFCs 10-29 from Negotiated Rate (NR) to Cost Reimbursement (CR) at a rate of \$75.00.
7. **Amendment No. 2 (DMH-02113) with Optimist Boys' Homes and Ranch, Inc. dba Optimist Youth Homes and Family Services**, amends the NR for the following SD/MC services: Mode 10, SFCs 95-99 from \$95.40 to \$97.59; Mode 15, SFCs 01-09 from \$1.40 to \$1.50; Mode 15, SFCs 10-19/30-59 from \$1.88 to \$1.94; and Mode 15, SFCs 60-69 from \$3.51 to \$3.59.
8. **Amendment No. 5 (DMH-02282) with Child and Family Center**, adds a new service site located at 21704 W. Golden Triangle Road, Suite 500, Santa Clarita, CA 91350, under a new Provider Number to be determined (TBD).
9. **Amendment No. 5 (DMH-02283) with Child and Family Guidance Center**, shifts from Probation – Schiff-Cardenas funds for Mental Health Screening, Assessment, and Treatment (MHSAT) an amount of \$65,000 to Probation – Schiff-Cardenas for the MultiSystemic Therapy (MST) Program, and decreases the Probation – Schiff-Cardenas funds for the MST Program in the amount of \$7,500 for FY 2005-06 and any subsequent fiscal years.
10. **Amendment No. 5 (DMH-02300) with ENKI Health and Research Systems, Inc.**, adds one-time CalWORKs Homeless Families Projects funds to the Maximum Contract Amount (MCA) in the amount of \$300,000 for FY 2005-06 only.

11. **Amendment No. 1 (DMH-02332) with The Los Angeles Child Guidance Clinic**, decreases County General Funds (CGF) (Local Mental Health Plan (MHP) Non Medi-Cal) in the amount of \$28,573 from the MCA, to be used as a County Match to the State of California – Department of Rehabilitation Cooperative Agreement, which allows for the provision of vocational services to Los Angeles County's mentally ill clients for FY 2005-06 only.
12. **Amendment No. 2 (DMH-02332) with The Los Angeles Child Guidance Clinic**, amends Agreement to shift \$297,432 in Non-Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Medi-Cal County Local Match to Local MHP Non Medi-Cal – CGF and reduces Non-EPSDT Medi-Cal Federal Financial Participation (FFP) funds in the amount of \$297,432, reduces Individuals with Disabilities Education Act (IDEA) funds in the amount of \$368,172. The MCA will be decreased by a total amount of \$665,604 for FY 2005-06 only.
13. **Amendment No. 3 (DMH-02332) with The Los Angeles Child Guidance Clinic**, reduces the Family Preservation funds from the MCA in the amount of \$100,000 for FY 2005-06.
14. **Amendment No. 4 (DMH-02332) with The Los Angeles Child Guidance Clinic**, extends the Cash Flow Advance (CFA) program from October through December FY 2005-06 only, and is not to exceed \$965,394 per month.
15. **Amendment No. 5 (DMH-02332) with The Los Angeles Child Guidance Clinic**, increases CGF (Local MHP Non Medi-Cal) in the amount of \$28,573 to restore the same amount of funding taken to be used as a County Match to the State of California – Department of Rehabilitation Cooperative Agreement in Amendment Number 1.
16. **Amendment No. 8 (DMH-02339) with National Mental Health Association of Greater Los Angeles**, reduces MHSA funds in the amount of \$21,252 from the MCA for the transfer of funds to the Consultant Services Agreement for the provision of support services for outreach and engagement activities to increase participation of service providers, service recipients, their families, and unserved and underserved populations in the planning process for the implementation of the MHSA.
17. **Amendment No. 3 (DMH-02340) with New Horizons Family Center**, adds EPSDT-CGF Growth Match funds in the amount of \$9,084, EPSDT-FFP Medi-Cal funds in the amount of \$49,750, and EPSDT-State General Funds (SGF) in the amount of \$40,666, for a combined total increase of \$99,500 to the MCA.

18. **Amendment No. 10 (DMH-02343) with Pacific Clinics**, adds one-time CalWORKs Homeless Families Projects funds to the MCA in the amount of \$300,000 for FY 2005-06.

Vermont Avenue, Los Angeles, CA 90044 under an existing Provider Number 7409; and adds SD/MC services under the rates specified to the new service site: Targeted Case Management Services (Mode 15, SFCs 01-09 at a rate of \$1.83); Mental Health Services (Mode 15, SFCs 10-19/30-59 at a rate of \$2.36); Medication Support Services (Mode 15, SFCs 60-69 at a rate of \$4.37); Crisis Intervention Services (Mode 15, SFCs 70-79 at a rate of \$3.52); Community Outreach Services (Mode 45, SFCs 10-19/20-29 at a rate of \$65.00); and Client Support Services (Mode 60, SFC 64) reimbursed at actual cost.
