SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 155 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of September, as follows:

1. **Amendment No. 1 (MH120005) with Associated League of Mexican Americans, Inc.**, adds Therapeutic Behavioral Services (TBS) for seriously emotionally disturbed children/youth under the age of 21.
2. **Amendment No. 1 (MH120013) with Children's Institute, Inc.**, adds a new Provider Number for service site located at 4300 Long Beach Blvd., Suite 700, Long Beach, CA 90807. Services to be provided at this site include Targeted Case Management Brokerage, Mental Health Services and Medication Support Services.
3. **Amendment No. 2 (MH120018) with El Centro De Amistad, Inc.**, adds \$316,000 to the Maximum Contract Amount (MCA) for additional medication support services.
4. **Amendment No. 1 (MH120021) with Ettie Lee Homes** amends the Agreement to add Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) funds in the total amount of \$300,000 for Fiscal Years (FYs) 2006-07, 2007-08, and 2008-09.
5. **Amendment No. 1 (MH120028) with Gateways Hospital and Mental Health Center** shifts \$460,000 from County General Fund-Psychiatric Emergency Services (CGF-PES) Match to Local Mental Health Plan (MH) CGF-PES and decreases CGF-PES/Federal Financial Participation (FFP) Match by \$460,000.

6. **Amendment No. 2 (MH120072) with Westside Center for Independent** adds \$22,721 of Mental Health Services Act (MHSA) funding for FY 2006-07 only to provide Client Supportive Services.
7. **Amendment No. 1 (MH120101) with Hamburger Home dba Aviva Center** requests a Provider Number to be added, and adds a new service site identified as Hamburger Home dba Aviva Center Valley Wraparound Outpatient located at 12817 Victory Blvd., North Hollywood, CA 91606-3012. The following Short-Doyle/Medi-Cal services will be provided at the service site: Targeted Case Management Services, Mental Health Services, Medication Support and Crisis Intervention Services at the rates specified in the LE Agreement.
8. **Amendment No. 2 (MH120119) with Phoenix Houses of Los Angeles, Inc.,** amends the contract to increase Provisional Cost Reimbursement Rates for the following Short-Doyle/Medical Services: Targeted Case Management Services, Mode 15, Service Function Codes (SFCs) 01-09, from \$1.77 to \$1.86; Mental Health Services, Mode 15, SFCs 10-19/30-59 from \$2.28 to \$2.40; Medication Support, Mode 15, SFCs 60-69 from \$3.73 to \$3.90; and Crisis Intervention, Mode 15, SFCs 70-79 from \$3.41 to \$3.58.
9. **Amendment No. 1 (MH120021) with Ettie Lee Homes, Inc.,** adds CGF-EPSTD in the amount of \$300,000 for FYs 2006-07, 2007-08, and 2008-09.
10. **Amendment No. 1 (MH120125) with SHIELDS For Families** adds Department of Health Services Office of AIDS Programs and Policy's (DHS-OAPP HIV/AIDS) funds in the amount of \$47,000, to provide services to mental health clients with AIDS. The funds will be transferred from the South Central Health and Rehabilitation Program.
11. **Amendment No. 1 (MH120127) with South Central Health and Rehabilitation Program (SCHARP)** decreases the MCA by \$47,000 DHS-OAPP HIV/AIDS funds for mental health services to clients with AIDS. The funds will be transferred to SHIELDS, a Department of Mental Health (DMH) contractor. The Amendment also changes the name from Wilshire Children's Center to Children's Services.
12. **Amendment No. 1 (MH120128) with Special Service for Groups** adds CGF-EPSTD in the amount of \$111,459; adds EPSTD-FFP in the amount of \$610,400; and adds EPSTD-State General Funds (SGF) in the amount of \$498,941, for a total combined increase of \$1,220,800 to the MCA for FYs 2006-07, 2007-08,

and 2008-09. This money is being redirected from Devereaux – Santa Barbara, an agency that closed its program effective June 30, 2006.

13. **Amendment No. 2 (MH120128) with Special Service for Groups** adds EPSDT-CGF in the amount of \$180,701; adds EPSDT-FFP in the amount of \$989,600, and adds EPSDT-SGF in the amount of \$808,899, for a combined total increase of \$1,979,200 to the MCA for FYs 2006-07, 2007-08, and 2008-09. The money is to fund the expansion of mental health services for children and transitional age youth.
