

SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 61 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), processed in the month of April, as follows:

1. **Amendment No. 6 (DMH-1644) with Hamburger Home dba Aviva Center**, changes the interim rates and reimbursement method to Cost Reimbursement for the following Short-Doyle/Medi-Cal Services: Mode 10, Service Function Code (SFC) 95-99 Day Rehab – Full Day from \$94.96 to \$122.75; Mode 15, SFC 01-09 Targeted Case Management Services from \$1.32 to \$1.89; Mode 15 SFC 10-19/30-59 Mental Health Services from \$1.75 to \$2.44; Mode 15, SFC 60-69 Medication Support Services from \$3.24 to \$4.51; and Mode 15, SFC 70-79 Crisis Intervention Services from \$2.57 to \$2.63 for Fiscal Year (FY) 2004-05.
2. **Amendment No. 9 (DMH-01654) with San Fernando Valley Community Mental Health Center, Inc.**, adds County General Funds (CGF) funded by Sales Tax Realignment in the amount of \$11,500 to the Maximum Contract Amount (MCA) to provide additional peer advocacy services to Provider No. 7252 for FY 2004-05.
3. **Amendment No. 3 (DMH-01655) South Bay Children's Health Center Association**, changes the Day Rehabilitation Program Provider Number 7220 from 410 South Camino Real, Redondo Beach, CA 90277 to 17800 Van Ness Avenue, Torrance, CA 90504.
4. **Amendment No. 4 (DMH-01766) with Child and Family Center**, adds \$104,796 in Non Early and Periodic Screening, Diagnosis and Treatment (EPSDT), Federal Financial Participation (FFP), and reduces other CGF by \$48,367 for a net increase of \$161,225 to the contract for FY 2004-05.
5. **Amendment No. 5 (DMH-01769) with Children's Hospital of Los Angeles**, adds EPSDT-CGF Growth match funds in the amount of \$6,250, EPSDT-FFP

Adds EPSDT-CGF Growth Match funds in the amount of \$12,500, EPSDT-FFP Medi-Cal funds in the amount of \$125,000, and EPSDT-SGF funds in the amount of \$112,500, for a combined total increase of \$250,000, to the MCA for the delivery of countywide, community-based children's mental health care services for FY 2005-06.
6. **Amendment No. 3 (DMH-01809) with New Directions, Inc.**, adds Client Supportive Service Exhibit 1010-A for FY 2004-05.
  7. **Amendment No. 4 (DMH-01823) with Portals**, changes the interim rates and reimbursement method to Cost Reimbursement for the following Short-Doyle/Medi-Cal Services: Mode 05, SFC 65-79 Adult Residential from \$90.63 to \$102.84; Mode 15, SFC 01-09 Targeted Case Management from \$1.39 to \$1.58; Mode 15, SFC 10-19/30-59 Mental Health Services from \$1.78 to \$2.02; Mode 15, SFC 60-69 Medication Support Services from \$3.26 to \$3.70; and Mode 15, SFC 70-79 Crisis Intervention Services from \$2.72 to \$3.08. In addition, Mode 45, SFC 45 10-20 Outreach Services a Non-Medi-Cal service, will change from \$52.13 to \$59.15 for FY 2004-05.
  8. **Amendment No. 10 (DMH-01831) with Special Service for Groups**, changes the service site for the Special Service for Groups Backup Act, located at 1336 Wilshire Blvd., Suite 101, Los Angeles, CA 90017 Provider No. 7112 to 1138 Wilshire Blvd., Suite 207, Los Angeles, CA 90017, Provider No. To Be Announced (TBA).
  9. **Amendment No. 1 (DMH-01909) with Del Amo Hospital, Inc.**, amends the Mental Health Services Agreement Contract Allowable Rate – Fee-For-Services Medi-Cal Acute Psychiatric Inpatient Hospital Services – to increase the rate from \$475 per day to \$570 per day for acute psychiatric inpatient hospitals serving children and adolescents who are Medi-Cal beneficiaries for FYs 2004-05, 2005-06, and 2006-07.
  10. **Amendment No. 1 (DMH-01915) with Aurora Las Encinas Hospital**, amends the Mental Health Services Agreement Contract Allowable Rate – Fee-For-Services Medi-Cal Acute Psychiatric Inpatient Hospital Services – to increase the rate from \$475 per day to \$570 per day for acute psychiatric inpatient hospitals serving children and adolescents who are Medi-Cal beneficiaries for FYs 2004-05, 2005-06, and 2006-07.
