SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 116 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of January, as follows:

1. **Amendment No. 3 (DMH-01407) with California Institute for Mental Health (CIMH)**, adds Children's System of Care State General Funds (CSOC-SGF) and realignment revenue in the amount of \$190,000 to the MCA for Fiscal Year (FY) 2004-05 only.
2. **Amendment No. 4 (DMH-01646) with Hillview Mental Health Center, Inc.**, reduces the Maximum Contract Amount (MCA) by \$162,566 of Department of Children and Family Services (DCFS) Independent Living Funds (ILP) funds for FYs 2004-05, 2005-06, and 2006-07 to reflect the approved ILP funding level of \$200,000.
3. **Amendment No. 3 (DMH-01659) with VIP Community Mental Health Center, Inc.**, adds funds to VIP for the establishment of the first Medical Hub at LAC-USC Medical Center. For FY 2004-05, the MCA is increased by \$2,533,000. For FYs 2005-06 and 2006-07, the MCA is increased by \$3,094,000.
4. **Amendment No. 2 (DMH-01752) with 1736 Family Crisis Center**, changes the service delivery site for Provider Number 7111 from 601 South Pacific Coast Highway, Redondo Beach, CA 90277, to 901 West Victoria Street, Rancho Dominguez, CA 90220.
5. **Amendment No. 2 (DMH-01755) with ASC Treatment Group dba The Anne Sippi Clinic**, adds CGF (County General Fund) in the amount of \$181,400 to fund an increase of 10 treatment beds for the residential mental health program for FY 2004-05.

6. **Amendment No. 2 (DMH-01758) with Barbour and Floyd Medical Associates**, adds a new provider number and a new service site located at 3201 North Alameda Street, Suite H, Compton, CA 90222, for the Day Rehab/Full Day program.
7. **Amendment No. 2 (DMH-01762) with California Hispanic Commission, Inc.**, adds Medication Support Services (Mode 15, SFCs 60-69) at the provisional cost reimbursement rate of \$4.37 and a new program, Brief Strategic Family Therapy (BSFT), to the current service site located at 3225 North Broadway, Los Angeles, CA 90031, under the existing Provider Number 7519.
8. **Amendment No. 5 (DMH-01801) with Kedren Community Health Center, Inc. dba Kedren Psychiatric Hospital and Community Mental Health Center**, adds a new service site located at 2160 West Adams Blvd., Los Angeles, CA 90018, under a new Provider Number 7577.
9. **Amendment No. 2 (DMH-01830) with Social Model Recovery Systems, Inc. dba The River Community**, adds a new Provider Number TBA at contractor's existing service delivery site located at 248 East Rowland Street, Covina, CA 91723 and one new Provider Number To Be Announced (TBA) at new contractor's service delivery site located at 508 South Second Avenue, Covina, CA 91723.
10. **Amendment No. 3 (DMH-01839) with Stirling Academy, Inc. dba Stirling Behavioral Health Institute**, adds additional CalWORKs funding in the amount of \$60,000 for FYs 2004-05 and 2005-06 to fund mental health services to CalWORKs recipients.
11. **Amendment No. 3 (DMH-01848) with Vista Del Mar Child & Family Services**, change the Cost Reimbursement Rates as follows: Mode 10, SFCs 85-89 (Day Treatment Intensive/Full Day) from \$177.60 to \$189.33, Mode 10, SFCs 95-99 (Day Rehabilitative/Full Day) from \$115.14 to 122.75, Mode 15, SFCs 01-09 (Targeted Case Management Services) from \$1.77 to \$1.89, Mode 15, SFCs 10-19/30-59 (Mental Health Services) from \$1.94 to \$2.11, and Mode 15, SFCs 60-69 (Medication Support Services) from \$3.72 to \$2.49.

The following 10 amendments to Legal Entity Agreements (12 to 21) extends the agencies ability to participate in the Cash Flow Advance (CFA) program from December through February of FY 2004-05:

12. **Amendment No. 1 (DMH-01642) with Filipino American Service Group, Inc.**, total amount of the monthly CFA payment shall not exceed \$4,784 per month.
13. **Amendment No. 1 (DMH-01762) with California Hispanic Commission**, total amount of the monthly CFA payment shall not exceed \$94,692 per month.

14. **Amendment No. 2 (DMH-01769) with Children's Hospital of Los Angeles**, total amount of the monthly CFA payment shall not exceed \$587,869 per month.
15. **Amendment No. 2 (DMH-01782) with Five Acres – The Boys' and Girls' Aid Society of Los Angeles County**, total amount of the monthly CFA payment shall not exceed \$629,005 per month.
16. **Amendment No. 2 (DMH-01798) with Institute for Multicultural Counseling and Education Services, Inc. (I.M.C.E.S.)**, total amount of the monthly CFA payment shall not exceed \$70,000 per month.
17. **Amendment No. 2 (DMH-01803) with Koreatown Youth and Community Center, Inc.**, total amount of the monthly CFA payment shall not exceed \$30,247 per month.
18. **Amendment No. 3 (DMH-01805) with The Los Angeles Child Guidance Clinic**, total amount of the monthly CFA payment shall not exceed \$976,429 per month.
19. **Amendment No. 2 (DMH-01841) with Telecare Corporation**, total amount of the monthly CFA payment shall not exceed \$500,671 per month.
20. **Amendment No. 2 (DMH-01846) with United American Involvement Inc.**, total amount of the monthly CFA payment shall not exceed \$91,268 per month.
21. **Amendment No. 2 (DMH-01869) with David and Margaret Home, Inc.**, total amount of the monthly CFA payment shall not exceed \$62,500 per month.

The following 5 (five) amendments to Legal Entity Agreements (22 to 26) restores Healthy Families funds for the duration of their Agreement:

22. **Amendment No. 5 (DMH-01634) with Child and Family Guidance Center**, restores Healthy Families funds in the total amount of \$256,250.
23. **Amendment No. 3 (DMH-01636) with Community Family Guidance Center**, restores Healthy Families funds in the total amount of \$63,737.
24. **Amendment No. 3 (DMH-01647) with Institute for the Redesign of Learning dba The Almansor Center**, restores Healthy Families funds in the total amount of \$257,870.
25. **Amendment No. 2 (DMH-01768) with Children's Bureau of Southern California**, restores Healthy Families funds in the total amount of \$50,569.

26. **Amendment No. 2 (DMH-01799) with Intercommunity Child Guidance Center**, restores Healthy Families funds in the total amount of \$153,410.
27. **Amendment No. 1 to Medi-Cal Professional Services Agreements with two (2) individual providers**, adds the Board-mandated clauses: Notice to Employees Regarding the Safely Surrendered Baby Law and Contractor's Acknowledgement of County's Commitment to the Safely Surrendered Baby Law.
28. **Amendment No. 1 to Medi-Cal Professional Services Amendment with two (2) group providers**, adds Board-mandated revised language for FYs 2004-05 and 2005-06: Child Support Compliance Program; Contractor Responsibility and Debarment; new Certification Regarding Debarment, Suspension, Ineligibility, and Voluntary Exclusion; and temporarily adds provisional payment language from July 1, 2004, until the Integrated Systems (IS) is fully functional for FY 2004-05.
29. **Amendment No. 2 to Medi-Cal Professional Services Agreements with two (2) individual providers**, adds additional Health Insurance Portability and Accountability Act (HIPAA) language; adds a Guide to Procedure Codes and includes a "crosswalk" of technical terms, definitions, and language; deletes Exhibits B, B-1, B-2, and B-3 and replaces them with a Trading Partner Agreement; and adds Electronic Data Interchange/Direct Data Entry (EDI/DDE) Selection, General Requirements Agreement, and Claim Submission Agreement.
30. **Amendment No. 3 to Medi-Cal Professional Services Agreements with two (2) individual providers**, changes the Contractor's Exclusion from Participation in a Federally Funded Program language, adds Attestation form, and includes the Board-mandated Preamble.
31. **Amendment No. 4 to Medi-Cal Professional Services Agreements with two (2) individual providers**, temporarily adds provisional payment language for the period effective October 16, 2003, until the IS is fully functional and adds contract language in regards to "No Payment for Services Provider Following Expiration/Termination of Contract."
32. **Amendment No. 4 to Medi-Cal Professional Services Agreements with one (1) individual provider**, changes the Contractor's Exclusion from Participation in a Federally Funded Program language, adds Attestation form, and includes the Board-mandated Preamble.
33. **Amendment No. 5 to Medi-Cal Professional Services Agreements with two (2) individual providers**, updates Child Support Compliance Program language and adds a Board-mandated clause regarding Debarment, Suspension, Ineligibility, and Voluntary Exclusion.

34. **Amendment No. 5 to Medi-Cal Professional Services Agreements with one (1) individual provider**, temporarily adds provisional payment language for the period effective October 16, 2003, until the IS is fully functional and adds contract language in regards to "No Payment for Services Provider Following Expiration/Termination of Contract."
35. **Amendment No. 6 to Medi-Cal Professional Services Amendments with 30 group providers**, updates Child Support Compliance Program language and adds a Board-mandated clause regarding Debarment, Suspension, Ineligibility, and Voluntary Exclusion.
36. **Amendment No. 1 to Clinical Assessment Program Agreements with 46 clinicians**, combines the Statement of Work Exhibits A and A-1, and Payment Schedule Exhibits B and B-1, to enable AB 3632 and D-Rate services to be performed by all assessors.
