SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 127 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Psychiatric Inpatient Hospital Services Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of June, as follows:

1. **Amendment No. 14 (DMH-00964) with The Regents of the University of California, Los Angeles (UCLA)**, changes the Negotiated Rate for Mode 15, Service Function Codes (SFC) 60-69, from \$4.38 to \$4.37 based on the State Department of Mental Health's (SDMH) and the Department of Mental Health's (DMH) criteria for establishing Negotiated Rates.
2. **Amendment No. 15 (DMH-00964) with The Regents of the University of California, Los Angeles (UCLA)**, deletes Addendum A – Amendment 12 and replaces with Addendum A – Amendment 15 and adds \$350,000 to Addendum A for program augmentation at Augustus F. Hawkins Mental Health Center (AFHMHC) for consultation on the evaluation of day treatment and related services, and academic and medical teaching services specifically focused on the treatment of co-occurring behavioral disorders for Fiscal Year (FY) 2003-2004.
3. **Amendment No. 3 (DMH-01121) with California Mental Health Directors' Association**, reduces the contract term by one year with a revised expiration date of June 30, 2004; increases the Maximum Contract Amount (MCA) for FY 2003-2004 by \$500,000 to meet the increased demand for mental health services delivered to Los Angeles County's Medi-Cal eligible children who are placed outside of Los Angeles County; and adds contract provisions and

increases the MCA by an additional \$193,654 to allow payment for FY 2003-2004 for prior years and current year denied Medi-Cal claims.

4. **Amendment No. 2 (DMH-01407) with California Institute for Mental Health (CIMH)**, adds \$44,000 to the MCA for training and consultation services for FY 2003-2004.

6. **Amendment No. 8 (DMH-01437) with Associated League of Mexican-Americans, Inc. dba ALMA Family Services**, adds Department of Public Social Services (DPSS) California Work Opportunity and Responsibility to Kids (CalWORKs) funds in the amount of \$100,000 to the MCA to fund DPSS CalWORKs mental health services for FYs 2003-2004 and 2004-2005.
7. **Amendment No. 5 (DMH-01448) with El Centro De Amistad, Inc.**, revises the Cost Reimbursement Rates for Mode 15, SFCs 01-09, from \$1.11 to \$1.67; Mode 15, SFCs 10-19/30-59, from \$1.12 to \$1.91; and Mode 15, SFCs 60-69, from \$2.38 to \$2.69 for FYs 2003-2004, 2004-2005, and 2005-2006.
