

SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 94 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of June, as follows:

1. **Amendment No. 11 (DMH-01243) with Penny Lane Centers dba Penny Lane**, decreases Federal Financial Participation (FFP) funding in the amount of \$34,715 and increases Realignment funding by \$34,715 for Fiscal Year (FY) 2002-03. There is no change to the Maximum Contract Amount (MCA).
2. **Amendment No. 8 (DMH-01634) with Child and Family Guidance Center**, increases Targeted Case Management Services, Mode 15, Service Function Codes (SFC) 01-09, from \$1.70 to \$1.80; Mental Health Services, Mode 15, SFCs 10-19/30-59, from \$2.09 to \$2.30; Medication Support, Mode 15, SFCs 60-69, from \$4.22 to \$4.30; and Crisis Intervention, Mode 15, SFCs 70-79, from \$3.49 to \$3.50.

6. **Amendment No. 15 (DMH-01652) with National Mental Health Association of Greater Los Angeles**, adds Mental Health Services Act (MHSA) funds, adds Other County General Funds (CGF) for Client Supportive Services, and adds Alcoholic and Drug Program Administration (ADPA) for Assembly Bill (AB) 2034 Housing & Homeless for Provider Number 7018 for FYs 2004-05, 2005-06, and 2006-07.
7. **Amendment No. 16 (DMH-01652) with National Mental Health Association of Greater Los Angeles**, adds \$30,876 in CGF to provide Interim Funding for the Assertive Community Treatment (ACT) Program to maintain indigent ACT clients in community placements for FY 2004-05.
8. **Amendment No. 5 (DMH-01655) with South Bay Children's Health Center Association**, relocates the Outpatient Program Provider Number 7220A from 410 South Camino Real, Redondo Beach, CA 90277 to 17800 Van Ness Avenue, Torrance, CA 90504.
9. **Amendment No. 7 (DMH-01656) with South Central Health and Rehabilitation Program (SCHARP)**, shifts \$20,834 from Non Early and Periodic Screening, Diagnosis and Treatment (EPSDT)-FFP CGF match to other CGF to provide funding for seriously emotionally disturbed adults with Human Immunodeficiency Virus (HIV)/Acquired Immune Deficiency Syndrome (AIDS), shifts \$241,668 from AB 2034 Treatment to AB 2034 Medi-Cal match to reflect the funding needs of the AB 2034 Medi-Cal program. The Amendment also adds \$77,549 Non EPSDT-FFP CGF match, \$20,834 Non EPSDT-FFP (HIV/AIDS), and \$200,000 Non EPSDT-FFP (AB 2034) for FY 2004-05.
