SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 447 amendments to existing Legal Entity Agreements, Specialized Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of July, as follows:

1. **Amendment No. 5 (71402) with Electronic Data Systems Corporation dba EDS Corporation**, extends the contract term for an optional six-month period, July 1, 2003 through December 31, 2003. The Maximum Contract Amount (MCA) shall not exceed \$840,000 for this period.
2. **Amendment No. 5 (DMH-00964) with The Regents of the University of California, Los Angeles (UCLA)**, decreases Early and Periodic Screening, Diagnosis and Treatment – State General Funds (EPSDT - SGF) in the amount of \$684,361 and Federal Financial Participation (FFP) Medi-Cal funds in the amount of \$684,361, for a combined total of \$1,368,722, for the redirection and expansion of countywide, community-based children's mental health services for Fiscal Year (FY) 2002-2003.
3. **Amendment No. 6 (DMH-00964) with The Regents of the University of California, Los Angeles (UCLA)**, decreases EPSDT - SGF in the amount of \$147,500 and FFP Medi-Cal funds in the amount of \$147,500, for a combined total of \$295,000, for the redirection and expansion of countywide, community-based children's mental health services for FY 2002-2003.
4. **Amendment No. 7 (DMH-00964) with The Regents of the University of California, Los Angeles (UCLA)**, adds \$66,824 to Addendum A (Countywide Academic and Medical Teaching Services Program) for program augmentation at

Augustus F. Hawkins. The MCA for FY 2002-2003 is \$1,404,053 and \$2,924,655 for FYs 2003-2004, 2004-2005, and 2005-2006.
