SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 144 amendments to existing Legal Entity Agreements, Specialized Agreements, Residential Agreement, Medi-Cal Psychiatric Inpatient Hospital Services Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of May, as follows:

1. **Amendment No. 3 (DMH-00936) with College Hospital - Cerritos**, adds \$215,704 to the Maximum Contract Amount (MCA) to purchase two additional acute inpatient hospital beds for minors for Fiscal Year (FY) 2003-2004 only.
2. **Amendment No. 5 (DMH-00936) with College Hospital - Cerritos**, decreases County General Funds (CGF) in the amount of \$23,371 in order to implement the Federal Medi-Cal Assistance Percentages (FMAP) Adjustments for both non Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Federal Financial Participation (FFP) EPSDT – FFP and EPSDT – FFP Medi-Cal revenue for FY 2003-2004.
3. **Amendment No. 7 (DMH-00936) with College Hospital - Cerritos**, increases the Administrative Day Services rate from \$268.63 to \$389.13 per day for FY 2003-2004.
4. **Amendment No. 3 (DMH-01079) with Braswell Rehabilitation Institute for Development of Growth & Educational Services, Inc. (B.R.I.D.G.E.S., Inc.)**, consolidates renewal of two Community Care Residential Facility (CCRF) Agreements into an existing Agreement with B.R.I.D.G.E.S, Inc. to improve management of contract Agreements with multiple service delivery sites.

5. **Amendment No. 2 (DMH-01155) with The Salvation Army, A California Corporation dba The Salvation Army Bell Shelter**, adds the following Board-mandated clauses: Notice to Employees Regarding the Safely Surrendered Baby Law and Contractor's Acknowledgment of County's Commitment to the Safely Surrendered Baby Law.
6. **Amendment No. 3 (DMH-01155) with The Salvation Army, A California Corporation dba The Salvation Army Bell Shelter**, adds the following Board-mandated language: Preamble and Contract Monitoring language for the Notification by Contractor to County when 75 percent of the MCA is incurred and within six months of expiration.
7. **Amendment No. 5 (DMH-01438) with Bienvenidos Children's Center, Inc.**, changes the Negotiated Rate for Mode 10, Service Function Codes (SFC) 85-89, Day Treatment Intensive: Full Day, from \$154.57 to \$154.28; deletes Mode 10, SFCs 95-99, Day Rehabilitative: Full Day from Provider No. 7382; and revises the Service Delivery Site Exhibit for FYs 2003-2004, 2004-2005, and 2005-2006.
8. **Amendment No. 4 (DMH-01444) with Clontarf Manor**, restores Realignment funds to the MCA in the amount of \$80,000 for FYs 2004-2005 and 2005-2006, which were inadvertently deleted in Amendment No. 2.
9. **Amendment No. 5 (DMH-01444) with Clontarf Manor**, adds Realignment funds to the MCA in the amount of \$160,000 for client support activities that were redirected due to termination of the Supplemental Rate Program.
10. **Amendment No. 6 (DMH-01446) with Community Counseling Service of Los Angeles, Inc.**, changes the Negotiated Rate for Mode 5, SFCs 40-49, from \$137.84 to \$137.58 for FYs 2003-2004, 2004-2005, and 2005-2006.

18. **Amendment No. 6 (DMH-01479) with San Gabriel Children's Center, Inc.**, adds Mode 15, SFCs 70-79, at the provisional Cost Reimbursement rate of \$3.41; changes the Cost Reimbursement rates for Mode 10, SFCs 85-89, from \$147.50 to \$177.60; changes Mode 15, SFCs 01-09, from \$1.33 to \$1.69; and changes the method of reimbursement from Negotiated Rate to Cost Reimbursement for Mode 15, SFCs 10-19/30-59, from \$1.74 to \$2.21 and Mode 15, SFCs 60-69, from \$3.60 to \$4.17 under existing Provider Number 7274.
