Non Medi-Cal Billable



Plans in the IS

There are several plans in the Integrated System (IS) that are not billable to Medi-Cal because they are either funded by another County Department for specific clients, they are Federal grants only for clients without benefits, or the service is not reimbursable by Medi-Cal. Previously, when providers attempted to send a claim to Medi-Cal with a non Medi-Cal billable plan, the IS was programmed not to send the claim to Medi-Cal and to submit it to the plan instead. Now, with the Short-Doyle/Medi-Cal Phase II (SD/MC II) implementation, the IS will issue a warning to providers that their claims cannot be submitted to the non Medi-Cal billable plan that was selected when the service is identified as Medi-Cal billable. If an eligible client’s service was identified as Medi-Cal billable and was billed to a non Medi-Cal billable plan, then the IS will send the error message, “Cannot submit claims to MediCal when Plan is not billable to MediCal.” (See above).

When a provider receives this error message, they should then re-evaluate the service and the client’s benefit to determine if the service should be billed to other applicable plans instead of the non Medi-Cal billable plan. If the only appropriate plan is non Medi-Cal billable, select that appropriate plan, uncheck the Medi-Cal check box and submit the claim. See below for a list of non Medi-Cal billable plans:
