SUBJECT: **MENTAL HEALTH SERVICES CONTRACTS/AMENDMENTS FOR
JUNE 2019**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 196 Amendments to existing and/or new Legal Entity (LE) Contracts, Specialized Contracts, Mental Health Services Act (MHSA) Contracts, Medi-Cal (MC) Professional Services Contracts (Individual and Group Providers), Clinical Assessment programs, and execution of five new Contracts processed in the month of June 2019 as follows:
