SUBJECT: **REPORT ON MENTAL HEALTH SERVICES, CONTRACTS, AND AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is the Department's notification of amendments and new Contracts as follows:

Amendments:

The following one Amendment is effective upon execution, February 24, 2021, and will terminate three months after the date on which the proclamation of a local and public health emergency due to COVID-19 is lifted by the County. For the Temporary Period, the Contractor will be paid for Phlebotomy fees according to the test prices in the Statement of Work-Technical Exhibit. The Maximum Contract Amount (MCA) remains the same:
