What is MAT?

Multidisciplinary Assessment Team (MAT) is a collaborative effort between the Los Angeles County Department of Mental Health (LACDMH), Department of Children and Family Services (DCFS), and community-based mental health provider agencies. It is designed to ensure the immediate and comprehensive assessment of children and youth entering out-of-home placement. The MAT Program has been operational countywide as of October 2009.

MAT assessments address the following areas:

- Child and family strengths and needs
- Caregiver strengths and needs
- Education
- Mental health
- Medical & dental developmental
- Hearing/language
- Vocational

Program Description

When a child is newly detained, he/she is eligible to receive a Multidisciplinary Assessment Team (MAT) assessment through DCFS. The MAT assessment was designed to ensure that all the child and family's strengths and needs are assessed.

This assessment is meant to help a family meet the needs that the child(ren) may have that place this family in danger of a lengthy separation. The information gathered by this assessment will be used to determine what interventions and services are most needed by the child(ren) with the intention of using this information for the most appropriate placement of the child while ensuring that his/her needs will be met.

Participants in the MAT process:

- Parents
- Caregivers
- Children (as appropriate)
- DMH MAT Assessor
- DCFS MAT Coordinator
- Service providers
- DCFS Children's Social Worker (CSW) and/or Dependency Investigator (DI)
- Public Health nurse
- Other CSAT members

Program Goals

- Timely and comprehensive strength-based assessment of children and families
- Earlier diagnosis of critical medical and mental health conditions
- Increased cooperation between families, caregivers, providers of services and DCFS
- More appropriate placement decisions for children
- More consideration given to sibling, relative, and community placements
- Earlier access to medical, educational and mental health services for children and families
