## 24-Hour Residential Treatment Services Contract

The Fixed Rate is maximum \$375 per day.

The Maximum Contract Amount (MCA) will be based on 16 beds if/when the Department of Mental Health awards a contract.

## Acute Psychiatric Inpatient Services Contract

The Fixed Rate for Adult Acute Psychiatric is \$895 and IMD Exclusion is \$895 per day.

The Fixed Rate for Child and Adolescent Acute Psychiatric is \$1,054 per day.

The Fixed Rate for Adult Behavioral Health and Physical Health Acute Psychiatric is \$1,080 and IMD Indigent is \$1,080 per day.

The Fixed Rate for Guaranteed Bed Medi-Cal Acute is \$1,025 and Indigent Acute is \$1,025. There is no Indigent Administrative Day reimbursement.

The Fixed Rate for Release Bed Medi-Cal Acute is \$1,080, Administrative is \$817.64, and Patch is \$262.36. The Indigent Acute and Administrative Rate is \$1,080.

The Fixed Rate for Surge Bed Indigent Acute is \$1,025 and Indigent Administrative is \$1,025 per day
