The DMH Training Unit is offering an Online Continuing Education Program that consists of 2 online trainings that include web-based study course and exam targeted for first time renewal licensed Psychologists, Social Workers (LCSW), Marriage and Family Therapists (LMFT) and Professional Clinical Counselors (LPCC). These online continuing education trainings fulfill the State of California Board of Psychology (BOP) and California Board of Behavioral Sciences (BBS) first time renewal continuing education requirements for licensed clinical staff of the public mental health system (DMH contracted or directly operated full time permanently employed outpatient mental health program).

**The courses meet the California BOP and BBS Continuing Education Coursework for Licensed Psychologist, LCSW, LMFT, and LPCC.*

ONLINE SELF-STUDY PRE-LICENSURE TRAININGS INCLUDE:

- Readings— Content online or can save/print as PDF.
- Online Modules— Access to web-based previously recorded presentation and instructional material.
- Online Exam—An 80% passing score is needed to receive the certificate of completion.

ELIGIBILITY:

- Employed as a Licensed Psychologist, LCSW, LMFT or LPCC within the LA County DMH Public Mental Health System-contracted or directly-operated outpatient programs
- Supervisor approval to take the training(s)

MUST AGREE TO THE FOLLOWING TERMS AND CONDITIONS:

- Completion of the training(s) during work hours is at the supervisor's discretion. **FOR DMH EMPLOYEES, NO OVERTIME IS APPROVED**
- Update the Training Coordinator as to the status of registration and completion of the trainings(s)
- Complete the registration process online with Alliant International University within 2 weeks of approval
- Complete the training(s) in 90 days from the date of being granted access by Alliant International University
- Complete a satisfaction survey at the end of the training (Separate from Alliant required evaluation)

3. To access the training, participants will be required to complete the registration process online at the Alliant International University website within 2 weeks of acceptance notification
