The DMH Training Unit is offering an Online Pre-Licensure Program that consists of 4 online trainings that include web-based study course and exam targeted for unlicensed Psychologists, Social Workers (MSW), Marriage and Family Therapists (MFT) and Professional Clinical Counselors (PCC). These online trainings fulfill the State of California Board of Psychology (BOP) and California Board of Behavioral Sciences (BBS) pre-licensure requirements.

ONLINE PRE-LICENSURE TRAINING INFORMATION:

Human Sexuality (10 Hours of Course Work)

Child Abuse Assessment and Reporting (7 Hours of Course Work)

Aging, Long Term Care and Elder/Dependent Adult Abuse (10 Hours of Course Work)

Domestic Violence Assessment, Detection and Intervention Strategies (15 Hours of Course Work)

**The courses meet the California BOP and BBS Pre-License Coursework for unlicensed Psychologist, MSW, MFT, and PCC.*

ONLINE SELF-STUDY PRE-LICENSURE TRAININGS INCLUDE:

- Readings— Content online or can save/print as PDF.
- Online Modules— Access to web-based previously recorded presentation and instructional material.
- Online Exam—An 80% passing score is needed to receive the certificate of completion.

ELIGIBILITY:

- Must be employed as a unlicensed Psychologist, MSW, MFT or PCC within the LA County DMH Public Mental Health System-contracted or directly-operated outpatient programs
- Supervisor approval to take the training(s)

MUST AGREE TO THE FOLLOWING TERMS AND CONDITIONS:

- Completion of the training(s) during work hours is at the supervisor's discretion. **FOR DMH EMPLOYEES, NO OVERTIME IS APPROVED**
- Must update the Training Coordinator as to the status of registration and completion of the trainings(s)
- Complete the registration process online with Alliant International University within 2 weeks of approval
- Complete the training(s) in 90 days from the date of being granted access by Alliant International University
- Complete a satisfaction survey at the end of the training (Separate from Alliant required evaluation)

INSTRUCTIONS:

1. All applications must be completed online: **Online-Pre-Licensure**
2. Upon approval, an email with Login instruction will be sent by Alliant International University
3. To access the training(s), participants will be required to complete the registration process online at the Alliant International University website within 2 weeks of acceptance notification
