### **DMH Updates**

Mirtala Parada Ward provided Capacity Building Concepts Updates 2022 - 2023; FY 2023 - 2024

- Outstanding UsCC Capacity Building Projects: Seven SOWs have been completed and send out to procurement. Reference quotes for these projects have been secured.
- o Two projects are out to solicitation; My Brother's Keeper & Prevention Works for Communities.
- The process is the following. Completed SOWs with quotes are sent to the procurement department, which is internal to DMH. Once procurement processes them, it goes to Internal Services Department (ISD). Once this happens BAH UsCC Subcommittee members will get an e-mail from Dr. Yaralyan letting you know the project has gone out for solicitation. We are requesting 30 days for this process. When the projects are released for bidding, we cannot engage in questions asked about the projects; we will differ you back to ISD to respond to questions.
- O Mirtala also informed BAH Subcommittee members that interviews have been conducted with two potential candidates for permanent BAH Liaison position, but we have not been successful in selecting a liaison yet. First candidate declined the position due to having personal/family health struggles. Second candidate had a great deal of clinical experience, but not enough practice in community psychology, as a result did not feel comfortable holding the position. We will continue to interview potential qualified candidates for this position.

Mirtala Parada Ward also provided the following updates:

 Supervising Clinical Psychologist has been hired to provide supervisory support to UsCC Liaisons. She will attend the next BAH UsCC Subcommittee meeting and be introduced to the group.
