Quality Improvement

Dr. Cunnane shared the CPS 2022 Countywide Highlights with members:

- Total Surveys Completed + 7225
 - 25.8% increase from Spring 2021
 - Adults completed the majority of surveys (40.9%).
- Survey Format:
 - Families & Youth completed majority of surveys using online formats.
 - Older Adults & Adults completed using the paper format.
 - 63% surveys completed using electronic formats.
- Length of Enrollment.
 - Majority of Older Adults & over half of Adults in services 1 + year.
 - Families & Youth: Majority in services 1 + years or 6 months to a year.
 - Language: 80% of surveys completed in English.
- Domain Satisfaction:
- Families & Older Adults had the highest satisfaction for the Quality and Cultural Appropriateness domains.
- Families had highest satisfaction in Social Connectedness, Access, and Improved Functioning domain.
- Older Adults had the highest satisfaction in the Perception of Outcomes, Participation in Treatment Planning, and General Satisfaction.

	 Youth demonstrated the lowest scores among the four age groups across most domains except for Social Connectedness and Quality and Cultural Appropriateness.
