- Dr. Gertmenian reviewed the Fields in SRTS, indicating transfer referral from LA General.
  - Note: LA General is closing July 1<sup>st</sup>, 2024. The clients will be transitioning to MCPs for non-SMHS and transferring to LACDMH provider for SMHS. Many of the Adult Clients are transferring to Northeast MHC.
- Dr. Gertmenian highlighted the Ease of Access for homeless individuals and mentioned that DMH is working on making it easier for homeless individuals to access our System.
  - Focusing on linkage
  - Providers may see an increase in referrals for homeless individuals. (Crisis/HOME/FSP/Outpatient Clinic)
  - Teaming with homeless outreach workers to streamline the referral process to get the homeless connected to our mental health services as needed.
- Dr. Gertmenian briefly reviewed the 90-Day Rule with attendees, see bulletin 24-01.

- AB 665, Minor Consent to Mental Health Services was passed and will become effective July 1<sup>st</sup>, 2024.
- AB 352, Privacy protections for information about genderaffirming care, abortion, abortion-related services, and contraceptives.
  - Agencies need to ensure that they are not releasing any gender or abortion related care information without proper consent.
  - Encourage organizations to speak to their EHR vendor.
