24-Hour Residential Treatment Services Contract

The Fixed Rate is maximum \$375 per day.

The Maximum Contract Amount (MCA) will be based on 16 beds if/when the Department of Mental Health awards a contract

Acute Psychiatric Inpatient Services Contract

The Fixed Rate for Adult Acute Psychiatric is \$1,110 for APH and \$1,173 for GACH and IMD Exclusion is \$1,110 per day.

The Fixed Rate for Child and Adolescent Acute Psychiatric is \$1,110 for APH and \$1,173 for GACH per day.

The Fixed Rate for Adult Behavioral Health and Physical Health Acute Psychiatric is \$1,273 and Indigent is \$1,273 per day.

The Fixed Rate for Guaranteed Bed Medi-Cal Acute is \$1,273 and Indigent Acute is \$1,273. There is no Indigent Administrative day reimbursement.

The Fixed Rate for Release Bed Medi-Cal Acute is \$1,273, Admin is \$817.64, and Patch is \$455.36. The Indigent Acute and Administrative Rate is \$1,273.

The Fixed Rate for Surge Bed Indigent Acute is \$1,110 and Indigent Administrative is \$1,110 per day
