Fee Schedule for Providing Copies of Clinical Records

(Directly-Operated Only)

This Bulletin provides an updated fee schedule to Directly-Operated (DO) providers of charges for providing copies of clinical records. This updated guidance is effective as of the date of this Bulletin.

Medical Records- Continuity of Care	Health Care Provider	No Charge		"Health Care Provider" means a licensed person or organization that provides health care services
Medical Records - Public Benefits	Health Advocates; Non-Profit Legal Agency	No Charge	California Health & Safety Code 123110 (d)(1)	A letter or document is needed to prove that records are needed to support a claim or an appeal regarding eligibility for a public benefit such as Medi-Cal, SSI, CalFresh, IHSS, etc.
Medical Records - Legal (a)	Non-Profit Attorney	No Charge		"Non-profit attorney" means an attorney employed by a non-profit legal service entity such as a public defender
Medical Records- Legal (b)	Private Attorney	\$25 flat fee	California Health & Safety Code 123110 (b)	"Private Attorney" means any attorney not employed by a non-profit legal service entity (does not apply to public defenders)
Medical Records- Any civil action subpoena	Attorney or Court	\$15 flat fee	Evidence Code §§1560– 1564, Code of Civil Procedure §2020.430.	Applies to subpoenas for clinical records issued in any civil action in state court
Medical Records- Criminal subpoena	Attorney or Court	No Charge	Evidence Code §§1560– 1564, Code of Civil Procedure §2020.430.	complying with a subpoena issued in criminal proceedings
Legal Appearances (witness deposition or testimony of a DMH employee in court)	Attorney or Court	\$275 per day	Government Code Section 68096.1	The fee shall be tendered in conjunction with a subpoena and shall be paid for <b>each day</b> the employee is required to remain in attendance
