#### 8. REVIEW OF THE MHC TOPICS OF INTEREST LIST

Discussion: Commissioner Weissman stated Dr. Wong expressed interest in hosting a meeting during the summer for SALT Co-Chairs, DMH staff assigned to service areas, a consultant to oversee various budgets and expenditure plans to discuss how we go about processing next fiscal year. Kenia confirmed the meeting will be held in addition to the MHC meeting on July 25, 2024, scheduled as the SALT budget workshop.

In June the focus is on housing, beds, and other issues. Commissioner Weissman's name is listed on the Topics of Interest list under Housing and Homeless. She was asked to assist in shaping what the reports should be and how the meeting takes place. In August we are looking at hosting a retreat, September we look to SA 6.

Chair Molina stated Theresa Comstock, Executive Director, CAL/BHBC is willing to come and present a state level presentation on Proposition 1. Chair Molina will work with Kenia to arrange the visit in May or June.
