DMH Updates

Dr. Jennifer Alquijay provided the following DMH updates:

- o Timeline for Capacity Building Projects on the upcoming year is going to be a little tighter. As a result all USCCs, including the BAH UsCC Subcommittee must submit project proposals for next year by June.
- o The proposals must be submitted through the CBP Project Proposal form as it is a document.
- The CBP form must be submitted on time in order for the BAH Liaison to write the Statement of Work for it.
- We will work on the CBP proposals submitted and will create Statements of Work for it.
- o All the active CBPs must be completed within 12 months.

Behavioral Health Services Act – Kalene Gilbert:

- o Behavioral Health Services Act is a proposed by California State Legislature overview which supports Gov. Newsom's vision to "modernize behavioral health."
- o The name Mental Health Services Act will change to the Behavioral Health
- o Services Act (BHSA). Programmatic changes will begin July 1, 2026.
- o Administrative funding for the new community planning process will begin

January 2025.

- o \$6.3B Housing bond will be added to the budget fund treatment facilities and housing for homeless.
- o The Act also proposes significant shifts in MHSA allocations, reducing funding from core mental health services (Outpatient, Crisis, Linkage) to create a new housing category.
- The Act requires counties to provide new substance use disorder (SUD) services for SUD and no additional funding.
- No specific allocation for Prevention, Suicide Prevention, Anti Stigma, Workforce.
- Education and Training, Capital Facilities and Technological Needs which are current funding categories under MHSA will include the following. Prevention & Workforce Education and Training services will be administered by the State..
- FY 2025 2026 Capacity Building Concepts Survey Selection: Romalis Taylor A committee will be formed to create CBP proposals for the top 3 CBP ideas from BAH UsCC Subcommittee Meeting. This committee is likely to meet in the month of July, 2024.
 - Outreach/Events, (O & E): BAH UsCC Subcommittee will be planning retreats, & ongoing O & E events to increase subcommittee capacity and come up with ideas/topics for Capacity Building Projects, CBPs.
