What I find is I can earn the money that I need to get housing but I'm already on the A.L.W program. If I earn the money that I need for housing, I'm going to lose Medi Cal which will cover the transplant. So, UCLA, and Cedar said. This is something that doctors are aware of now, but I wouldn't be able to sue a doctor for research that happened over time just like people are claiming long term effects of COVID. How can you predict the future? I'm not trying to attack the system; I'm trying to figure out how to survive and right now the laws are not in my favor. So right now, we're trying to look for a voucher so I can go past what basically UCLA is saying I can get on the list with a transplant in a couple years. So, the key is just housing. If we can get a voucher somehow and bypass the speed of, you know, there's a long line of people that basically are set up for housing because they're the rules are basically set in the way that you have to have the unhoused. I sent Fred next door to the department of mental health where he receives his services. And they'd be able to assist with a fee waiver and once again he was told no. So I think this plays a big part in our housing, in our homeless problem is if people are shipped in or come here from other states and then apart of getting your birth certificate is a part of document ready and you can't receive one and so we brought him up here because he didn't know what to do and I just on this commission has to be representing some kind of housing. So, Fred is right here and if someone's able to connect him with some kind of supportive services to reach out and help him ready into is that not something that can be done at the P.R.C. for people or do they have to be connected to it a department or have a caseworker for that to happen? The cruel and ineffective criminalization of unhoused people in Los Angeles documents the experience of people living on the street and in vehicles, temporary shelters, and parks in Los Angeles. With houselessness, a pervasive problem. In the county of Los Angeles with the monetary value of property has risen to the extreme heights. Has stagnated for decades, houselessness has exploded into public view. To issue publicly and acknowledge the necessity of increased housing to solve houselessness criminalization of those without it. The criminalization of houselessness means treating people who live on the streets as criminals and directing resources toward arresting and siting them. And extreme poverty from the view of house public. Criminalization is ineffective because it punishes people for living in poverty. My son has been suffering from mental illness. Currently, he's sitting in an acute care psychiatric hospital. He's literally on a waiting list at DMHICD to be on an I.M.D. waiting list. This has happened due to an overly strict policy and lack of appropriate treatment options and care coordination for his patient population. Appropriate treatment options for his patient population which is the people with serious mental illness do not include best partnerships, board, and cares, those are options where those patients are able to actively participate and don't need medication management. Those are not appropriate for S.M.I. community. My son and other patients need to be prioritized by the department of Mental Health. This population of patients is the sickest and most in need and forgotten. MHSA funds need to be redirected and established so that we can have additional I.M.D. sub-acute facilities and wrap around services by increasing the number of beds and facilities and by using a multimodel including MHSA funds. We can prevent additional deterioration of condition for this patient population. It might also be possibly decreasing the number of homeless patients with serious mental illness. We might literally preventing the death of these patients and possibly the death of my son. Please help them and help me to re prioritize the patient community when it comes to allocation and providing services. Providing beds and providing intervention.
