Coastal API Family MHC is a directly operated DMH clinic located in service area 8, Gardena. The clinic provides multicultural/multilingual services to the most underserved AAPI communities, but also serves the Latino and African American population who resides in the nearby cities including Hawthorne, Gardena, Torrance, Compton, South LA, Inglewood and more. We have various level of care to serve the chronically mentally ill clients ages 6+ up, including TAY, ADULT, and OLDER ADULT. Current programs include, general outpatient services, Full Service Partnership, Calworks, and Child wellbeing services. Under each program, services that are provided include: Psychosocial assessments, individual and group psychotherapy and rehab, targeted case management, and crisis intervention.
