We had our normal meeting, and we had a wonderful presentation about domestic violence from the district attorney's office, and one of the topics that we kind of sort of addressed was the issue of older adults who are parents who have an adult child with serious mental illness and how uneven the domestic violence is within the county. It depends on the area of the county that adult protective services is stationed in. That can determine whether or not they even take a report. It's very loosey goosy. Number two, anecdotally, we are seeing people that identify as trans dying by suicide since the election. I want to put that out there for your information. Hopefully, the department will take a stance that they will not involve themselves in the immigration status of people seeking service as has happened in the past. Thirdly, mental health, nonprofit in St. Claire Rita that I founded, we had a stop the stigma event in May. We were encouraged to apply for department of mental health funding. We have four vendors. It's almost Christmas, that have not been paid. We now know they are never going to get paid, so I have to raise \$5,200 very quickly. I want to

I came to from spa 2 which I know spa 2 losing housing as a professional going to spa 1 where I am now housed with a lot of tribulation with those that say they'll house me or bridge me to home. To be put in a place where now it's not safe. I think what needs to happen, they need to be understanding of what the law will do if you don't know it. I had a situation that happened day before veteran's where I was trying to protect myself and the perpetrators who now have crushed my hand, accused me of assaulting them because I didn't understand the law or how to call 911 correctly if I could. I was incarcerated. That has caused additional traumatic situation for me where I am right now. I believe people who have become in that situation, they are afraid to talk with the landlord.
