1. 2024-2029 FUNDING SOURCE AUTHORIZATION NUMBER

The Los Angeles County Department of Mental Health (LACDMH) requires authorization for all services. Individual and Group Providers (IGP) formerly known as Fee-For-Service (FFS) II shall input only one authorization on a claim line.

The FY 2024-2029 Funding Source Authorization is given by LACDMH to all disciplines of the providers. These Funding Source Authorizations will be used by IGP/FFS II for Specialty Mental Health, Psychological Testing, and Medication Support services. Funding Source Authorizations numbers begin with an 'F', followed by a number.

Provider shall refer to the LACDMH HIPAA 837 5010 Companion Guide for samples of an IGP/FFS II 837P Outpatient Claim Line with Primary, Interactive Complexity, Prolong, or Add-On Code, on and after July 1, 2023. **Please submit the claim service line number (2400) in unit (UN) and not in minutes (MJ)**

2. SERVICES REQUIRE MEMBER AUTHORIZATION NUMBERS

The Member Authorization number is specific to a client and used for specific services and duration of time. Member Authorization numbers are all numeric.

The Member Authorization number, commonly known as Treatment Authorization Request (TAR) number, an 11-digit number, is obtainable from the respective Psychiatric Inpatient Hospital or Psychiatric Inpatient Facility. The procedure codes requiring Member Authorization number or TAR number are as follows: 99221, 99222, 99223, 99231, 99232, 99233, 99238, and 99239.
