## REQUEST FOR STATEMENT OF QUALIFICATIONS FOR AS-NEEDED PSYCHIATRY SERVICES DMH RFSQ SOLICITATION NO. DMH12192023B1

### ADDENDUM NUMBER THREE (3)

On December 19, 2023, The Los Angeles County (LAC) Department of Mental Health (DMH) released a Request for Statement of Qualifications for As-Needed Psychiatry Services.

Pursuant to the RFSQ, Section 4.2 County's Right to Amend Request for Statement of Qualifications, LACDMH has the right to amend the RFSQ by written addendum. This Addendum Number Three is being issued to make modifications to the RFSQ to reflect recent hourly rates and contract boilerplate changes. New RFSQ language is highlighted for easy reference.

The following revisions are being made to the RFSQ:

- 1) **RFSQ Appendix A (Sample Master Agreement for As-Needed Psychiatry Services) Exhibit D (Billing and Payment)** shall be deleted in its entirety and replaced with Exhibit D-3 (Billing and Payment) to reflect the following hourly rates;

1. Psychiatry Services - All LACDMH work sites, including tele psychiatry services.	\$258.81
2. Child and Adolescent Services – All LACDMH work sites, including tele psychiatry services.	\$297.63

<u>Description /Work Sites</u>	<u>Hourly Rate</u>
3. Psychiatry Services - LACDMH work sites in the High Desert Area – Incentive for those Psychiatrists commuting 50 miles or more to in-person services	\$310.57
4. Child and Adolescent Services – LACDMH work sites in the High Desert Area – Incentive for those Psychiatrists commuting 50 miles or more to in-person services.	\$357.16
5. Psychiatry Services - Overtime and holiday rates <u>will not</u> be paid.	N/A
6. Child and Adolescent Psychiatry services – Overtime and holiday rates will not be paid.	N/A

2) **RFSQ Appendix A (Sample Master Agreement for As-Needed Psychiatry Services) Exhibit G (BUSINESS ASSOCIATE AGREEMENT UNDER THE HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT OF 1996 [“HIPAA”])** shall be deleted in its entirety.

Except for the revisions contained in this Addendum Number Three, there are no other revisions to the RFSQ. All other terms and conditions of the RFSQ remain in full force and effect.
