### **DMH Updates/Follow-Ups**

Mental Health Services Act (MHSA) programs and services are transitioning to Behavioral Health Services Act (BHSA).

Encouraged community members to join Community Planning Team (CPT) Meetings.

Hate Crimes Report – Hate Based Incidents (compared 2022 and 2023) – Shared statistics/results.

Board motion that started a few years ago – focuses/attempts to deal with hate-based incidents.

- Will start having an annual report
- Proposals moving forward- probably weave in psychoeducation/coping mechanisms for hate/race-based incidents.

Highlight and turn up the volume on both the Land and Labor acknowledgements.

# **Next Steps:**

Rex: How will we proceed with voting as we did not receive proposals for the unhoused population focus area?

Eden: Voting members voted for the unhoused population as a focus area, we should give a week for individuals to submit a proposal focusing on serving that population.

Rex: Two different possibilities:

- Table the unhoused population focus area for next FY knowing/keeping in mind that it's a focus area already set in stone
  - Move on with the three focus areas and have a wild card some of the project proposals presented this year do not fit under the scope of the focus areas that were voted on.
- Adjust submitted project proposals to focus/serve the unhoused populations.

Eden: Disservice to unhoused folks. Project dedicated to them – not adapted to serve them. (Rex agrees)

Rex: Concerned, the timeline has already been pushed, and any more delays will cause a delay in projects being awarded again.

Eden: Move forward with voting on 3 focus areas.

Roz: Only a few days to come up with proposal. Can start thinking of writing/creating proposal for unhoused population.

- Eden: Agrees, a month is not needed to create a proposal.
  - Vote on the 3 focus groups- give some time to write proposals and vote at another time.
- Pushing for online project.

Dr. Jen: Voting must be done within the month. We need to start writing the Statements of Work.

- Will create survey to vote on either tabling unhoused population focus area

Rex: How many folks will be able to submit a proposal that serves the unhoused population?

- 4 hands were raised.

Bill: Unhoused population- sense of urgency. The White House Administration is making lots of changes.

- Members agree it is a sensitive topic.

Rex: DMH to send out a survey to vote on the following options to be sent out to the voting members.

#### Vote:

- Option 1: Keeping focus area for this FY25-26 and giving folks time to submit a proposal.
- Option 2: Moving unhoused populations to next FY and voting for the 3 focus areas.
