

# **Los Angeles County Population 2023**


Census Data by Race/Ethnicity, N=9,825,708


Enrolled in Medi-Cal 2023 by Race/Ethnicity, N=4,506,095


Comparison: LA County Census Population vs Medi-Cal Population by Race/Ethnicity






























