The following sections may be of particular interest to public agencies:

- Section 2.1 Grantmaking Policy Contains recommended overall grantmaking policy for Measure A funds, including recommendations for targeting competitive grant funds and community engagement.
- Section 2.9 Countywide Parks Needs Assessment Maintenance Policy includes recommendations on maintaining the Parks Needs Assessment, including the park inventory data.
- Section 2.13 Sharing Funds Policy Contains recommendations for sharing allocation funds between Study Areas and M&S funds between entities.
- 3.1.1 Calendar for Current Funding Cycle Contains recommended calendars for grant programs, including month in which application will be released, month in which application is due, and month in which grant awards will be announced.
 - » Do these calendars work for your agency? Are some months better than others for submitting grant applications?
- Section 3.3 Community Outreach and Engagement Describes the recommended community outreach and engagement requirements for Measure A-funded project.
 - » Do you anticipate needing assistance to meet the requirements? Or are these requirements in line with your typical practice?
- Section 3.4.8 Good Standing Contains recommended procedures for achieving and maintain good standing with RPOSD. Good standing is required to obtain any Measure A funds
 - » Are these requirements reasonable? Do they present challenges for your agency?
- Section 4.2 Annual Allocations Describes the various annual allocations available to public agencies.
- Section 4.2.1 Use of Annual Allocations Contains recommendations for the use of annual allocations, including recommendations for time limits on holding funds.
 - » Are these time limits reasonable? Or are they too long or too short?
- Section 4.3 Competitive Grants Describes the six competitive grant programs of Measure Δ
 - » For each program, are the recommended grant minimum and maximum award amounts reasonable? Or should they be higher or lower?

June 12th Board Letter and Litigation Update

On June 12th, the Board of Supervisors approved RPOSD's recommendations regarding the release of Measure A funds for annual allocations. These are the Category 1 & 2 funds, along with maintenance & servicing, and implementation & oversight. The funds will be available this fall; however, if the current litigation is not resolved in RPOSD's favor, all expended funds must be repaid.

The Board also approved the recommendation to reserve Measure A competitive grant funds until the litigation is resolved. These funds will accrue until that time.

Park Funding 103

Park Funding 103 will be held in early Fall 2018. These meetings will provide information about annual allocations, enrollment with RPOSD, and available technical assistance. Look for more information about Park Funding 103 later this summer!


