## Changes to Medi-Cal and CalFresh Programs

**DPSS Communications Toolkit**  
Valid through March 31, 2026

The enactment of House Resolution (HR) 1 on July 4, 2025, and additional changes to State regulations, present significant policy changes that impact eligibility, reporting, and program requirements for both Medi-Cal and CalFresh programs.

While some changes will take effect beginning November 2025, additional policy changes will be implemented in 2026, 2027, and 2028. Changes related to Able Bodied Adults Without Dependents (ABAWD) work requirements for CalFresh, and those scheduled for implementation beyond January 2026 will be shared separately as implementation occurs.

In response to these changes, the County of Los Angeles Board of Supervisors directed the Department of Public Social Services (DPSS) to implement a campaign to inform and prepare DPSS customers and the public about the forthcoming changes and steps they can take to ensure they remain eligible to continue receiving their Medi-Cal and CalFresh benefits.

The “Keep Your Benefits: Changes to Medi-Cal and CalFresh Programs” Communications Toolkit addresses each of the changes occurring from **November 2025 through January 2026** and includes digital content for web, email, and social media. Assets are available in English (EN) and nine additional threshold languages: Armenian (AE), Cambodian (CA), Chinese (CH), Farsi (FA), Korean (KO), Russian (RU), Spanish (SP), Tagalog (TA), and Vietnamese (VI).



## CalFresh: Changes to State Utility Assistance Subsidy (SUAS)

**Changes to Issuance of State Utility Assistance Subsidy (SUAS) to allow Standard Utility Allowance Deduction**

Effective 11/1/25, the State will implement a change as to which CalFresh Households (HH) will receive the State Utility Assistance Subsidy (SUAS) in order to receive the Standard Utility Allowance. This change may reduce or terminate some households' CalFresh benefits.


To remain eligible to the SUA deduction, ensure you report your heating or cooling utility expenses if it is separate from your shelter cost.

- **New households: This change will take effect at application starting November 1, 2025.**
- **Existing households: This change will take effect at your next renewal.**

## CalFresh: Changes to State Utility Assistance Subsidy (SUAS)

Effective 11/1/25, the State will implement a change as to which CalFresh Households (HH) will receive the State Utility Assistance Subsidy (SUAS) in order to receive the Standard Utility Allowance. This change may reduce or terminate some households' CalFresh benefits.

To remain eligible to the SUA deduction, ensure you report your heating or cooling utility expenses if it is separate from your shelter cost.

- **New households:** This change will take effect at application starting November 1, 2025.
- **Existing households:** This change will take effect at your next renewal.
