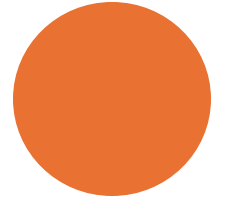

JCOD: How we started

MISSION STATEMENT

Our Mission is to cultivate a person-centered, coordinated continuum of care for vulnerable justice-impacted individuals and their communities. By leading collaborative system improvement efforts, we focus on prevention, diversion, and reentry to achieve community safety, wellbeing, and equitable justice.

What is Measure J & the JCOD Care First Community Investment (CFCI)?

Measure J

- Measure J was a 2020 voter-approved initiative that requires LA County to allocate 10% of its locally generated, unrestricted revenues to community investment and alternatives to traditional justice system responses.
- The funds are administered through the Justice Care and Opportunities (JCOD) Care First Community Investment (CFCI) program.
- The initiative seeks to address the disproportionate impact of racial injustice through community investment and alternatives to incarceration and prohibiting using those funds for carceral systems and law enforcement agencies.

CFCI

- The Care First Community Investment (CFCI) is a significant investment that builds up our collective capacity to best serve the justice-involved people of Los Angeles County.
- CFCI was created by the Los Angeles County Board of Supervisors and placed under JCOD's stewardship in November 2022 to invest in community-based services and expand access to critical resources across the County.
- Since its launch, LA County CFCI Care Grants have directed more than \$350 million to community-based organizations serving residents across all five supervisorial districts.

CFCI funding is distributed through County Departments and JCOD CFCI Care Grants to Community-Based Organizations

Direct Community Investment

- Community-based youth development programs
- Job training and jobs to low-income residents
- Access to capital for small minority-owned businesses with a focus on Black-owned businesses
- Rent assistance, housing vouchers, and accompanying supportive services to those at-risk of losing their housing or without stable housing
- Capital funding for transitional housing, affordable housing, supportive housing and restorative care villages with priority for shovel-ready projects

Alternatives to Incarceration

- Community-based restorative justice programs
- Pre-trial non-custody services and treatment
- Community-based health services, health promotion counseling, wellness and prevention programs, and mental health and substance use disorder services
- Non-custodial diversion and reentry programs including housing and services

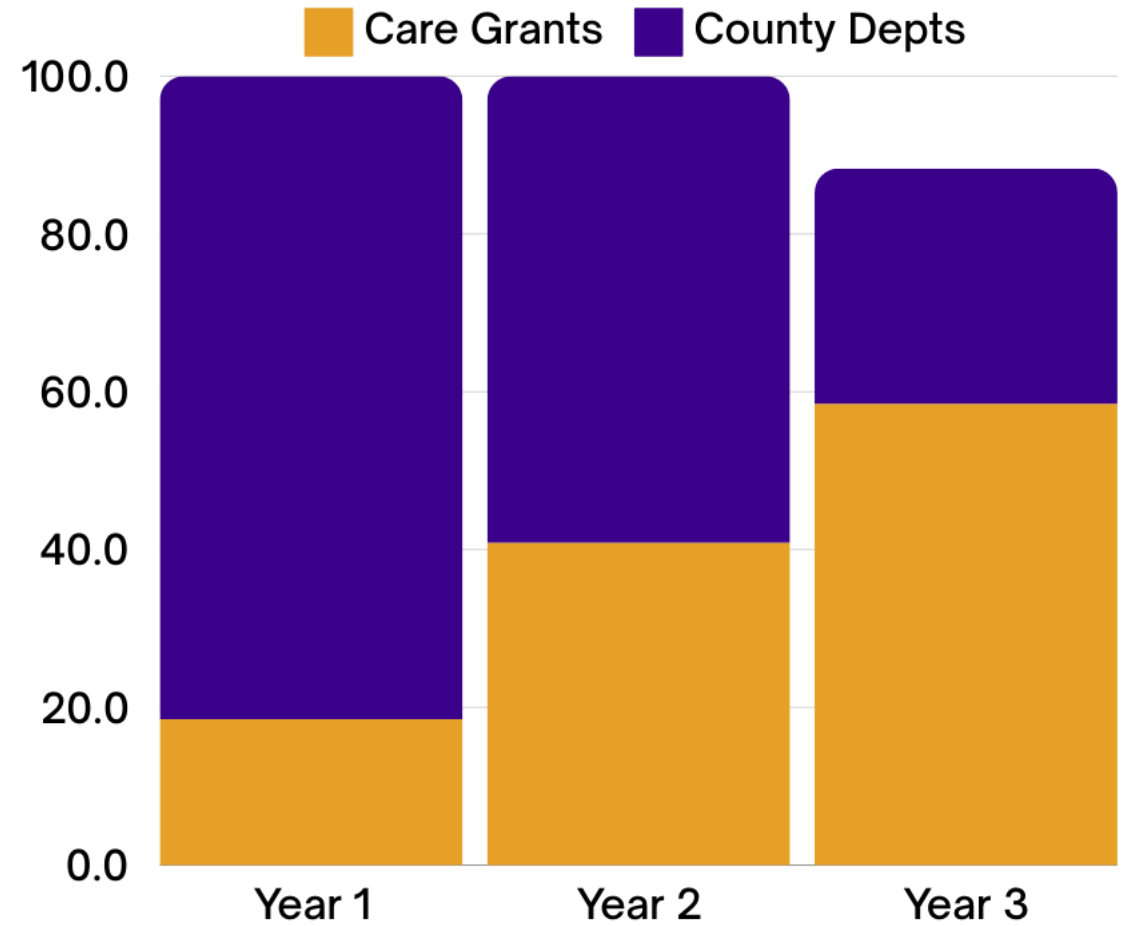

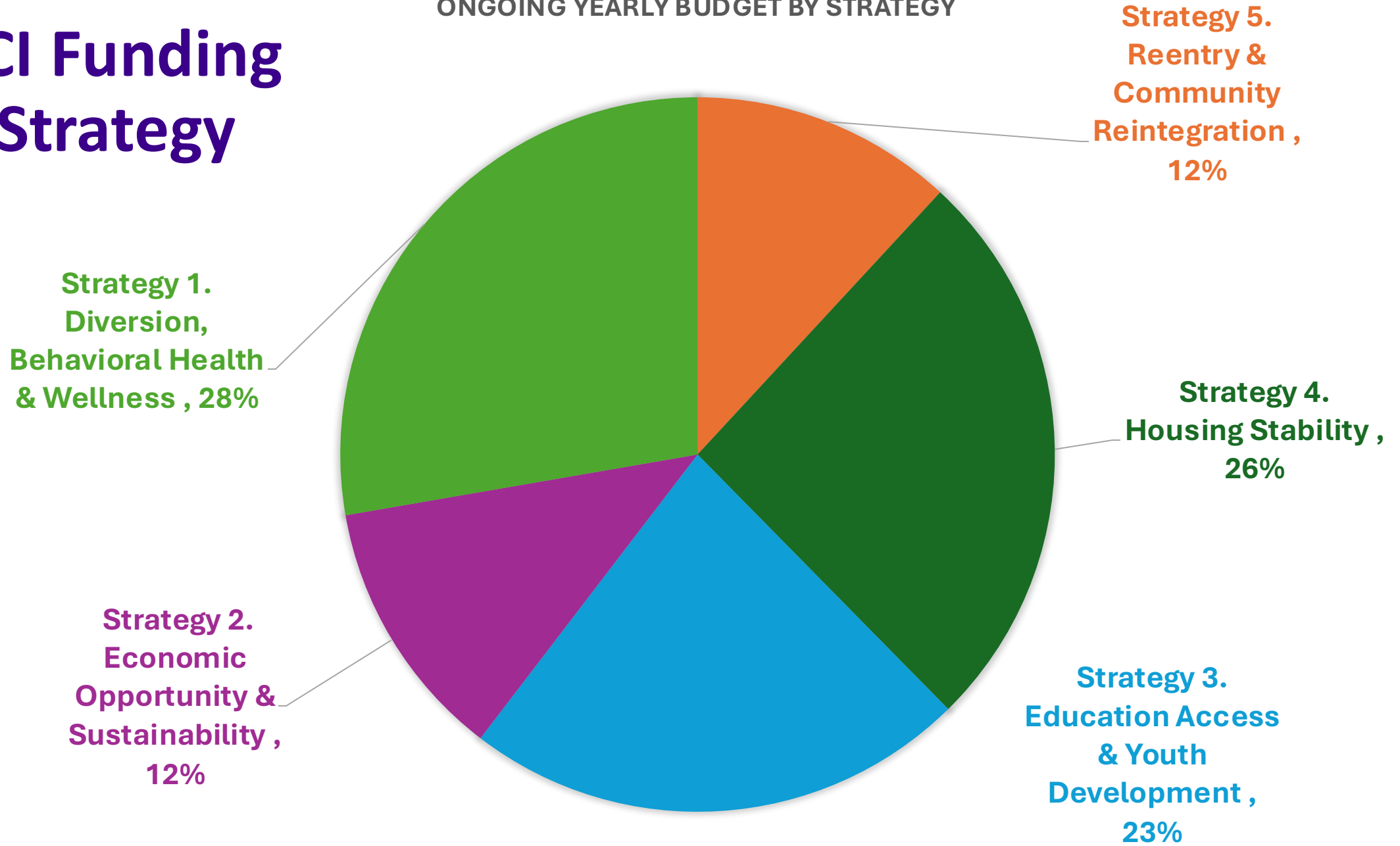

- Select responsibilities of the Committee:
 - Weighs community needs and concepts from County departments, service providers, and individuals who are systems-impacted to use CFCI funding for new programs and/or extensions and expansions
 - Makes recommendations for CFCI funding allocations

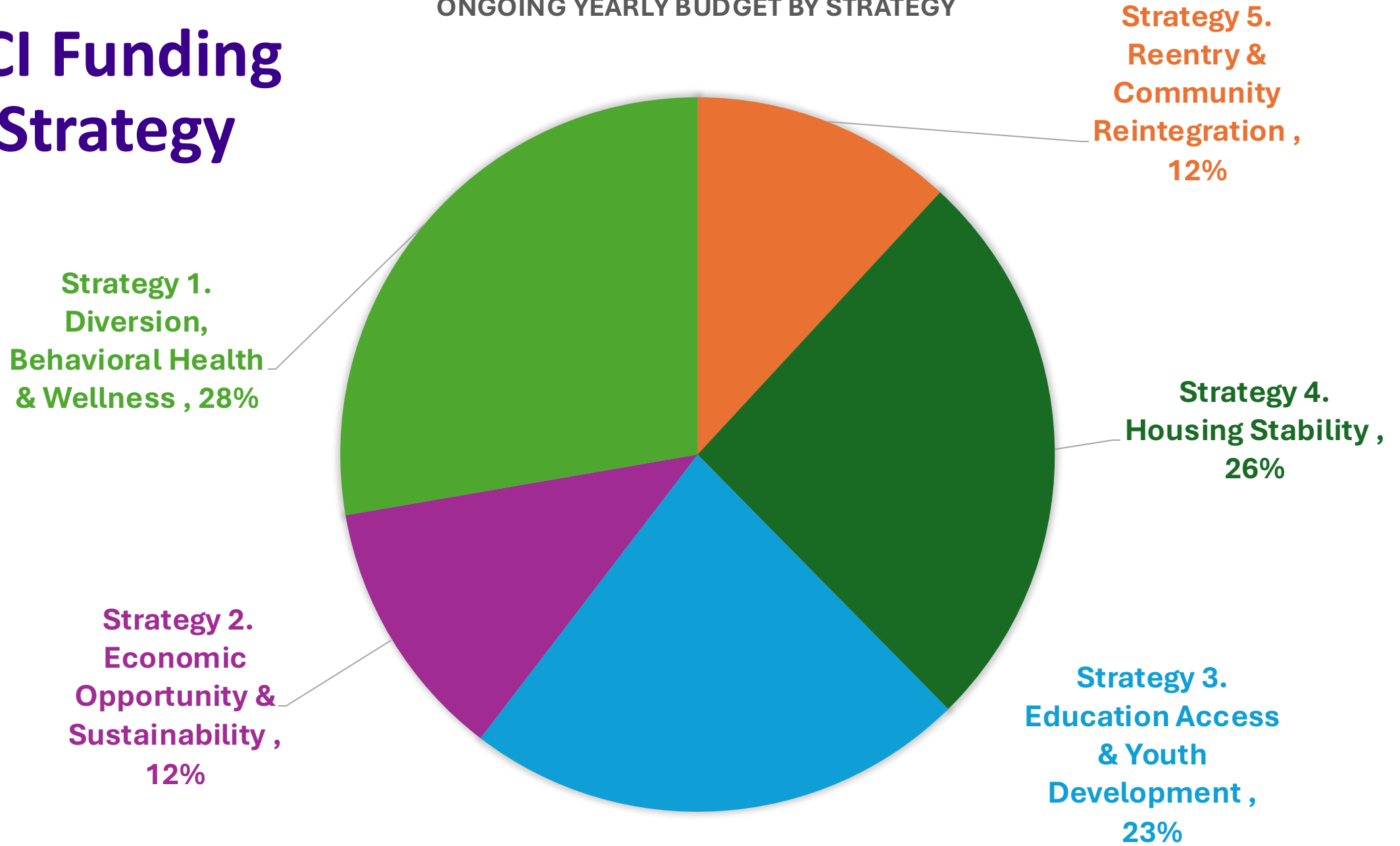

CFCI Funding by Strategy

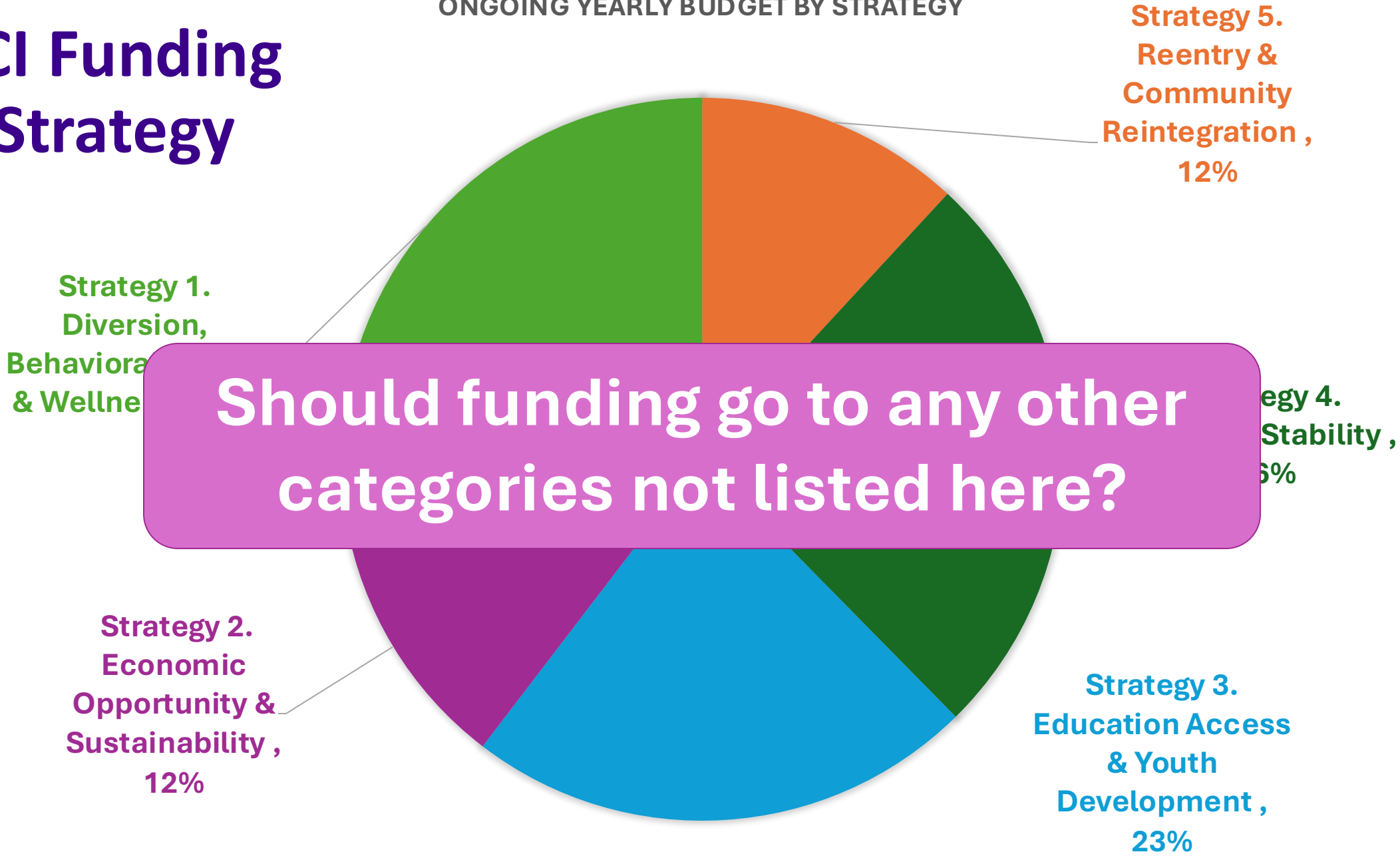
ONGOING YEARLY BUDGET BY STRATEGY
