This inverse condemnation lawsuit against the Department of Public Works contends that a main line sewer backed up into Plaintiff's home as it was being remodeled.

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$154,205.76.

b. **Tremell Thomas, et al. v. County of Los Angeles, et al.**
Los Angeles Superior Court Case No. BC 547 390

This wrongful death lawsuit arises from an incident that occurred at the Jesse Owens Park swimming pool where Plaintiffs' son was found unconscious by County lifeguards.

Action Taken:

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$3,000,000.

c. **Rosa M. Simon-Juan, et al. v. Bernabe Rios, et al.**
Los Angeles Superior Court Case No. BC 577 676

This lawsuit arises from alleged injuries sustained in a vehicle accident involving a Sheriff's Department employee and a pedestrian.

Action Taken:

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$430,000.

d. **Arthur Jenkins, et al. v. County of Los Angeles, et al.**

This lawsuit concerns allegations of civil rights violations and excessive force by Sheriff's Deputies during a traffic stop.

The Claims Board approved the settlement of this matter in the amount of \$40,000.

e. **Tara Jan Adams v. County of Los Angeles**
United States District Court Case No. 15-CV-4501

This lawsuit alleges that an employee from the Sheriff's Department was subjected to retaliation and denied promotional opportunities.

Action Taken:

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$1,275,000.

f. **Virginia Jauregui v. County of Los Angeles, et al.**
Los Angeles Superior Court Case No. BC 540 351

This lawsuit alleges that an employee from the Department of Mental Health was subjected to sexual harassment, retaliation, and that the Department failed to accommodate her disability and engage in the interactive process.

Action Taken:

The Claims Board recommended to the Board of Supervisors the settlement of this matter in the amount of \$350,000.

g. **Katherine Berberian v. County of Los Angeles**

The Claims Board approved the settlement of this matter in the amount of \$40,000.

**h. Gayane Shirvanyan v. County of Los Angeles

The Claims Board approved the settlement of this matter in the amount of \$100,000.

NATURE OF CASE	<p>Plaintiffs Tremell Thomas and Enger Dodson filed this action for wrongful death as a result of the death of their minor son Enodre Thomas, who nearly drowned at the Jesse Owens Park pool on June 9, 2013. Enodre was pronounced dead three days later, after his parents took him off of life support. Plaintiffs claim that the County lifeguards were negligent resulting in Enodre's death. NATURE OF CASE	<p>On August 29, 2013, Mrs. Simon-Juan was walking in a marked crosswalk which connects the west side of Central Avenue with the south side of 108th Street. At the same time, a Parks Bureau Security Officer made a left turn, but he did not see Mrs. Simon-Juan in the crosswalk until just prior to the impact, and was unable to stop or take any evasive action before striking her about the left side of her body. Mrs. Simon-Juan claims injuries to her right knee and the entire left side of her body including back, neck, and shoulder. Mr. Simon-Juan claims damages for loss of consortium.</p> <p>Due to the risks and uncertainties of litigation, a full and final settlement of the case in the amount of \$430,000 is recommended.</p>

Briefly provide a description of the incident/event:	<p><u>Simon-Juan v. County of Los Angeles</u> Summary Corrective Action Plan 2016-052</p> <p>On August 29, 2013, an on-duty Los Angeles County Sheriff's Department security officer, assigned to Countywide Services Division – Parks Bureau, was driving as a single-person unit in a marked security officer vehicle at the intersection of 108th Street and Central Avenue. As the security officer made a left turn from westbound on 108th Street to southbound Central Avenue, traveling approximately 5-10 miles per hour, he struck the plaintiff who was in the crosswalk as she walked eastbound on Central Avenue.</p> <p>The security officer called for paramedics via his handheld radio and Los Angeles City Fire Department personnel responded. The plaintiff complained of pain to her left foot and left hand. The plaintiff also sustained minor abrasions to the left side of her head and left hand.</p> <p>The plaintiff was transported to Harbor UCLA Hospital for treatment of her injuries.</p>

1. Briefly describe the **root cause(s)** of the claim/lawsuit:

A **Department** root cause for this incident was the Department's security officer violated California Vehicle Code section 21950(a).

The California Vehicle Code states that a driver of a vehicle shall yield the right-of-way to a pedestrian within a marked crosswalk or within any unmarked crosswalk at an intersection.

2. Briefly describe recommended corrective actions:
(Include each corrective action, due date, responsible party, and any disciplinary actions if appropriate)

This collision was investigated by the Los Angeles Police Department (LAPD) South Traffic Division and Los Angeles County Sheriff's Department Parks Bureau management personnel.

Following their investigation and review, it was determined the security officer was at fault for the collision in violation of California Vehicle Code section 21950(a), failure to yield to a pedestrian in a crosswalk.

The Los Angeles County Sheriff's Department had relevant policies and procedures/protocols in effect at the time of the incident.

The Los Angeles County Sheriff's Department's training curriculum addressed the circumstances which occurred in the incident. Appropriate administrative action has been taken.

Parks Bureau conducted a review and assessment of all traffic collisions from 2013 through 2016. Based on this audit, a traffic reduction – risk management plan was developed.

The Parks Bureau's Traffic Collision Reduction - Risk Management Plan will serve as Parks Bureau's outline for ongoing traffic collision reduction efforts. The intent of the plan is to reduce exposure to auto liability by reducing preventable traffic accidents and minimize the loss or decline of Department resources.

During the audit, it was discovered that the total number of traffic collisions between the calendar year of this incident (August 2013) and the 2016 calendar year decreased by approximately 11%.

The most frequently cited causes of preventable traffic collisions at Parks Bureau were incidents where employees traveling at low speeds had struck objects while operating vehicles off-road in the parks (i.e. rocks, curbs, trees, steel poles, etc.).


Within this plan, specific risk management issues have been identified and goals have been established. Mitigation efforts will include strict audits concerning the condition of the fleet and coordination between other Sheriff's Department patrol stations and Traffic Services Detail to ensure timely investigations. Additionally, Parks Bureau will increase driver's training to include all employees involved in a traffic collision to attend the Sheriff's Department Alternatives to Discipline Driving Course or S.T.A.R. Driving Course.





