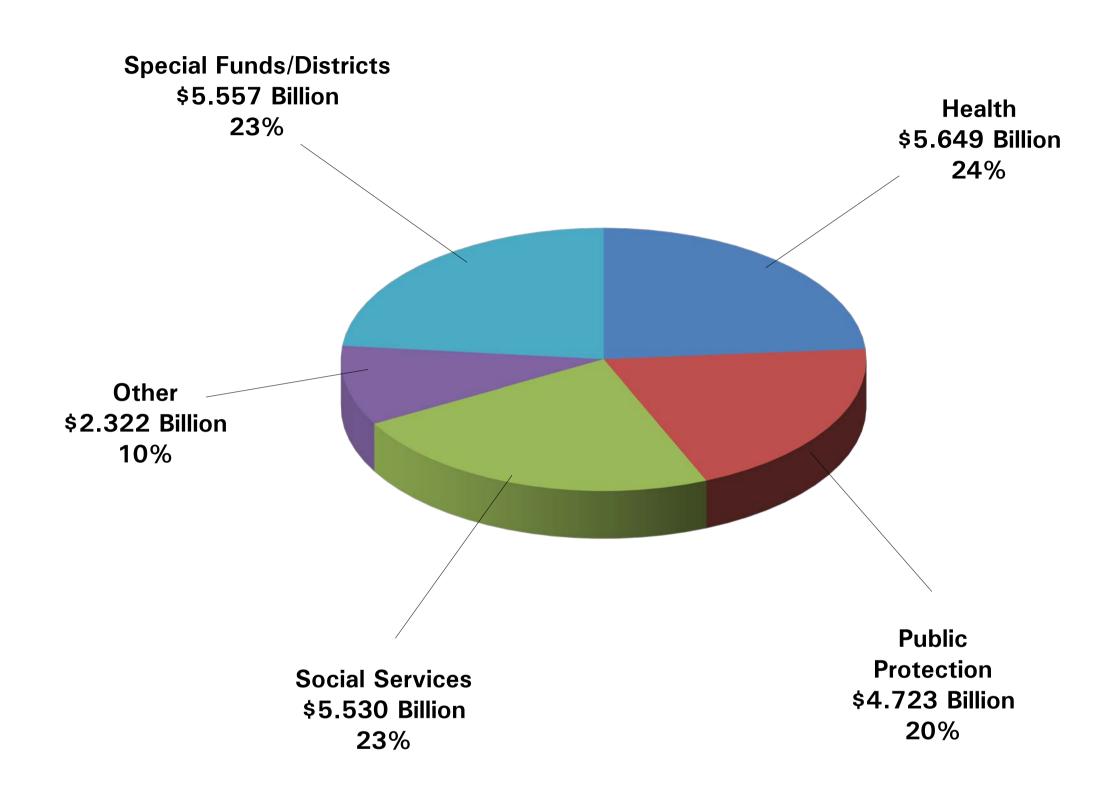
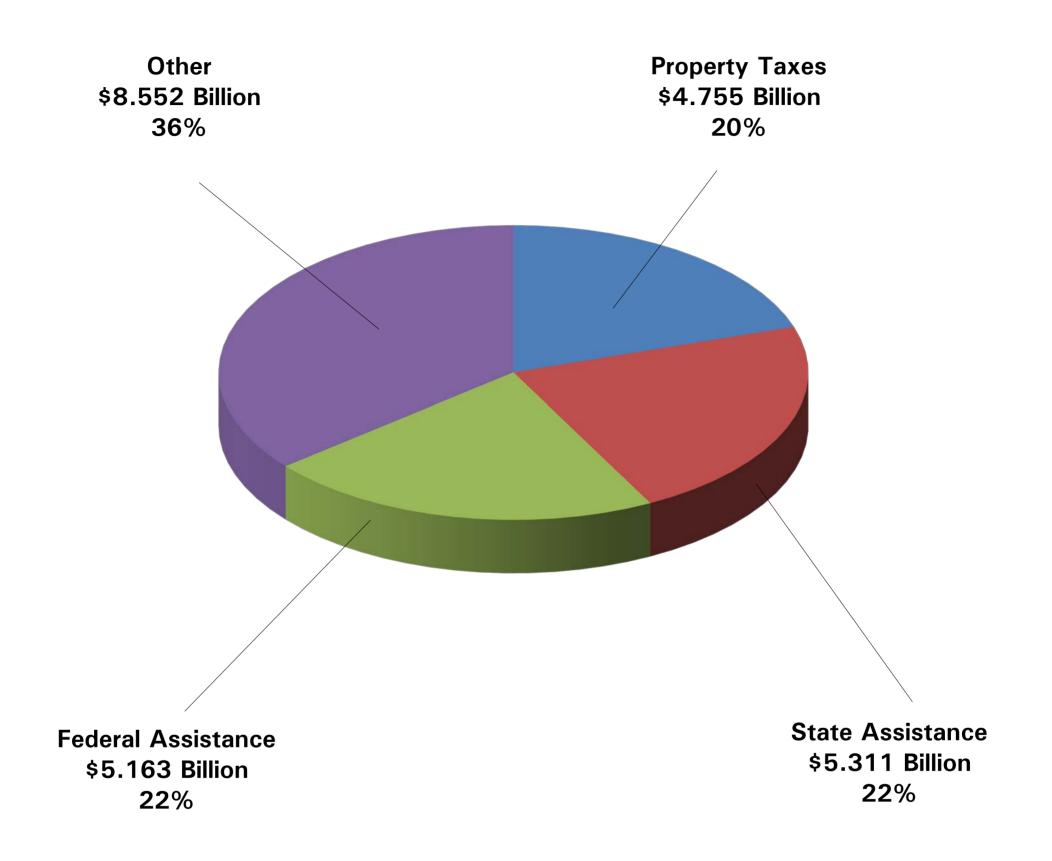
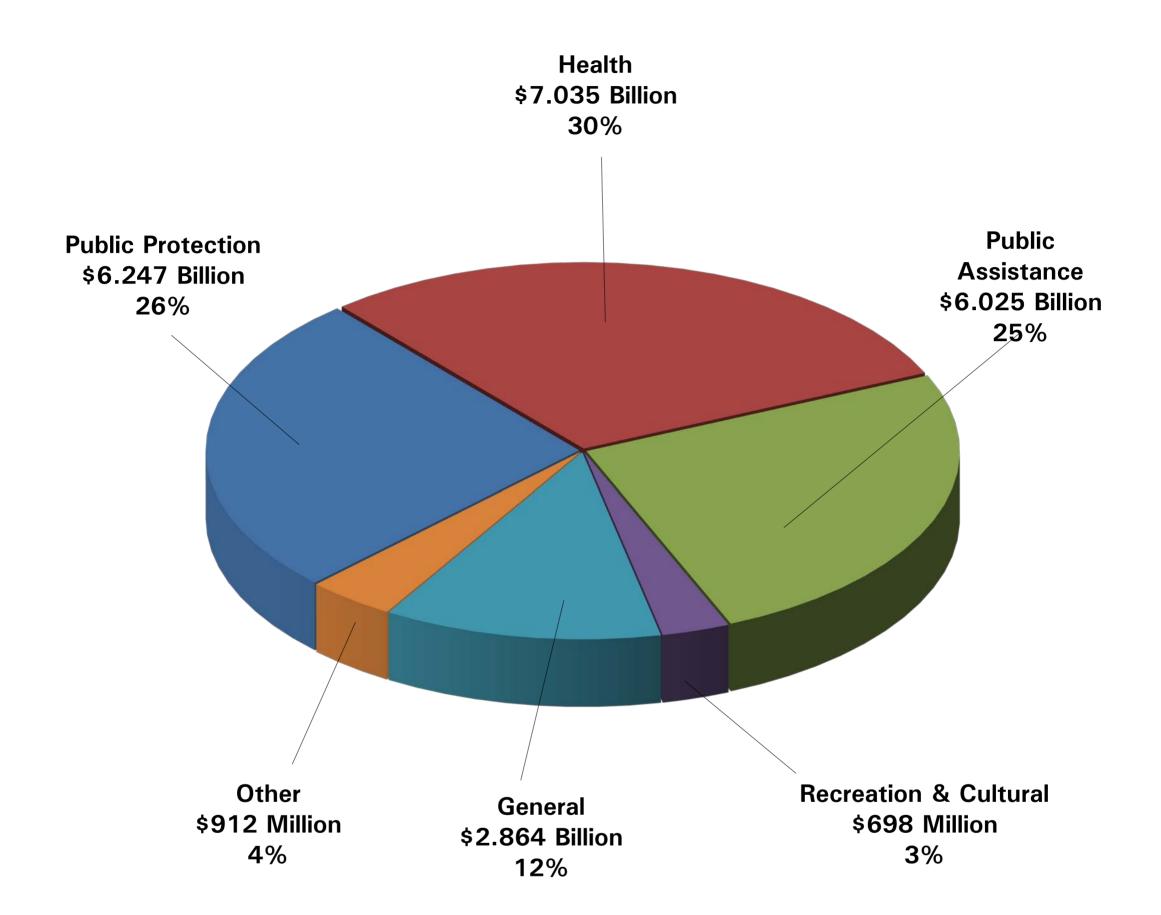
Los Angeles County 2012-13 Recommended Budget Total Requirements \$23.781 Billion



Los Angeles County 2012-13 Recommended Budget Total Resources \$23.781 Billion

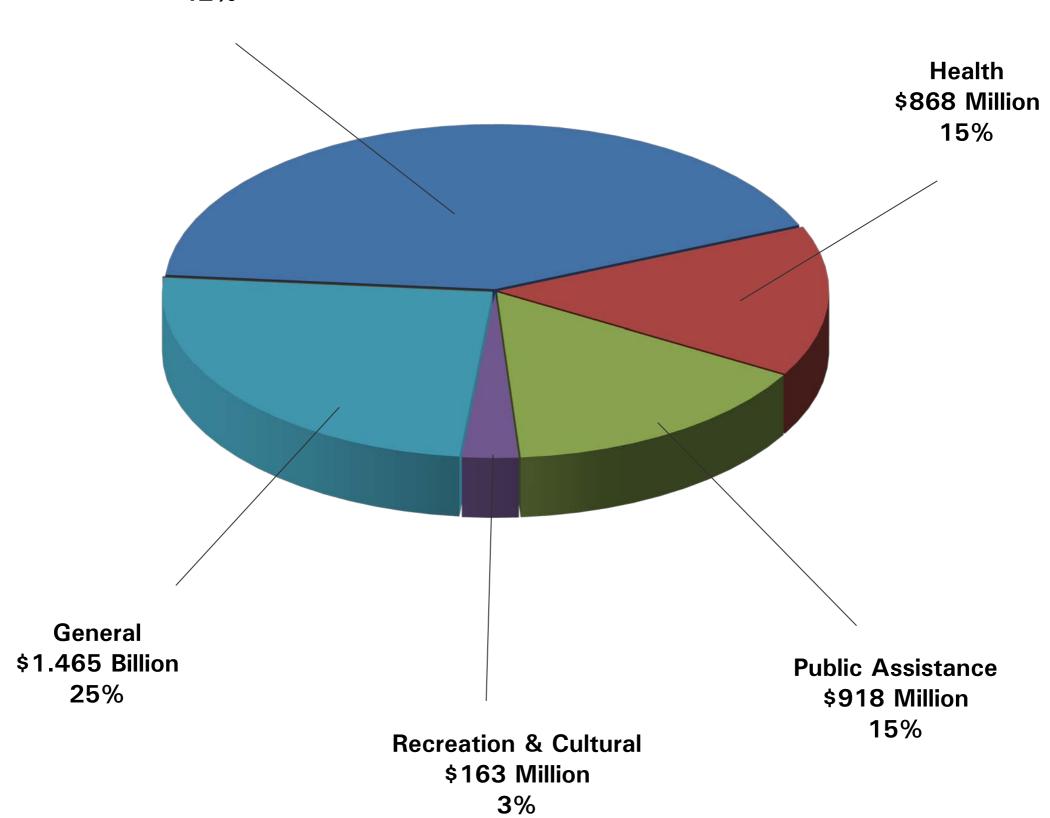


Los Angeles County 2012-13 Recommended Budget Total Cost by Function \$23.781 Billion

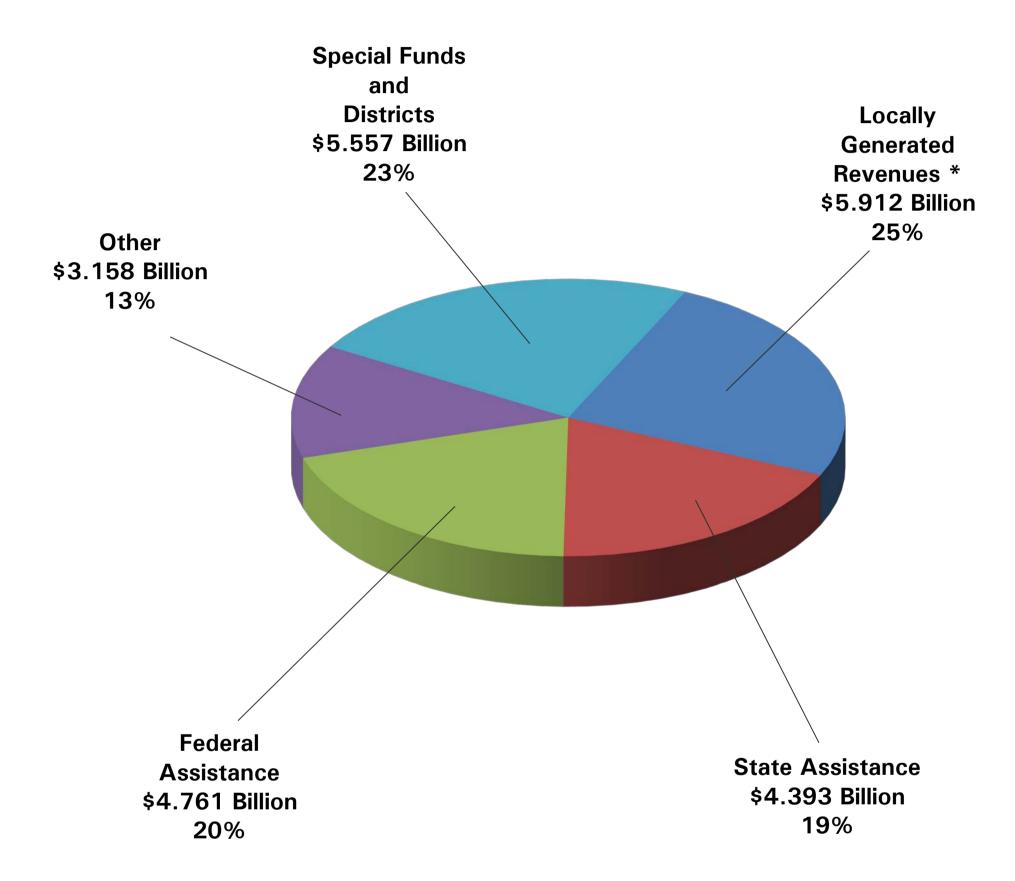


Los Angeles County 2012-13 Recommended Budget Total Net County Cost by Function \$5.912 Billion

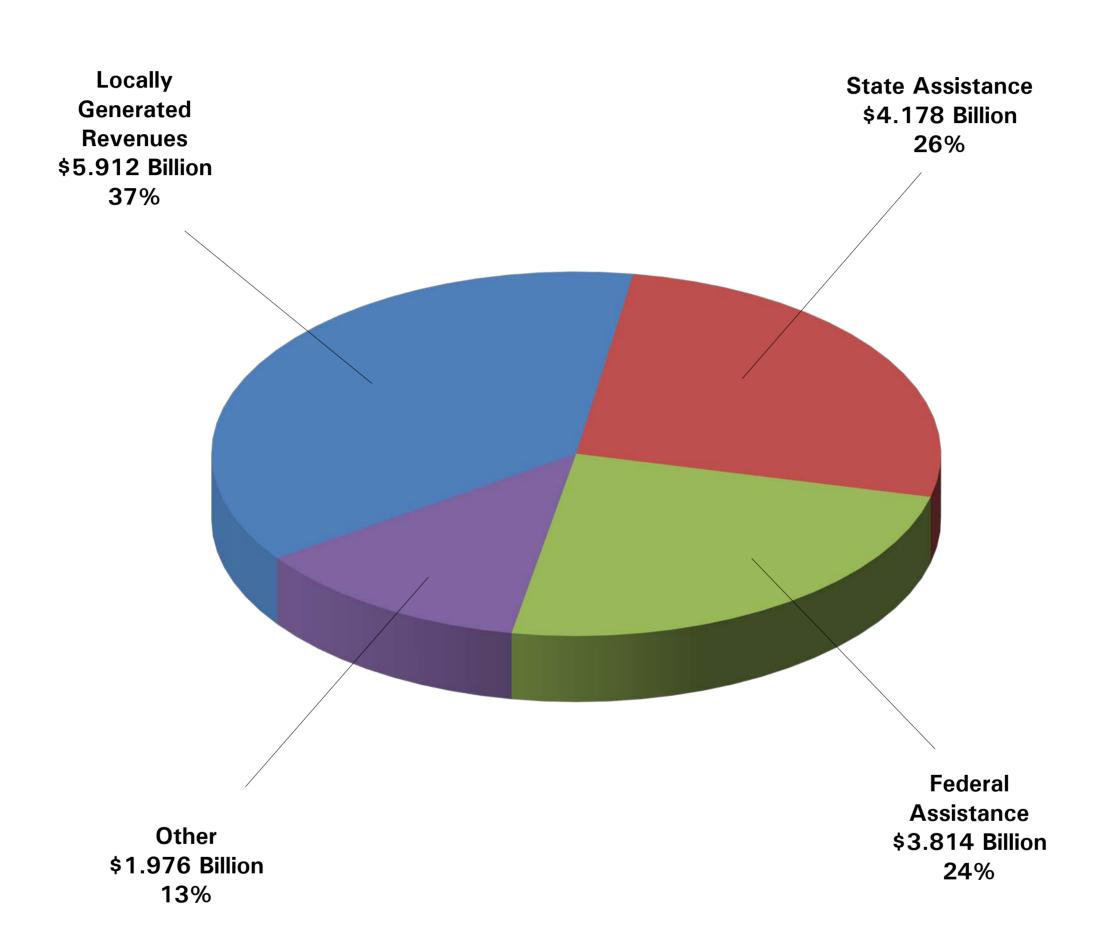


Los Angeles County 2012-13 Recommended Budget Total Revenue \$23.781 Billion

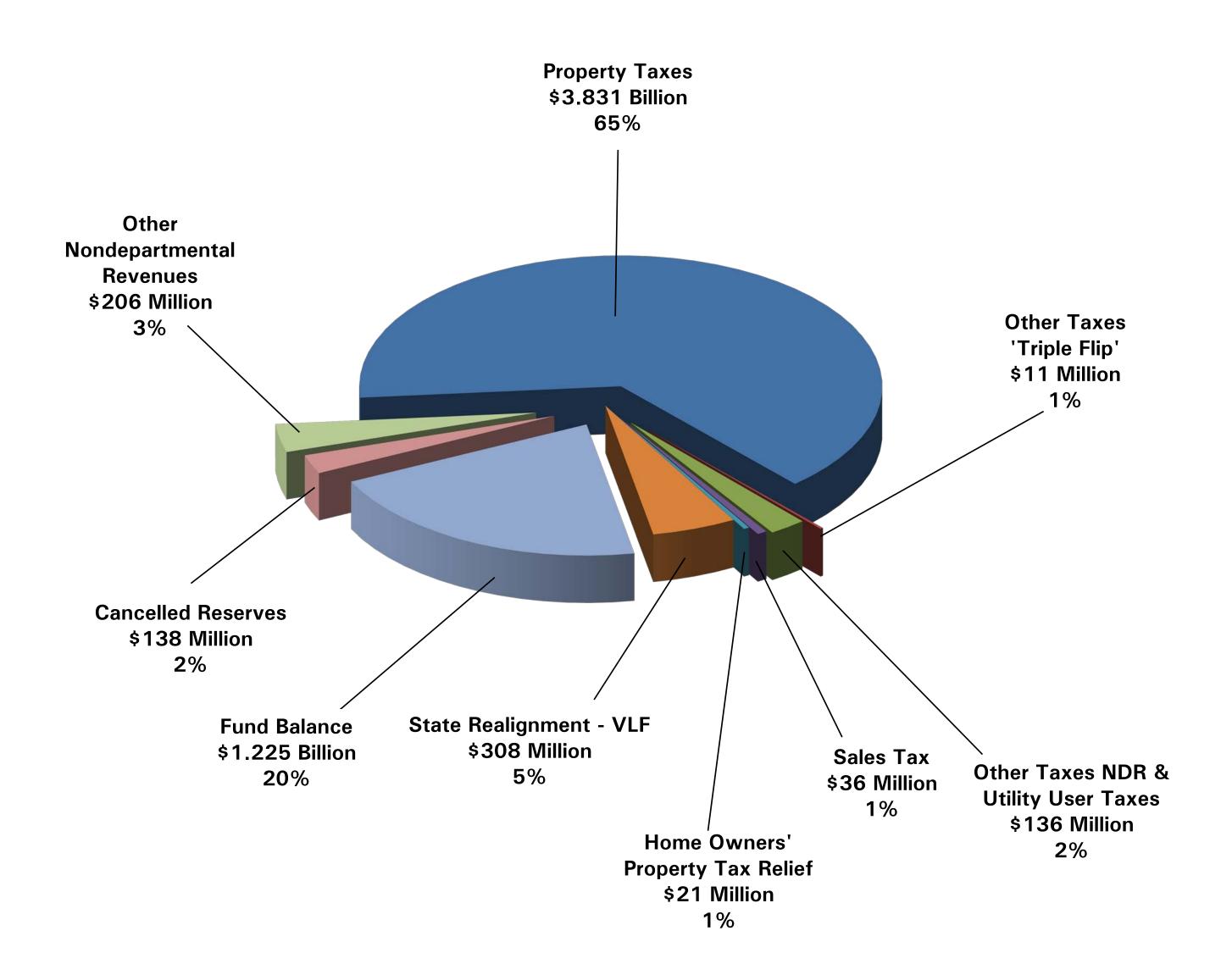

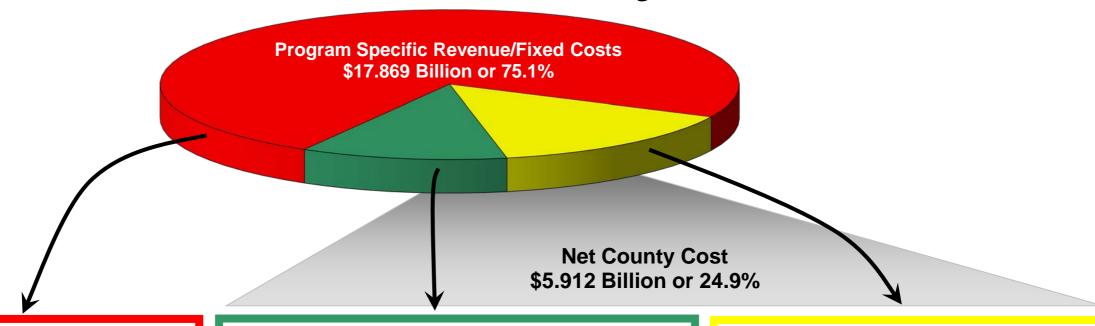


Los Angeles County 2012-13 Recommended Budget Locally Generated Revenues \$5.912 Billion
