This lawsuit alleges federal civil rights violations and deliberate indifference to safety needs by Sheriff's Department jail staff for the death of an inmate at Twin Towers Correctional Facility; settlement is recommended in the amount of \$4,500,000.

c. <u>Donneley Rabot, et al. v. County of Los Angeles, et al.</u> United States District Court Case No. CV 20-10562

This lawsuit alleges wrongful death and federal civil rights violations against the Probation Department arising out of a fatal shooting by a Deputy Probation Officer; settlement is recommended in the amount of \$875,000.

Date of incident/event:	October 22, 2019
Briefly provide a description of the incident/event:	On October 22, 2019, Los Angeles County Deputy Probation Department Officers (DPO), wearing DPO uniforms, went to a house in the City of Carson to conduct a probation compliance search and serve a no bail probation violation arrest warrant. Upon entering the residence, the decedent grabbed a large knife. The officers shouted to drop the knife. However, the decedent ignored the instructions to drop the knife and began to move quickly toward the officers, stating "Fuck you! Shoot me! Kill Me!," resulting in the shooting and death of the decedent.

1. Briefly describe the **root cause(s)** of the claim/lawsuit:

Special Enforcement Operation (SEO) DPOs attempted to search and serve a no bail warrant at the residence of the decedent. When the DPOs entered the residence, the decedent grabbed a knife and disregarded verbal instructions to drop the knife. The decedent charged towards the DPOs with the knife, resulting in an officer involved shooting and death of the decedent. The deputies were unable to deescalate the situation and did not identify a mental health crisis prior to the officer involved shooting.

2. Briefly describe recommended corrective actions: (Include each corrective action, due date, responsible party, and any disciplinary actions if appropriate) Effective July 27, 2020, the Probation Department reduced its focus on warrant apprehensions and refocused efforts on compliance checks.

Effective November 2019, the Probation Department requires a supervisor be present during all compliance operations. Previously, an acting supervisor could lead a compliance team.

On November 17, 2020, Crisis Intervention Training was completed for SEO deputies to ensure all officers are equipped with the tools to address situations in which the supervised person may be in crisis related to mental health or substance use disorder.

On June 28, 2021, Officer Involved Shooting training was completed by SEO to ensure all deputies were given a refresher course on the use of force continuum and legal updates on use of force.

Probation reached out to the Los Angeles Sheriff's Department (LASD) on October 28, 2021 to request a training class for Probation's armed officers to demonstrate all of the available resources LASD's Mental Evaluation Team has available and to help Probation in the identification of clients with a history of mental health crisis before and during operations. The scheduling of this training is pending.

Senior Probation Director of Probation's SEO is the responsibible party for the above corrective actions.

MINUTES OF REGULAR MEETING

APRIL 18, 2022

1. Call to Order.

The meeting of the Los Angeles County Claims Board was called to order at 9:41 a.m. The meeting was held via teleconference with all Claims Board Members participating telephonically. 3. Closed Session – Conference with Legal Counsel – Existing Litigation (Subdivision [a] of Government Code section 54956.9).

At 9:42 a.m., the Chair convened the meeting into closed session to discuss the items listed as 4(a) through 4(g).

4. Report of actions taken in Closed Session.

No members of the public were on the public teleconference phone line to hear the reportable actions of the Claims Board.

At 11:37 a.m., the Claims Board reconvened in open session via the public teleconference phone line and reported the actions taken in closed session as follows:

a. Non-Litigated Claim of Rosanna H. Su

This claim concerns allegations that medical malpractice by Los Angeles County+USC Medical Center contributed to a delay in the diagnosis of plaintiff's medical condition.

Action Taken:

The Claims Board recommended to the Board of Supervisors settlement of this matter in the amount of \$250,000.

b. <u>Taniela Tuihalamaka v. Jim McDonnell, et al.</u> Los Angeles Superior Court Case No. BC 706455

This medical malpractice lawsuit against the Department of Health Services and the Sheriff's Department alleges that jail staff at Men's Central Jail failed to provide plaintiff's scheduled medication causing him to suffer a stroke.

Action Taken:

The Claims Board recommended to the Board of Supervisors settlement of this matter in the amount of \$625,000.

c. Non-Litigated Claims of Juanita Decoudreaux, Donna J. Iliescu, and Gloria Ferrell

Claimants seek compensation from the Department of Public Works for property damage allegedly caused by a backflow of sewage due to a mainline blockage;

Action Taken:

The Claims Board approved settlement of this matter in the amount of \$45,949.99.

d. Non-Litigated Claim of Rafael Estrada

This claim arises from injuries plaintiff allegedly sustained in an automobile accident involving an employee of the Department of Children and Family Services.

The Claims Board approved settlement of this matter in the amount of \$56,000.

e. <u>Reggie DeAndre Mallard v. County of Los Angeles, et al.</u> United States District Court Case No. 2:20-CV-05231

This lawsuit alleges that plaintiff's civil rights were violated by the District Attorney's Office and the Sheriff's Department when they allegedly failed to disclose evidence.

Action Taken:

The Claims Board approved settlement of this matter in the amount of \$99,000.

f. <u>Brian Roger, et al. v. County of Los Angeles, et al.</u> Los Angeles County Superior Court Case No. 20STCV43642

This lawsuit arises from injuries plaintiff allegedly sustained in a single vehicle accident involving a Los Angeles County Fire Department truck.

Action Taken:

The Claims Board approved settlement of this matter in the amount of \$70,000.

g. <u>Jennifer Donnell v. County of Los Angeles</u> Los Angeles Superior Court Case No. 21STCV36479

This lawsuit involves allegations that an employee of the Probation Department was subjected to harassment, retaliation, and discrimination.

The Claims Board did not approve settlement of this matter.
